## INDEPENDENT AUDITOR'S REPORT

### To the Plan Committee of Blount Construction Company, Inc. Employee Stock Ownership Plan

#### Opinion

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Blount Construction Company, Inc. Employee Stock Ownership Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Blount Construction Company, Inc. Employee Stock Ownership Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**(A) DESCRIPTION OF PLAN**

The following brief description of the Blount Construction Company, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for complete information.

General - Blount Construction Company, Inc. (the Company) established the Blount Construction Company, Inc. Employee Stock Ownership Plan effective as of February 1, 1992. Effective January 1, 2021, the Plan was amended and restated. The Plan operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an independent Trustee.

The Plan obtains Company common shares through Company contributions of stock, and holds the stock in a trust established under the Plan.

Effective January 1, 2023, the Plan was amended to implement a minimum annual installment threshold for distributions on account of separation from service, other than death, disability, and retirement. Distributions commencing on or after January 1, 2024, that have an account balance in excess of \$5,000,000, are made over a three-year period. Distributions commencing on or after January 1, 2024, that have an account balance in excess of \$50,000, are made over a three-year period.

On December 8, 2023, the Plan purchased 370,424 shares of Company common stock from the Company through a loan agreement with the Company (the Internal ESOP Loan). The Internal ESOP Loan is to be repaid over forty-nine years by fully deductible Company contributions to the trust fund. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of common stock. The Company has no rights against the shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024 present separately the asset and liabilities and changes therein pertaining to (1) the accounts of employees with vested rights in allocated stock (Allocated) and (2) stock not yet allocated to employees (Unallocated). Also, see Note (I).

Eligibility - Employees of the Company who are age 21 or older are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions - The Company is obligated to make cash contributions to the Plan in an amount which, when aggregated with any dividends paid to the Plan, will allow the Plan to service the current payment due on the loan. All other contributions to the Plan are made at the discretion of the Company's Board of Directors, and can be made in the form of cash or Company stock. For 2024, the Company contributed 28,777 shares of Company stock valued at \$1,020,143. The Company also made a cash contribution of \$506,289 to service the current payment due on the loan. Employees are not permitted to make contributions to the Plan.

Payment of Benefits - Distributions on account of separation from service or death commence in the Plan year following the event. Distributions on account of disability or retirement commence as soon as practicable after the event. All are made in a lump sum payment or are made in a series of not less than three annual installments. Account balances less than \$5,000 are made in a lump sum payment the year following the separation. Distributions are made in cash.

Beginning in 2022, the Plan permitted terminated participants whose stock accounts have been converted to cash to request distributions of their account at any time.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan. During 2024, the Company repurchased 123,654 shares at prices determined from the independent appraisal.

On December 8, 2023, the Company entered into a share redemption agreement with the Trustee. The participants eligible for the share redemptions were terminated prior to January 1, 2023, and had a vested balance. Prior to the redemption, the Company adopted a 1,000 for 1 stock split such that after the stock split, the Company had 1,825,117 shares outstanding, all of which is held by the ESOP trust.

The Company paid \$9,816,227 to the Plan for 370,424 shares redeemed at a price determined to be fair value and approved by the Trustee.

Voting Rights - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any shares on behalf of the collective best interest of plan participants and beneficiaries.

Plan Termination - The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon any full or partial termination of the Plan, the affected participants' accounts will become 100% vested. Upon full termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of the Company's contribution and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Vesting - If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. After the second year of service, participants vest 20% per year of service and are 100% vested after six years of service.

Put Option - Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who have attained normal retirement age, as defined by the Plan, may diversify up to 75% of the post-1986 shares allocated to his or her account. Participants who elect to diversify receive a cash distribution.

Forfeitures - Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of missing vested or terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$189,206 and \$169, respectively.

**(B) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The common shares of the Company are valued at fair value. See Note (E) for discussion of fair value measurements.

Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade date basis. Realized gains and losses, if any, from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Allocations - The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("Allocated") and (b) stock not yet allocated to employees ("Unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Operating Expenses - Most expenses of maintaining the Plan are paid by the Company. Administrative expenses totaling \$3,940 for the year were for benefit payment processing fees and expenses to maintain the Plan.

Payment of Benefits - Benefits are recorded when paid.

Date of Management's Review - Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**(C) TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 13, 2016 that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Code. Although the Plan has been restated since receiving the determination letter, the Plan administrator and the Plan tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

**(D) ADMINISTRATION OF PLAN ASSETS**

The Plan's assets at December 31 2024, which consist of Blount Construction Company, Inc. common shares, a money market fund, and a mutual fund, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the Internal ESOP Loan, which is reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee fees are paid directly by the Company.

**(E) FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The "Fair Value Measurements and Disclosures" Topic of the FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of the mutual fund is based on quoted net asset values of the shares as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund registered with the U.S. Securities and Exchange Commission. The fund must publish their daily net asset value and transact at that price. The mutual fund held by the Plan is considered to be actively traded.

The fair value of the money market fund is based on a daily net asset value of \$1 per share. The fund is comprised of U.S. Treasury and government securities.

*Level 3 Fair Value Measurements*

The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The Trustee, under the supervision of the Plan Committee, determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. Transfers into the Plan for contributions for the years ended December 31, 2024 and 2023 totaled \$1,526,432 and \$9,939, respectively. Transfers into the Plan for redemption for the years December 31, 2024 and 2023 total \$0 and \$9,816,227, respectively. Transfers out of the Plan for distributions for the years ended December 31, 2024 and 2023 totaled \$3,624,015 and \$9,792,887, respectively.

The Plan's policy is to recognize purchases and issues of Level 3 investments that were made during the year. For the years ended December 31, 2024 and 2023, there were purchases of Company stock of \$0 and \$9,129,089, respectively. For the years ended December 31, 2024 and 2023, there were no issues of Level 3 investments.

**(G) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTION**

The Plan invests in Company common stock. This is a related party and party-in-interest transaction. As described in Notes (B) and (D), the Company pays most of the expenses of the Plan. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

**(H) RISKS AND UNCERTAINTIES**

The Plan investments include the Company's common stock, which is exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**(I) LOAN PAYABLE**

On December 8, 2023, the Plan entered into a \$9,129,089 loan agreement with the Company to purchase 370,424 shares of common stock from the Company. The Internal ESOP Loan has a term of 49 years, has an interest rate of 5.03%, and is secured by a pledge of the purchased shares of common stock. The unallocated shares are collateral for this loan. Shares are released from collateral and allocated to participants when principal and interest payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments, divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 7,560 shares being released and allocated to the Plan for the year ended December 31, 2024. Also see Note (A).

**(J) SUBSEQUENT EVENT**

On July 1, 2025, the Company acquired a paving contractor (the target entity) as part of an asset purchase transaction. After the acquisition, the employees of the target entity became employees of the Company. Employees who meet the eligibility requirements will become participants of the Plan effective January 1, 2026, and thereafter.
