We have performed audits of the financial statements of the IPS & Affiliates 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Description of Plan

The following description of the IPS & Affiliates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of IPS-Integrated Project Services, LLC and participating employers including IPS-Integrated Project Services, Corp., IPS Professional Engineers & Architects, PC, SommaTech LLC, and The Cardinal Group USA, LLC (collectively, the Plan Sponsor, Company or Employer) who have attained three months of service. There is no age requirement. The Plan excludes certain employees including residents of Puerto Rico, leased employees and employees under a collective bargaining agreement. The board of directors is responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant contributions:** Participants may contribute up to 70% of pretax annual compensation, as defined by the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants are also permitted to contribute Roth after-tax deferrals to the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

**Auto-enrollment:** The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 5% unless they affirmatively elect not to participate in the Plan. Contributions are invested in a designated balanced fund until changed by the participant.

**Employer contributions:** Effective January 1, 2022, the board of directors declared a safe harbor matching contribution for eligible participants. The Plan Sponsor will make a matching contribution to participant accounts based on their deferral contributions in an amount equal to 100% of the first 3% of compensation contributed to the Plan and 50% of the next 2% of compensation contributed to the Plan.

Additionally, profit sharing amounts may be contributed at the discretion of the Employer's board of directors. For the year ended December 31, 2024, there were no discretionary profit-sharing contributions made.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the plan administrator in 1% increments. Participants may change their investment options daily.

#### Note 1. Description of Plan (Continued)

**Participant accounts:** Each participant's account is credited with the participant's contribution and the Employer's matching contribution, as well as allocations of any profit-sharing contribution and Plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participant contributions are immediately vested in their contributions plus actual earnings thereon. Participants become fully vested in the Employer matching contributions upon the occurrence of death, total or permanent disability, or normal or early retirement. Other than as stated above, Employer contributions vest as follows:

**Payment of benefits:** The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed. Upon termination of service, a participant will receive a lump-sum amount equal to their vested account balance if the vested account balance is less than \$1,000.

**Forfeitures:** Forfeitures are used to reduce future Employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$44,541 and \$28,573 at December 31, 2024 and 2023, respectively. During 2024, \$5,737 was used to pay administrative expenses and \$85,876 was used to reduce Employer matching contributions. Accumulated forfeitures will be applied to pay expenses or to reduce the Employer contributions in 2025.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Note terms range up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the plan administrator. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. These rates range from 4.25% to 10.50% on loans outstanding as of December 31, 2024, and mature through December 2032. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are reported at their unpaid principal balances plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the plan administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess contributions payable:** Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees related to the administration of participant accounts, notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses.

**Contributions:** Contributions from plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

#### Note 3. Information Provided by Fidelity Management Trust Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by the Trustee. The plan administrator has obtained certifications from the trustee that the information provided to the plan administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets at December 31, 2024 and 2023:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust funds:** Valued at NAV per unit based on the underlying investments comprising the trust. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient for estimating fair value.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

#### Note 6. Related-Party and Party-in-Interest Transactions

Transactions with the Trustee qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee totaled \$138,680 for the year ended December 31, 2024. The Employer also paid certain administrative expenses of the Plan.

#### Note 7. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's qualified status. The volume submitter advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter received the advisory letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During 2023, the Plan sponsor inadvertently failed to deposit \$8,366 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan sponsor intends to deposit this amount to correct this failure in 2025. The correction and any excise taxes, if applicable will be made from the Plan sponsor's assets and not from assets of the Plan.
