Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kent US 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating

to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of Kent US 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established on January 1, 2022 by Kentech Technical Services, LLC and affiliated companies who have adopted the Plan (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Eligibility

The Plan specifically excludes collectively bargained employees, nonresident aliens with no US income, leased employees, and legal benefits only and casual employees hired after January 1, 2019. There are no age or service requirements to enter the Plan.

C. Participant Contributions

Participants may elect to make pre-tax and/or Roth contributions to the Plan up to the maximum amount permitted under provisions of the Code. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a pre-tax deferral rate of 3% of compensation.

Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction.

D. Company Contributions

In 2022, the Plan provides for employer safe harbor matching contributions equal to 100% of the first 3% of compensation deferred by participants plus 50% of the next 2% of eligible compensation participants elect to defer. Employer discretionary nonelective contributions are also permitted under terms of the Plan. In 2023, the Plan’s safe harbor matching was amended to provide employer safe harbor matching equal to 100% of the first 5% of eligible compensation participants elect to defer. The Company did not make nonelective contributions for the 2024 Plan year.

E. Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers, Plan earnings or losses and expenses and an allocation of Company contributions. Company matching contributions are allocated based on participant contributions. Company nonelective contributions, if any, are allocated as a uniform percentage of eligible employee compensation. Participants direct the investment of their accounts. The accounts of participants who do not make an affirmative investment election are invested in the Vanguard Target Retirement fund appropriate for a participant’s age and projected retirement date.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their accounts attributable to elective contributions, rollovers and Company safe harbor matching contributions. Participants vest 50% after 2 years of service and 100% after 3 years of service in accounts attributable to employer non-elective contributions. Vesting schedules that apply to certain participants are grandfathered such that terms effective January 1, 2016 are no less favorable than terms applied to participants prior to this time. Regardless of the vesting schedules, a participant will become fully vested upon death or total and permanent disability.

Forfeitures of terminated participants' non-vested accounts may be used to reduce Company contributions or to pay Plan administrative expenses. In 2024, forfeitures totaled \$111,265, of which were used to pay Plan expenses.

G. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or withdraw vested benefits in a lump sum. Under limited circumstances, the plan administrator may approve in-service withdrawals due to hardship. Benefits are recorded when paid.

H. Notes Receivable from Participants

Participant loans are permitted under the Plan. Loans are granted for a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. A loan is secured by a participant's vested account, bears interest at a reasonable rate determined by the administrator, and is repaid via payroll deductions. Notes are measured at the unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan. Notes receivable from participants at December 31, 2024 and 2023 carry interest rates ranging from 4.25% to 9.50%, and maturing through 2034.

I. Expenses

Investment fund operating expenses are incurred directly by the funds and are factored into each fund's value as a reduction in investment return. Certain administrative expenses including withdrawal and participant loan administration fees are charged directly to participants. Direct administrative costs paid by the Plan in 2024 totaled approximately \$114,646. Other costs incurred for administering the Plan may be paid by the Plan or the Company at the direction of the plan administrator.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and

assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information relating to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024, and investment income for the year then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee.

NOTE 4 - INCOME TAX STATUS

The Company adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is designed and operated in accordance with and qualifies under applicable requirements of the Code and the trust, which forms a part of the Plan, is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation

techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. Mutual funds are valued at closing market prices. Self-directed brokerage accounts include common stock and mutual funds valued at closing market prices and cash equivalents valued using matrices of trades in similar securities and third party pricing services. NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date.

and investment activity are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition party-in-interest transactions under ERISA.

NOTE 8 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan transitioned trustees from Vanguard Fiduciary Trust Company ("Vanguard") to Empower Retirement, LLC ("Empower"). Although the transfer of assets was initiated prior to year-end, the assets were not received by Empower until January 2025. As of December 31, 2024, the Plan retained legal ownership of all investments, which were reported in the financial statements accordingly.

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. Other than the above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
