Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Branding Iron Holdings Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Branding Iron Holdings Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of Branding Iron Holdings Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Branding Iron Holdings Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of the Branding Iron Holdings Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which has been adopted by Branding Iron Holdings (the Company), is a defined contribution profit sharing plan that includes a 401(k) provision. The Plan covers both union and non-union employees. Union employees who have completed three months of service and are 18 years of age or older are eligible for participation. All other employees who have completed one year of service and are 18 years of age or older are eligible for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to defer a minimum of 1% of their eligible compensation either as a pre-tax or Roth contribution, not to exceed the annual dollar limit under Internal Revenue Service (the IRS) guidelines. Participants who attain age 50 during the Plan year may elect to make catch-up contributions, subject to certain limitations. Participants may also make rollover contributions representing distributions from other qualified plans.

Eligible employees who do not affirmatively elect otherwise are automatically enrolled in the salary deferral portion of the Plan. These participants begin making pre-tax salary deferral contributions to the Plan at 4% of eligible earnings. This deferral rate will increase in 1% increments annually starting with the following January 1 after the participant is automatically enrolled, and will continue until the participant reaches a deferral rate of 10%.

Each year, the Company may elect to make a matching contribution. For the Plan years ended December 31, 2024 and 2023, the Company contributed 100% of the first 4% of eligible compensation.

Notes To Financial Statements (*Continued*)

The Company may also make a discretionary contribution. If a Union employee is eligible to participate in the Plan, completed a year of service as defined in the Plan Document and is employed on the last day of the Plan year they would be eligible to receive a discretionary contribution from the Company. All other employees are eligible to receive a discretionary contribution from the Company upon meeting the Plan's eligibility requirements. The employee does not have to make deferrals to receive the contribution. All union employees received a discretionary contribution of 1% of the eligible employee's compensation during 2024 and 2023. There were no discretionary contributions made to nonunion employees during 2024 or 2023.

The Plan is subject to certain non-discrimination rules under ERISA and the Internal Revenue Code (the IRC). For 2024 and 2023, the Plan failed certain non-discrimination tests under the IRC due to lower deferral percentages by non-highly compensated eligible employees relative to the deferral percentages of highly compensated eligible employees. In order to meet the requirements of the non-discrimination rules, the Plan is required to return contributions received from certain participants during the Plan year in excess of the IRC limits. These refunds are accrued within excess contributions payable in the statement of net assets available for benefits and reduce participant contributions on the statement of changes in net assets available for benefits.

Administration Of The Plan

The Standard Insurance Company serves as the recordkeeper and Minnesota Life Insurance Company (Minnesota Life) is the Plan's asset Custodian.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of Plan's net change in fair value of investments. The allocation of net change in fair value of investments is determined by the net change in fair value of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a number of investment options offered by the Plan.

BRANDING IRON HOLDINGS RETIREMENT SAVINGS PLAN

Notes To Financial Statements (*Continued*)

Vesting Schedule

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is fully vested after five years of service or upon reaching early retirement age, total and permanent disability or upon death.

Forfeitures

Forfeitures of nonvested participant balances can be used to reduce Plan expenses or Company discretionary contributions. For the year ended December 31, 2024, forfeitures reduced the Company's discretionary contributions and Plan expenses by \$88,058 and \$12,948, respectively. For the year ended December 31, 2023, forfeitures reduced the Company's discretionary contributions and Plan expenses by \$108,496 and \$13,242, respectively. Forfeited, nonvested account balances of \$90,782 and \$108,160 remained as of December 31, 2024 and 2023, respectively.

Notes Receivable From Participants

A participant may borrow from their account subject to certain limitations. The minimum amount of any note is \$1,000. In no event can the participant borrow more than the lesser of \$50,000 or 50% of the participant's vested balance. Notes are secured by the vested balance in the participant's account, and are for a period not exceeding five years unless used to acquire a personal residence in which case the maturity may not exceed 30 years. Notes bear interest at a reasonable fixed rate of interest based on prevailing market rates. The notes are repaid through payroll withholdings and direct payments from participants, including principal and interest, with rates ranging from 4.25% to 9.50%. The final installments are due on various dates through April 2048. Participants may have up to two loans outstanding at a time.

Payment Of Benefits

Upon termination of employment, death, total disability, or attainment of normal retirement age (65), a participant (or beneficiary) may elect distribution of his or her account as a single lump sum, in substantially equal installments, or in partial withdrawals. In service withdrawals from a participant's vested account balances are permitted upon reaching age 59½.

Participant Hardship Withdrawals

A participant may withdraw from the Plan a portion of his or her vested account in the event of undue financial hardship, which includes payments for education, medical expenses or purchase of a primary residence.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan are paid by the Company. Other administrative expenses, primarily transaction fees and account fees, are paid by the Plan. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investment.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Investment Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. Interest income is recorded as earned on the accrual basis. No allowance for credit losses has been recorded as December 31, 2024 or 2023.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian and The Standard Insurance Company have certified that the following data included in the accompanying financial statements and supplemental schedule of assets held at end of year is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023;
- Investment information included in the supplemental schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts

Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV as provided by Minnesota Life, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. All pooled separate accounts have daily redemption frequencies at NAV with no redemption notice periods, and file an annual report on Form 5500 as a direct filing entity. There are no capital commitments related to any of the Plan's pooled separate accounts. The pooled separate accounts held by the Plan are not required to be reported in the fair value hierarchy.

The method described above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodology used at December 31, 2024 or 2023.

5. Party In Interest Transactions

Plan investments are units of pooled separate accounts and an investment contract managed by Minnesota Life or an affiliate of Minnesota Life. These transactions qualify as party in interest transactions allowable under ERISA regulations.

Certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered allowable party in interest transactions.

6. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Income Tax Status

Effective January 15, 2022, the Plan was restated with a pre-approved document for savings plans sponsored by Minnesota Life. Minnesota Life received an updated opinion letter from the IRS dated June 30, 2020. The Company has not received a determination letter with respect to the Plan's qualification. The Plan has been amended since the opinion letter was issued. However, the Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company identified certain operational errors relating primarily to participant and Company contributions. The Company plans to take necessary corrective actions to ensure the Plan maintains its tax qualified status.

8. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.


