The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule H Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the

supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Plan Description

The following description of the TORC Robotics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of TORC Robotics, Inc. (the “Company”) who are age 21 or older. The Plan excludes union, nonresident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2024, the Plan adopted the following provisions:

- An automatic enrollment provision where employees will automatically be enrolled at 6% unless they opt out. This provision will apply to new participants as well as existing participants with a rate less than 6%.
- QACA safe harbor match applied at 100% deferrals up to 6% compensation. These contributions will be 100% vested after 2 years.
- Vesting wavier for anyone employed on December 31, 2023 (100% vested).
- Prior service with Algolux (USA), Inc., recognized for eligibility, vesting, and contribution allocations.
- Distributions for deemed severance of employment and Qualified reservist distributions are allowed.

Effective December 4, 2024, the Plan was amended to consider interns and Co-op employees eligible if they are credited with at least 1,000 hours and to remove the discretionary match.

Contributions

Participants contribute to the Plan through voluntary pretax or Roth payroll deductions. Participants may elect to defer up to 100% of their pretax compensation up to an amount not to exceed the Internal Revenue Service (IRS) limitations on net contributions. Eligible participants who have attained age 50 on or before the close of the Plan year may make catch-up contributions, subject to the limitations of the *IRC*. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. The Company makes a safe harbor contribution to a participant’s account equal to 100% of the participant’s elective contributions, subject to a limit of 6% of the participant’s total compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may also contribute additional amounts to the Plan at its sole discretion. No discretionary contribution was made by the Company for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor contribution, and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor contributions plus earnings thereon. Vesting in the Company’s discretionary profit-sharing contributions, plus earnings thereon, is based on years of continuous service, as defined by the Plan. A participant is 100% vested after six years of credited service.

Notes from Participants

Participants may borrow from their accounts an amount greater than \$1,000 not to exceed the lesser of (1) \$50,000 reduced by the excess, if any, of the highest outstanding balance of the participant's loans during the one-year period before the loan over the outstanding balance of the participant's loans on the date of the loan; or (2) 50% of the participant's vested balance. Note terms range from one year to five years or up to ten years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar notes as defined in the Plan. Interest rates on loans at December 31, 2024 were 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Upon termination of service, death, disability, or retirement, a participant can elect to transfer their vested interest in the Plan to a qualified plan of a new employer, rollover their funds into an Individual Retirement Account, or receive their vested interest in the Plan in a lump-sum amount. Vested account balances less than \$5,000 will be automatically distributed in a lump-sum payment upon termination. Hardship withdrawals and in-service distributions at age 59 ½ are also permitted, subject to plan provisions described in the Plan document.

Administrative Expenses

Administrative expenses incurred by the Plan are paid by the Company on a discretionary basis. Substantially, all such expenses were paid by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts were \$3,135 and \$1,229, respectively. Forfeited non-vested accounts may be used to reduce employer contributions or pay administrative expenses. No forfeitures were used to reduce employer contributions or pay Plan expenses for the year ended December 31, 2024.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash Equivalents

At December 31, 2024, the Plan's cash consisted of an interest-bearing money market fund. This account was not insured by the FDIC.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its

investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Note 4 – Investment Contracts

Fully Benefit-Responsive

For the year ended December 31, 2023 and through December 4, 2024, the Plan invested in the Voya Fixed Account, a fully benefit-responsive traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus credited interest, less participant withdrawals. This contract maintains the participants' contributions plus a specified rate of interest and is guaranteed by Voya's claims paying ability. The guaranteed minimum interest rate is 1.00%. The expected and actual average yield earned by the Plan was 2.00% for the year ended December 31, 2023. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The following represents the total contract value of this investment contract held by the Plan.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the *IRC* or the failure of the trust to be tax-exempt under Section 501(a) of the *IRC*.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Other Plan Sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

Note 5 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Certain Plan investments are shares of mutual funds issued and managed by Voya; therefore, these transactions qualify as party-in-interest transactions. Fees paid to Voya Retirement Insurance and Annuity Company, Charles Schwab Trust Bank and SageView Advisory Group LLC for administrative services for the year ended December 31, 2024 totaled \$25,658.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

Note 7 – Tax Status

The non-standardized, pre-approved profit sharing plan document obtained its latest determination letter on September 21, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable sections of the *IRC*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
