Note 1: PLAN DESCRIPTION

The following description of the Interventional Cardiologists of Gainesville, P.A. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan covering all full-time employees of the Interventional Cardiologists of Gainesville, P.A. (the Plan Sponsor). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of the Directors of the Plan Sponsor.

Some administrative functions are performed by employees of the Sponsor. No compensation is remitted to the Sponsor for these services. The administration of the Plan is the responsibility of an administrator appointed by the Board of Directors of the Plan Sponsor.

Plan assets are held and managed by Fidelity Personal Trust Company, the custodian and the qualified institution for the Plan, (Fidelity or custodian) which invests contributions and Plan earnings. The custodian makes investment transactions as directed by the trustees.

Avantax is recordkeeper for the Plan. The recordkeeper performs certain plan administration functions, annual ERISA compliance testing, and Form 5500 preparation services.

The Plan Sponsor was acquired by CVAUSA Intermediate Holdings, Inc., on April 12, 2023. Plan assets were transferred subsequent to 12/31/2024. See Note 7 for additional information on the Plan Merger.

Eligibility

Employees, except collective bargaining (union) employees and non-resident aliens, may become a participant of the Plan when they have worked 1,000 hours during one year of service and are age 21 or older. An eligible employee may enter the Plan on the next semi-annual entry date after all entry requirements have been met.

Note 1: PLAN DESCRIPTION (Continued)

Contributions

Each year, participants may contribute up to 100 percent (%) of pretax annual compensation, as defined in the Plan. Additionally, participants may make post tax deferrals into a Roth 401(k) account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. In addition, certain participants have self-directed brokerage accounts which can be invested in mutual funds or in equities. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan Sponsor makes safe harbor matching contributions of 100% of each dollar of participant contribution up to 3% of participant's compensation, plus 50% of each dollar of participant contribution in excess of 3% but not in excess of 5% of participant's compensation. Additionally, the Plan Sponsor may make an additional profit sharing contribution not to exceed 6% of the participant's compensation. There was no profit sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan Sponsor's matching contributions, as well as allocations of the Plan Sponsor's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions, employer safe harbor contributions and the earnings thereon. Vesting in employer discretionary matching and profit sharing is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have up to three loans outstanding at a time. Loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate ranging from 4.25% to 9.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan has an automatic roll-over distribution for balances over \$1,000. The form of payment is a lump-sum distribution or an installment distribution if a participant's vested interest is greater than \$5,000. Participants with prior money purchase balances are subject to distribution limitations per the plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,904 and \$26,598, respectively. These accounts will be used to reduce future employer contributions and fund expenses paid by the Plan. During 2024, the Plan Sponsor used \$2,200 of the forfeitures to pay plan fees. Also, in 2024, employer contributions were reduced by \$23,934 from forfeited nonvested accounts.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV.

The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments. During the year ended December 31, 2024, expenses of \$142,760 were paid by the Plan and allocated to participants' accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through the date that the financial statements were available to be issued, October 15, 2025. See Note 7 – Plan Termination for relevant disclosures. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by Fidelity Personal Trust Company, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment income and net appreciation in the value of investments information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule, Schedule H, Line 4i - Schedule of Assets (held at end of year) as of December 31, 2024, except for notes receivable from participants.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: The account is a government money market mutual fund that seeks to preserve the value of the Plan's investment. The fund is valued based on the closing market price.

Self-directed accounts

Equities: Valued at the closing price on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts ("CCTs"): The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$11,116 for the year ended December 31, 2024.

Fidelity provides certain administrative services to the Plan pursuant to a service agreement between the Plan Sponsor and the Plan's Custodian. The Custodian receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the service agreement, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, the Plan received credits under this program of \$12,001 and used credits towards plan fees of \$12,001, with no balance available for future use. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Note 7: PLAN TERMINATION

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

The Plan Sponsor was acquired by CVAUSA Intermediate Holdings, Inc., effective April 12, 2023.
