Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Summit Point Raceway Associates 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Summit Point Raceway Associates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Note 1: The Plan and its significant accounting policies:

The following description of the Summit Point Raceway Associates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established by Summit Point Raceway Associates, Inc. (the "Company") on January 1, 2023 to provide benefits to eligible employees. Prior to January 1, 2023, the Company was a participating employer in the Xator 401(k) Retirement Plan. On April 11, 2023, Xator 401(k) Retirement Plan's assets were liquidated and the portion of assets held by the Company's employees totaling \$2,401,597 was transferred into the Plan. The Plan covers all employees of the Company, other than nonresident aliens, union employees, and residents of Puerto Rico, who are 18 years of age or older and have completed 2 months of service. Employees classified as temporary, part-time, or seasonal are eligible to participate only if they complete 1,000 hours of service within a 12-month period. Effective January 1, 2024, the Plan adopted a restated Plan document and adoption agreement. The Plan is subject to the provisions of ERISA.

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, designated officers of the Company act as trustees. In 2023, the Company contracted with Reliance Trust Company ("Reliance") and Transamerica Retirement Solutions Corporation, a division of Transamerica Financial Life Insurance Company, to act as custodian and recordkeeper, respectively. In 2024, the Company contracted with Transamerica Financial Life Insurance Company ("Transamerica") and Transamerica Retirement Solutions Corporation to act as custodian and recordkeeper, respectively. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan pays asset management fees, which are included in administrative expenses. Fees related to the administration of distributions and loans are charged directly to the participant's account and are included in administrative expenses.

Investment valuation and income recognition - Investments of the Plan were held by Reliance in 2023 and Transamerica in 2024 and invested based solely upon instructions received from participants. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued) - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. The Plan administrator believes all notes receivable from participants are collectible.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The Plan has not applied for or received a favorable determination letter because it is using a prototype plan approved by the Internal Revenue Service. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 1: The Plan and its significant accounting policies: (continued)

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since December 31, 2024 due to normal market fluctuations.

Adoption of new accounting policy - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, total net assets available for benefits and change in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze their financial assets for expected credit loss under this new standard.

Reclassifications - Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current year financial statements. Net assets available for benefits and the increase in net assets available for benefits are unchanged due to these reclassifications.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. These eligible employees may also elect to make Roth elective deferrals. Roth elective deferrals are made after taxes have been withheld. Participants may contribute a combination of pre-tax elective deferrals and Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction.

Participant contributions (continued) - Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - The Company provides a safe harbor matching contribution equal to 100% of each eligible participant's contributions up to 4% of the participant's eligible compensation. The safe harbor matching contribution was \$164,703 and \$152,433 for the years ended December 31, 2024 and 2023, respectively. The Plan also allows for a discretionary profit sharing contribution in an amount determined by the Company. No discretionary profit sharing contribution was made for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, administrative expenses and an allocation of the Company's contribution, if any. Allocation of the Company's safe harbor matching contribution is based on participants' contributions. Allocation of the Company's discretionary profit sharing contribution is based on participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral, rollover contributions, safe harbor contributions and related earnings. Effective January 1, 2023, new participants are fully vested in the employer's discretionary profit sharing contributions allocated to their account after three years of credited service. Profit sharing contribution balances that transferred from the Company's old plan to the Xator 401(k) Retirement Plan on January 1, 2020 and then transferred back to this Plan on April 11, 2023 will vest on a six-year graded schedule (0% for less than two years, 20% for two years, and then increasing by 20% for each subsequent year).

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,715 and \$-0-, respectively. These accounts will be used to reduce future employer contributions and pay administrative fees. \$8,500 were used to pay administrative fees for the year ended December 31, 2024. No forfeitures were used to reduce employer contributions or pay administrative fees for the year ended December 31, 2023.

Payment of benefits - Upon termination, the participant or beneficiary will receive the benefits in a lump-sum amount equal to the value of the participant's vested interest in their account, or in installments, paid at least annually over a period not exceeding the joint and survivor life expectancy of the participant and beneficiary. The Plan allows for automatic lump-sum distributions of participant vested account balances below \$5,000.

Notes receivable from participants - The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance and bear interest at the available market financing rates. The loans must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a primary residence. The specific terms and conditions of such loans are established by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Note 3: Certified information:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by Transamerica and Reliance, the custodians of the Plan in 2024 and 2023, respectively.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by Transamerica as of December 31, 2024.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4: Fair value measurements: (continued)

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund - valued at cost, which equates to fair value. This is a depository liability of Transamerica valued based on their general unallocated accounts.

Note 5: Related party transactions and party in-interest transactions:

Certain Plan investments are mutual funds managed by Transamerica. Transamerica is the custodian and therefore, these transactions qualify as party in-interest transactions. Also, the Plan paid Snyder Cohn, PC in 2024 for a portion of the Plan's 2023 audit fees. These fees were paid out of forfeitures. Additionally, the Plan issues loans to participants, which are secured by the participants' accounts. These transactions are considered party in-interest transactions.

Note 6: Reconciliation of financial statements to Schedule H of Form 5500:

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise from classification differences in investment income.

Note 7: Plan termination and/or modification:

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Note 8: Subsequent events:

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
