(1) Description of the Plan

The following description of the Mercury Aircraft Inc. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined-contribution plan available to substantially all employees of Mercury Aircraft Inc. and Mercury Minnesota, Inc. (the “Companies”) who have attained 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

(b) Contributions

Under the provisions of the Plan, eligible participants may contribute up to 75% of their compensation to the Plan in the form of pre-tax or Roth contributions, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. All participants that are automatically enrolled in the Plan begin contributing 3% of their annual eligible compensation. On an annual basis automatically enrolled participants contribution elections are increased 1% up to a maximum of 15% of their annual eligible compensation, unless the participant elects otherwise. Additionally, participants may direct the investment of their account balance into various investment options offered by the Plan. Participants may transfer amounts from other qualified plans into this Plan with the consent of the Plan Administrator. The Companies may match 100% of employee contributions up to 3% of the participant’s eligible compensation, as defined in the Plan document. The Companies may also make discretionary matching contributions based on each participant’s eligible compensation deferred into the Plan each Plan year. There were no matching contributions or discretionary matching contributions made in 2024.

Effective July 2023, the Plan was amended to allow for discretionary nonelective contributions (profit sharing contributions) based on each eligible participants compensation. Profit sharing contributions equaling 3% of participants compensation were made starting in July 2023 (see note 8). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and Plan earnings (losses) and charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of the participant's account plus earnings thereon is based on the vesting schedule below:

(e) Notes Receivable from Participants

The Plan allows for hardship loans to participants. These loans must be applied for and are subject to review and approval. Specified hardship rules per the Plan document must be complied with prior to granting any hardship loan. Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Generally, loans must be repaid within five years, unless for the purchase of a primary residence. Prevailing interest rates will apply.

(f) Payment of Benefits

The Plan provides for normal retirement benefits upon reaching the age of 65 and has provisions for early retirement, disability, in-service, death and termination benefits for those participants who are eligible to receive such benefits.

(g) Forfeitures

In accordance with the Plan document, forfeitures of non-vested employer contributions and earnings thereon are applied to reduce future employer contributions. During 2023, approximately \$16,200 of forfeitures were used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$28,900 and \$15,800, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

The Plan's expenses are paid either by the Plan or the Companies, as provided by the Plan document. Expenses that are paid directly by the Companies are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

(g) Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Stable Value Fund: Valued at the NAV of the individual collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their employer contributions.

(5) Tax Status

The Plan adopted a non-standardized form of a prototype plan. The Internal Revenue Service (“IRS”) has determined and informed the prototype plan sponsor by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, interest income on notes receivable from participants, and assets transferred to the Plan for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity).

(7) Party-in-Interest Transactions

Certain Plan investments are managed by an entity related to Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, transactions involving these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

(8) Transfer to the Plan

During 2023, the Plan Sponsor completed the termination and liquidation of The Retirement Plan for Employees of Mercury Aircraft, Inc., a defined benefit pension plan covering certain employees of Mercury Aircraft, Inc. and Mercury Minnesota, Inc. In connection with the liquidation, remaining plan assets, after satisfying all pension obligations and expenses, amounting to \$1,846,910 were transferred to the Plan and credited to a suspense account to be used over a seven year period to fund non-elective profit sharing contributions.

For the years ended December 31, 2024 and 2023, the Plan credited employer profit sharing contributions amounting to \$285,090 and \$129,201, respectively, to participants out of this suspense account. At December 31, 2024 and 2023, the amount of funds available for future non-elective profit sharing contributions, after an allocation of Plan earnings and administrative expenses, amounted to \$1,551,487 and \$1,753,421, respectively.

(9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
