## Independent Auditor's Report

To the Board of Directors

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rogue Community Health 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1 - DESCRIPTION OF PLAN**

The following description of Rogue Community Health 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Rogue Community Health (the "Company"). The Company is named as the Plan Administrator. This is a salary deferral and matching Plan. An employee becomes eligible to make salary deferrals on such employee's first day of employment and an employee becomes eligible to receive the match after the completion of three consecutive full calendar months of employment during which the employee has been credited with at least 250 hours of service or the completion of a Year of Service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute to the Plan through salary deferrals. During any calendar year, a participant may defer any amount up to the Elective Deferral Dollar Limit under Internal Revenue Code §402 and the Internal Revenue Code §415 Limitation. Participants who have attained age 50 before the end of a Plan year are eligible to make catch-up contributions. Roth Deferrals are also permitted under the Plan. After 90 days all employees will receive an employer contribution of 1% of eligible compensation, whether they contribute or not. Additionally, for the employees who make contributions, an additional employer matching contribution will be made based on the Participant's length of service and contribution and is determined as follows: after 90 days to 1 year the match is up to an additional 1% if the employee contributes up to 1% for a maximum employer contribution of 2% of eligible compensation; 1 to 3 years the match is up to an additional 3% if the employee contributes up to 3% for a maximum employer contribution of 4% of eligible compensation; 4 years the match is up to an additional 4% if the employee contributes up to 4% for a maximum employer contribution of 5% of eligible compensation; 5 years and over the match is up to an additional 5% if the employee contributes up to 5% for a maximum employer contribution of 6% of eligible compensation.

**Participant Accounts**

Each participant's account is credited with the participant's salary deferrals, the Company's matching contributions and an allocation of Plan appreciation or depreciation; and may be charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of the contributions into various investment options offered by the Plan.

**Vesting**

The Plan provides that participants are always fully vested in salary deferrals and earnings allocated to their accounts. Participants are 100% vested in the Employer's contributions plus the earnings. In applying the vesting rules under the Plan, the following special rules apply: A participant that is not employed on or after January 1, 2015 is subject to the prior vesting schedule.

**Investment Options**

Upon enrollment in the Plan, a participant may direct contributions in any one of several investment options offered by Variable Annuity Life Insurance Carrier Co. (VALIC).

**NOTE 1 - DESCRIPTION OF PLAN (Continued)**

**Notes Receivable from Participants**

Participants may borrow amounts ranging from \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance. The participant's total amount outstanding during any twelve-month period may not exceed \$50,000. The notes are secured by the participant's vested account balance and bear interest at rates of prime plus 1% at time of issue. The note repayment period may not exceed five years, unless the note is for the purchase of a primary residence. Note principal and interest is paid directly by participants to the Plan custodian.

**Payment of Benefits**

Upon termination of service, a former employee whose vested account balance exceeds \$5,000 may elect a distribution of the entire vested account balance in cash, or as a rollover to an IRA or another qualified plan. A distribution of only a portion of the vested account balance may instead be elected. A former employee may also elect to receive a distribution in the form of an annuity. Alternatively, a distribution in the form of installment payments may be elected in order to satisfy required minimum distributions. If the vested account balance is less than or equal to \$5,000 upon termination of service, a former employee may elect a distribution of the entire vested account balance in cash, or as a rollover to an IRA or another qualified plan. If an election is not properly made, it will be distributed to a rollover IRA for the former employee. In-service hardship distributions of participants' salary deferrals are allowable under certain circumstances.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for unallocated insurance contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued utilizing information provided by the Trustee insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable charged directly to the participant's account and certain record-keeping and consulting fees paid by the Plan. Investment-related expenses are included in net depreciation of fair value of investments.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by VALIC, the custodian of the Plan's investment assets.

**NOTE 4 - INVESTMENTS**

During 2024, the Plan's investments in mutual funds (including gains and losses on investments bought and sold as well as held during the year) appreciated in value by 1,473,465.

**NOTE 5 - FAIR VALUES OF FINANCIAL INSTRUMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**NOTE 5 - FAIR VALUES OF FINANCIAL INSTRUMENTS (Continued)**

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used December 31, 2024 and 2023.

*Mutual Funds:* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – DEPOSIT ADMINISTRATION CONTRACT**

The unallocated insurance company accounts represent a deposit administration contract entered into by the Plan with VALIC. VALIC maintains the contributions in an unallocated fund whose assets are invested with other assets in the general account of VALIC. These assets are recorded at contract value, which represents contributions, plus earnings, less withdrawals and administrative expenses. Certain events might limit the ability of the Plan to transact at contract value; however, no such events are probable of occurring at the time of this filing. Generally, participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest rates associated with these contracts as of December 31, 2024 range from 1.0% to 5.0%. The contract value of the deposit administration account at December 31, 2024 and 2023 was \$1,686,320 and \$1,518,609, respectively.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company may terminate this Plan at any time by delivering to the Plan Administrator written notice of such termination, subject to the provisions of ERISA. In the event of plan termination, all amounts credited to an affected participant's account become 100% vested.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

VALIC is the custodian of Plan assets and manages investments offered through the Plan and therefore qualifies as a party in interest. Fees paid by the Plan for the administrative services amounted to \$10,034 for the year ended December 31, 2024.

**NOTE 9 - TAX STATUS**

The Internal Revenue Service does not issue determination letters for 403(b) plans at this time. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

The Company has adopted the income standard related to the recognition and measurement of uncertain tax positions. The Company believes that the adoption of this standard has no effect on its financial statements. The Company is no longer subject to examinations by major tax jurisdictions for the years prior to 2018.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
