Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gexpro Services 401(k) Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1. Description of the Plan

General

The following description of the Gexpro Services 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was formed on April 1, 2020 and is a defined contribution plan sponsored by GS Operating, LLC (Company) for the benefit of its employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Reliance Trust (Reliance) serves as plan trustee. Certain plan assets are invested in funds offered by T. Rowe Price, who serves as third-party administrator (TPA).

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 80% of eligible compensation. Participants over 50 years of age are allowed catch-up contributions subject to allowable amounts under Internal Revenue Code (IRC) regulations. Employee rollover contributions are also permitted.

The Plan elected to operate as a 401(k) safe harbor plan in order to satisfy certain nondiscrimination testing requirements. During the years ended December 31, 2024 and 2023, the Plan made nondiscretionary safe harbor matching contributions on behalf of all eligible employees equal to 100% of the first 3% of the participant's eligible compensation contributed to the Plan and 50% of the next 2% of eligible compensation contributed to the Plan. All Company nondiscretionary safe harbor matching contributions vested immediately. No discretionary employer matching contributions were made during 2024 or 2023.

Participant Investment Account Options

Investment account options available include various funds. Participants have the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The initial automatic deferral amount will increase by 1% annually, as of each anniversary of the participant's date of hire, up to a maximum of 10%.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary contributions, and plan earnings and losses. Each participant's earnings are invested separately according to the participant's investment direction so that each participant's account realizes appreciation or depreciation based on related investment performance. Plan earnings are calculated and credited to each participant's account on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions and related earnings thereon. Vesting in the Company's nondiscretionary safe harbor matching and discretionary matching contributions portion of their accounts plus earnings thereon is immediate upon contribution.

Notes Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000.

The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator. A participant may only have two loans outstanding at any time.

Payment of Benefits

Distribution of a participant's vested account balance is available upon the participant's retirement, death, disability, termination of employment, attainment of age 59½, or for a financial hardship meeting the requirements of the Internal Revenue Service (IRS) regulations. Participants may elect to receive the value of their account in either a lump-sum, installment, direct rollover, or a combination thereof. At December 31, 2024 and 2023, there were no requested unpaid benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) per shares held by the Plan at year-end. The Plan's investment in the common collective trust is valued at NAV per share utilizing the practical expedient at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons. These transactions qualify as party-in-interest transactions. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are shares of mutual funds managed by T. Rowe Price, who is the Plan's TPA. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurement must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no Level 3 securities at December 31, 2024 or 2023.

Investments Measured Using the NAV per Share Practical Expedient

The following table summarizes investments for which the fair value is measured using the NAV per share practical expedient as of December 31, 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 6. Risks and Uncertainties

The Plan provides for various variable investment options in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 7. Transfers of Plan Assets

Effective January 1, 2024, Resolux, Inc. employees began participating in the Plan. During 2024, certain participants were transferred into the Plan from Resolux Inc. 401(k) Profit Sharing Plan and Trust. An aggregate of \$915,237 was transferred in and is included as assets transferred in in the accompanying statements of changes in net assets available for benefits.

Effective January 1, 2025, the Plan merged with Lawson Products, Inc. and Certain Affiliates Retirement Plan, and plan assets were transferred out of the Plan. The conversion initiated a "Black Out" period beginning December 26, 2024 and continued through December 31, 2024. During this period, funds could not be applied to the employee-selected funds with T. Rowe Price or withdrawn from the Plan until the conversion was completed. At the end of the Black Out period, these funds were transferred to Fidelity and invested in funds as requested by each participant. On December 31, 2024, the Plan's investments were liquidated in anticipation of the transfer to Fidelity in January 2025, and the amounts were maintained in a cash account as of December 31, 2024.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 10. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype 401(k) plan and trust document sponsored by DST Retirement Solutions, LLC. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the IRC and that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$127 were not remitted within the required time period for the year ended December 31, 2023. These delinquent remittances were corrected during 2023. There were no such delinquent remittances during the year ended December 31, 2024.

Note 12. Subsequent Events

Effective January 1, 2025, the Plan merged with Lawson Products, Inc. and Certain Affiliates Retirement Plan, and plan assets were transferred out of the Plan (Note 7).

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
