## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements**

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan for the Employees of the Arc of Atlantic County, Inc. (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan, which was initially adopted in January 2009, is a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all eligible employees, who are not a non-resident alien, independent contractor or otherwise covered by a collective bargaining agreement, of The Arc of Atlantic County, Inc (the “Company” or “Employer”).

There is no minimum age or service requirement to make salary deferral contributions. For an employee to receive Employer matching contributions and Employer base contributions, an employee must have completed one year of service and be 21 years of age or older.

The Plan is managed through Mutual of America Life Insurance Company (“Mutual of America”).

**Contributions**

Each year, eligible participants may contribute up to 100% of their eligible compensation, subject to the maximum Internal Revenue Service (“IRS”) limitations. For year 2024, the applicable dollar amount was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a base contribution equal to 4% of participant’s eligible compensation. The base contribution is made whether or not the participant makes a salary deferral contribution. Employer base contributions are automatically invested in an interest accumulation account unless otherwise specified by the participant.

For participants with less than 5 years of service, the Company will also make a matching contribution equal 100% of the participant’s salary deferral contribution, up to 2% of the participant’s eligible compensation received during the Plan year.

For participants with 5 or more years of service, the Company will make an additional matching contribution equal to 50% of the participant’s salary deferral contribution that exceed 2% of the participant’s eligible compensation, up to 6% of the participant’s eligible compensation received during the Plan year.

During the year ended December 31, 2024, the Company made Employer contributions totaling \$353,431 to the Plan.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Plan participants are 100% vested in the account balance attributable to their deferred compensation plus actual earnings thereon. A participant becomes 100% vested in employer base and matching contributions upon 3 years of service.

Participants are immediately 100% vested upon death or total and permanent disability.

**Forfeitures**

Forfeitures of non-vested Company contributions may be used to reduce Employer contributions. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeitures available to the Plan.

**Plan Loans**

Participants may take out loans directly from Mutual of America. Loans must be a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested accrued benefit of the participant's account. The participant must pledge sufficient collateral, which must be maintained in the investments of the plan.

The loans are not shown in the Plan's statements of net assets available for benefits, as the loans are not made from Plan assets and are, therefore, not considered receivables to the Plan. Loan interest rates are determined by Mutual of America, and commensurate with prevailing interest rates. Principal and interest are paid ratably in accordance with the loan agreement directly to Mutual of America. Mutual of America maintains a lien against the participants' account balance. A default charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

Loan balances outstanding to Mutual of America from the Plan's participants totaling \$171,020 and \$131,750 as of December 31, 2024 and 2023, respectively. There were no defaulted loans subject to repayment from participant accounts as of December 31, 2024 and 2023. During the year ended December 31, 2024, there was no loan collateral foreclosed upon by Mutual of America and distributed from participant accounts to repay defaulted loans. Defaulted loans are distributed from participant accounts to repay defaulted loans when a participant reaches age 59 ½ or is terminated, whichever comes first.

**NOTE 1: DESCRIPTION OF PLAN (continued)**

**Payment of Benefits**

In the event of termination of employment due to death, disability, or retirement, a participant can receive their participant contributions and earnings thereon, and vested Company contributions and earnings thereon, in the form of a single-sum payment, installment payments or an annuity contract. Upon termination of employment, the Plan has a mandatory cash-out provision for participants with less than \$1,000 in their account, which does not require consent from the participant. Hardship withdrawals from accounts which are fully vested are permitted by the Plan. In-service distributions are allowed for participants after reaching age 59 ½.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined benefit contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Mutual of America. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3: INFORMATION CERTIFIED BY MUTUAL OF AMERICA**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Investments in registered investment companies consist of shares of mutual funds that are valued at quoted market prices which represent the net asset value ("NAV") shares held by the Plan at year-end.

*Money Market Fund:* Valued at the quoted NAV of shares held by the Plan at year end.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a fully benefit-responsive investment contract with Mutual of America Life Insurance Company totaling \$1,411,373 and \$1,468,726 as of December 31, 2024 and 2023, respectively. Mutual of America Life Insurance Company maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value (See Note 2). Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

**NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (continued)**

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the contract issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the contract issuer.

**NOTE 6: RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Mutual of America; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

**NOTE 7: TAX STATUS**

Currently, 403(b) Plans are not required to submit Plans to the Internal Revenue Service ("IRS") for determination. However, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and ERISA.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7: TAX STATUS (continued)**

The IRS will provide determination letters to 403(b) plans beginning in June 2023 in accordance with IRS Revenue Procedures 2022-40. The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

**NOTE 9: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. The Company also reserves the right to amend, modify, suspend or terminate the Plan permanently or temporarily, at such time as they deem appropriate. In the event of Plan termination or if the Company elects to discontinue contributions, the total value of each participant's account will be fully vested.

**NOTE 10: EXCESS CONTRIBUTIONS PAYABLE**

During the year ended December 31, 2023, the Plan failed to comply with nondiscrimination rules. Failing these tests required the Plan to refund contributions to certain affected participants. As of December 31, 2023, excess contributions payable totaled \$2,554, and is included in liabilities on the accompanying statements of net assets available for benefits, as the amount were not paid until after year end.
