## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of The 401(a) Profit-Sharing Plan of Occupational Training Center of Burlington County, Inc. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### A. DESCRIPTION OF PLAN

The following brief description of The 401(a) Profit-Sharing Plan of Occupational Training Center of Burlington County, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that became effective on January 1, 2005, and was amended and restated effective April 18, 2011. The Plan was established in a manner to satisfy the Employee Retirement Income Security Act of 1974 ("ERISA") under Section 404(c) of the Internal Revenue Code ("IRC") as a participant directed plan. The Plan is available to all employees who work on government contracts and was established to satisfy the "Bona Fide" health and welfare fringe benefit requirements of the Federal Service Contract Act ("FSCA"), and the Wage Standards for the New Jersey State Building Service Contract Act ("SBSCA").

The Occupational Training Center of Burlington County, Inc. (the "Center"), a 501(c)(3) organization, is the Plan Administrator and sponsor of the Plan. Epic Advisors, Inc. (the "Recordkeeper") is the recordkeeper for the Plan. Matrix Trust Company and Charles Schwab Trust Bank (the "Trustees") are the trustees for the Plan for the years ended December 31, 2024 and 2023, respectively.

#### **Contributions**

There is no minimum service requirement for a participant to receive employer contributions under the Plan and no employee contributions are required or permitted. The amount earned by each participant is based upon the hourly rate contained in a Wage Determination as issued by the United States of America government under the FSCA, and a Wage Determination as issued by the State of New Jersey government under SBSCA; multiplied by the hours paid not to exceed 40 hours per week (the "Earned Amount"). The amount contributed to the Plan is the Earned Amount less the participant's cost of other fringe benefits paid on their behalf including health insurance. All contributions to the Plan are credited to the participant's individual account on the date received by the Trustees. The Trustees provide participants with quarterly statements indicating the contributions, interest and investment gains or losses, charges, and opening and closing balances. Employer contributions are calculated and accrued monthly by the Center. Although required to be remitted quarterly, the Center remits contributions monthly.

#### **Participant Accounts**

Each participant's account is credited with the employer's contributions and Plan earnings; while losses and expenses are deducted and allocated based on participant account balances.

#### **Vesting**

Participants are immediately vested in all employer contributions, rollovers and transfers from qualified plans and actual earnings or losses thereon.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$517 and \$517, respectively. Forfeited non-vested accounts are available to reduce future employer contributions or pay Plan expenses. For the year ended December 31, 2024, no amounts were used to reduce employer contributions or pay Plan expenses.

### A. DESCRIPTION OF PLAN (CONTINUED)

#### Expenses of the Plan

The Plan's administrative expenses are paid from Plan assets.

#### Investment Options

Participants may direct investment of their account balances into the investment options offered under the Plan, including registered investment company funds. Participants can place their contributions in one or more of the investment options available under the Plan. Participants can direct the allocation of future contributions or transfer money from one investment option to another via the internet, or by completing a form provided for that purpose by the Plan Administrator or the Trustees.

#### Payment of Benefits

Unless otherwise elected, on termination of service due to death, disability or normal retirement, a participant or beneficiary will receive 100% of his or her vested account balance. Participants can withdraw amounts from their individual account after attaining the normal retirement age of 65 or early retirement age of 55 (after five years of participation in the Plan). Distributions are also permitted if the participant incurs a hardship or a disability that prevents the participant from working. Amounts can also be withdrawn upon termination of employment. Benefit payments may be made in a lump sum, installments over a period not to exceed the participant's life expectancy, or ad hoc after termination.

### B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Trustees. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

### C. INFORMATION CERTIFIED OR PROVIDED BY THE TRUSTEES

The plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company and Charles Schwab Trust Bank, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Cash and Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, net as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Cash and Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### D. FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in less active markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be active.

Common collective trust funds: Stated at NAV as reported to the Plan by the Trustees, based on the market values of the underlying assets. Because the common collective trust funds invested in by the Plan do not publish a daily NAV, the NAV is a practical expedient in determining the fair value of the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in Fair Value Levels**

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

**E. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Center reserves the right to amend, modify, suspend or terminate the Plan permanently or temporarily, at such time as it deems appropriate, without the consent of or prior notice to any employee, retiree or beneficiary, subject to the provisions of ERISA. Participants are immediately vested in all employer contributions, rollovers and transfers from qualified plans and actual earnings or losses thereon. Only the Center may amend the Plan. No such change is currently being contemplated; however, in any such event, the participant's right to their vested benefits is nonforfeitable.

**F. TAX STATUS**

The Center has adopted a prototype plan which received a favorable determination letter from the Internal Revenue Service on March 31, 2014, which stated that the prototype plan and trust were designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2024 and 2023. Consequently, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. CONCENTRATIONS OF CREDIT RISK AND UNCERTAINTIES**

The Plan invests in various investment instruments. Investment securities in general are exposed to various risks, such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**H. TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan paid administrative expenses to the Recordkeeper and the Trustees for the year ended December 31, 2024, as follows:
