NOTE 1 • DESCRIPTION OF THE PLAN

The following description of the Vacuum Truck Rentals, LLC (hereafter referred to as the "Company") 401(k) Retirement Plan (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution benefit plan in which all the employees of the Company are eligible to participate upon completion of three months of service and attainment of age twenty-one. An employee may begin participating on the first day of the Plan year quarter following the date the employee satisfies the Plan eligibility requirements. The Company's Board of Directors and the Plan Administrator control and manage the operation and administration of the Plan. Empower Retirement, LLC serves as the Administrator of the Plan. Empower Retirement, LLC and Talcott Life Insurance Company serve as the Trustees of the Plan assets. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company is a Mississippi Limited-Liability Company formed in 1999 to provide vacuum truck rental services to consumers in Mississippi and throughout the eastern United States.

Contributions

Participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan. The contribution is limited by law and adjusted by the Secretary of the Treasury for the percentage increase in the Consumer Price Index each year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 100 percent of the first 3 percent of base compensation deferred and the Company contributes 50 percent of compensation deferred between 3 and 5 percent of base compensation that a participant contributes to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100 percent vested in their contributions, the Company's matching contributions, plus actual earnings thereon.

NOTE 1 • DESCRIPTION OF THE PLAN (continued)

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any investment option allowed by the Plan. Participants may change their investment options daily via telephone or internet.

Loan Policy

Loans are not permitted under the Plan.

Payment of Benefits

Upon termination of service, participants with vested benefits of \$7,000 or less are automatically paid a single lump sum payment, unless participants request a direct rollover of such funds to an IRA. Upon termination of service due to death, disability or retirement, participants with vested benefits greater than \$7,000 may elect to receive either a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Administrative Expenses

Trustee, administration and valuation fees totaling \$48,112 and \$40,139, were absorbed by the Plan in 2024 and 2023, respectively. All other administrative expenses were paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates used will change within the next year.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Employee and Employer Contributions

Employee deferral contributions and respective matching contributions are recognized as additions to net assets on the date on which such employee deferrals would otherwise have been payable to the participant. Employee rollover contributions are recognized as an addition to net assets on the date transferred from other qualified plans.

Valuation of Investments and Income Recognition

Investments are stated at year-end fair value (except for the fully benefit-responsive investment contract, which is reported at contract value and the common collective trust, which is reported at net asset value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits. See Note 4 for a discussion of fair value measurements.

The common collective trust funds are valued at the net asset value per share, or its equivalent, of the funds, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on any investment.

Purchases and sales of securities are recorded on a trade-date basis. Income from investments is recorded and accrued as earned. Capital gain distributions are included in dividend income.

Concentration of Market Risk

The Plan assets held during 2024 and 2023 included a significant amount of registered investment companies and common collective investment trust funds, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility.

Additionally, registered investment companies and common collective investment trusts may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including mortgages backed by subprime mortgage loans. The values, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issues and changes in interest rates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement, LLC and Talcott Resolution Life Insurance Company (the Trustees of the Plan).

NOTE 4 • FAIR VALUE MEASUREMENTS

Fair value measurements define fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Fair value measurements establish a fair value hierarchy that prioritizes the observable and unobservable inputs used to measure fair value into three broad levels:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The trusts publish their daily NAV and transact at that price.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Advance written notice is required for any redemption directed by the Plan Sponsor. Redemptions of \$1,000,000 of a Plan's assets invested in the Funds require 5 business days advance notice. Redemptions will be made on a pro-rate basis from the Plan's interest in the Fund. Participation in the collective trust may be terminated by either party with 30 days advance notice.

The funds offered under the collective trust are intended to provide long-term investments with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund.

NOTE 5 • INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a traditional fully benefit-responsive investment contract with Talcott Resolution Life Insurance Company (the "Insurer") totaling \$184,974 and \$164,767 for December 31, 2024 and 2023, respectively. The Insurer maintains the contributions in a general account which invests primarily in synthetic investment contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon by the issuers that is reviewed quarterly and cannot fall below zero percent. The interest rate was 2.90 percent and 2.80 percent for 2024 and 2023, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

This guaranteed investment contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 • INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Martin, Martin, Randall and Associates, Inc. The prototype plan has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at December 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 7 • RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and collective investment trusts managed by an affiliate of Empower Retirement. Empower Retirement, LLC and Talcott Resolution Life Insurance Company act as Trustees for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Additionally, Martin, Martin, Randall and Associates, Inc. provides recordkeeping services for the Plan. Such fees are based on customary and reasonable rates for such services. Party-in-interest transactions include certain trustees, administration and valuation fees paid to such parties.

NOTE 8 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan remitted all employee contributions to the Plan, contributions of \$23,273 were not remitted within the required time period for the year ended December 31, 2024. The Plan has corrected the matters through the Voluntary Fiduciary Correction Program and made the participant accounts whole.

NOTE 9 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. SECURE 2.0 has key effective dates which vary by provision. The Plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
