Note 1. Description of the Plan

The following description of the District Council 37 Local 389 Home Care Employees Health and Welfare Fund (the “Fund” or “Plan”) only provides general information about the Plan’s provisions. Participants should refer to the plan agreement for a complete description of the Plan’s provisions.

General - The Plan is a multiemployer health and welfare plan established under the terms of collective bargaining agreements (CBAs) between the District Council 37 Local 389 Community and Social Agency Employees Union, AFSCME, AFL-CIO (the Union), and a group of contributing home care agencies (Employers). The Plan is governed by the board of trustees (the Trustees). The Plan provides health and welfare benefits to eligible participants, and certain benefits to their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility - Participants become eligible for benefits on the first day of the month following the date of the contract, provided an enrollment card has been submitted and further provided that they have satisfied the hours worked services rule of 30 hours per week on average, for three consecutive months after their hire date for a total of no fewer than 360 hours worked during the period.

Contributions - The Plan is primarily funded by employer contributions pursuant to collectively bargained agreements, and to a much lesser extent, by the participants’ contributions.

Benefits - The Plan provides hospitalization, major medical, prescription drug, dental, and optical benefits to participants in accordance with the provisions of the Plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Insured Benefits - The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits. In addition, the plan purchases stop loss insurance to actively manage catastrophic medical claims.

Self-Insured Benefits - All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan uses a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

Note 2. Summary of Accounting Policies

Basis of Accounting and Use of Estimates - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of Plan benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of Plan benefit obligations.

Refunds and Rebates - Refunds due from the Plan's prescription drug administrator are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable on the statements of net assets available for benefits, with the offset against claims paid. Pharmacy rebates totaling \$29,627 and \$31,147 were recognized and netted against claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Stop-Loss - Claims that were already paid from the Plan that exceeded the stop-loss coverage and are due to the Plan at year-end are recorded as a receivable. Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds totaling \$- and \$72,117 have been netted against claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Employers' Contributions and Related Receivables - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Payroll contributions were determined from reports submitted by employers on a self-reporting basis based on contribution rates stipulated in each respective collectively bargained agreement. The amount of employer contributions receivable represents the estimated contributions due but not paid prior to year-end.

Investment Valuation and Income Recognition - Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by its investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Accounting Policies (continued)

Property and Equipment - Office equipment, furniture and software are stated at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the related assets which ranges from 3 to 5 years. Expenditures for maintenance and repairs are expensed as incurred while additions and improvements that extend the life of the asset are capitalized.

Fees and Other Expenses – Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The administrative expenses are initially paid by the Plan and the Plan is subsequently reimbursed by District Council 37 Local 389 Home Care Employees Pension Fund (or “Pension Fund”) for the Pension Fund’s certain shared expenses i.e., facilities, equipment and personnel as well as other administrative costs. The total amount of administrative expenses in the attached Schedules of Administrative Expenses is reduced by the share of expenses allocated to the Pension Fund. See also Note 8 – Related Party Transactions. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Benefit Obligations and Postemployment Benefit Obligations

Amounts currently payable by the Fund are based on claims payable and amounts for claims incurred but not reported (IBNR) based on estimates provided by the Plan's actuary which have not yet been paid from the net assets of the Fund.

Postemployment benefit obligations are the amount for accumulated eligibility credits at year-end based on estimates provided by the Plan's actuary, which are determined by using historical claim patterns experienced by the Fund.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the Fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and are considered a level 1.

Common collective trust: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

Note 6. Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income. The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Priorities Upon Termination of the Plan

Although the board of trustees has not expressed intent to discontinue the Plan, they may do so at any time subject to the provisions of ERISA and the terms of the CBA. In the event of termination of the Plan, the assets of the Plan would continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the trustees so determine, until no assets remain.

Note 8. Party in Interest and Related Party Transactions

The Plan is related to the Pension Fund by a common Board of Trustees and by the sharing of employees and office space. Pursuant allocation studies of utilization of time spent by employees and office space measurement, the Plan shares facilities, equipment and personnel with the Pension Fund in an effort to reduce operating costs. The Plan pays most administrative expenses and allocates a portion of these expenses to the Pension Fund. Specifically identified expenses incurred are charged directly to the Plan.

Amounts charged and allocated from the Plan to the Pension Fund as of December 31, 2024 and 2023 were \$502,237 and \$519,673, respectively. As of December 31, 2024 and 2023, the Plan's due from the Pension Fund was \$199,015 and \$275,379, respectively.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The Plan maintains cash balances in bank accounts that are individually secured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. From time to time such balances may exceed FDIC limits. The Plan management believes there is no significant risk to these funds.

Contributions from three employers accounted for approximately 90% of total employer contributions collected for the year ended December 31, 2024. In the event these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as set forth in the Plan document. The Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
