# WASTE ISOLATION PILOT PLANT SAVINGS PLAN

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Waste Isolation Pilot Plant (WIPP) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and the *Summary Plan Description* for more complete information.

Effective February 4, 2023, the Plan sponsor changed from Nuclear Waste Partnership LLC (NWP) to Salado Isolation Mining Contractors LLC (SIMCO). This change is due to the Department of Energy (DOE) changing the Prime Contractor at the WIPP Site.

**General:** The Plan is a defined contribution plan generally covering all employees who (1) are in the regular service of Salado Isolation Mining Contractors, LLC (“SIMCO”), (2) are eligible to work in the United States, (3) are not covered by a collective bargaining agreement unless written agreement is made between representative and SIMCO and (4) are not currently covered by another government contract defined contribution plan. SIMCO is the Plan sponsor and Employer with respect to the Plan.

The Plan is administered by WIPP Benefits and Investment Committee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Participant accounts:** A separate account is maintained for each Plan participant. Participant accounts include voluntary contributions, Employer-match contributions, and an allocation of investment earnings based on the investment fund options held in a participant’s account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s account balances at the end of each quarter, as defined by the Plan document. The benefit to which a participant is entitled at any given time is 100 percent of their contribution, their vested portion of the Employer contributions, and any earnings (losses) attributable to these contributions.

**Participant contributions:** Participants may voluntarily make pre-tax and/or after-tax contributions in any combination. Contributions can be made in whole percentage increments up to 35 percent of their after-tax basis, pre-tax basis or a combination of both, subject to certain Internal Revenue Code (“Code”) limitations, \$23,000 and \$22,500 for 2024 and 2023, respectively. Eligible compensation, as defined by the Plan, includes wages and other payments for which the Employer is required to furnish the participant a written statement on Form W-2, exclusive of bonus and incentive payments, variable pay, fringe benefits, and certain other payments, as defined in the Plan. Participants who are 50 years of age and over may voluntarily make additional “catch-up” contributions up to \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

**Entry date:** Employees hired or rehired are automatically enrolled as participants in the Plan on the first day of the pay period that is as soon as administratively feasible following their “Automatic Enrollment Date.” A participant’s Automatic Enrollment Date is 30 days after the date on which the participant first becomes an eligible employee. Eligible employees are not automatically enrolled in the Plan if they affirmatively elect to make deferral contributions at the time and in the manner specified by the Plan administrator or elect not to participate in the Plan prior to their Automatic Enrollment Date. A participant’s Salary Reduction Contributions under the automatic enrollment feature will be 6% until either a participant elects to discontinue or change his or her automatic enrollment.

A participant may elect to have his or her pre-tax contribution election automatically increase each year, pursuant to procedures established by the Plan administrator, and subject to the Plan’s overall contribution limits. The participant may choose to cease the automatic increase at any time.

**Employer contributions:** SIMCO contributes 50% of the first 6% of a participant's annual eligible compensation contributed to the Plan.

**Investment options:** Participants may direct contributions, including the Employer-match, in one percent increments into a variety of diversified investment fund options allowed by the Plan. If a participant is automatically enrolled in the Plan and has not selected an investment to invest his or her contributions to the Plan, those contributions are invested in an investment fund, as determined by the WIPP Benefits and Investment Committee. Participants may change their selection of investments at any time.

**Vesting:** Participants are immediately vested in their contributions, including earnings thereon. Participants vest in Employer contributions over a five-year period at 20 percent per year. For full-time employees and those regularly scheduled to work more than twenty-four (24) hours per week, vesting service is earned in fractional years based on a decimal ratio of actual calendar days of service to the number of days in that year. For employees regularly scheduled to work less than 24 hours a week, one year of vesting service is earned for each Plan year that a participant is credited with at least 1,000 hours of service and fractional years are earned for calendar years in which less than 1,000 hours are worked. Upon retirement or death, participants are vested immediately.

**Payment of benefits:** When a participant separates from service prior to age 65 and the participant's vested account balance is \$1,000 or less at the time of separation, such account will be distributed in a lump sum within ninety days following the participant's separation from service date (or as soon as practicable thereafter). If a participant's vested account balance is more than \$1,000, but less than or equal to \$5,000, the participant's vested account balance will be paid directly to an eligible retirement plan selected by the Plan administrative committee unless otherwise elected by the participant. If a participant's vested account balance is greater than \$5,000, the participant may retain the account balance in the Plan until age 65. If a participant has separated from service and is age 65 or older, the Plan shall begin distribution of the participant's account, unless the participant elects to retain their account in the Plan. Former participants may receive their account balances in the form of a lump sum, installments, or as partial distributions. Active participants may apply for a withdrawal from their account if they are over age 59½ or show financial hardship. All former participants must commence receiving required minimum distributions after attainment of age 73. Upon a participant's death, the designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

**Forfeitures:** Participants who terminate employment may receive a distribution of their vested account balance. The non-vested portion of their account, if any, is forfeited and used to reduce Employer contributions. The balance of unallocated forfeitures at December 31, 2024 and 2023, was \$6,277 and \$4,233, respectively. During the years ended December 31, 2024 and 2023, Employer contributions were reduced by \$147,235 and \$202,879, respectively, from non-vested accounts.

**Notes receivable from participants:** Active participants may borrow from \$1,000 to \$50,000 from their fund accounts, not to exceed 50% of their vested balance, provided they meet the Plan's eligibility requirements. The duration of the note is not to exceed five years, except for notes used to finance the purchase of a primary residence, which is not to exceed ten years. A participant may have no more than two outstanding notes at any one time. Interest rates are fixed for the term of the note and are established based on the prime interest rate plus one percent, updated monthly. Notes receivable from participants bear an interest rate of 4.25% to 9.50% at December 31, 2024, and 2023. Principal and interest are repaid ratably through payroll deductions. Notes are secured by a promissory note from the participant and his or her vested interest in the Plan. The notes are recorded at cost plus accrued interest.

**Plan termination:** Although SIMCO has expressed no intent to do so, the Plan gives the Employer the right to discontinue its contributions or to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting:** The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

**Contributions:** Participant contributions and the related Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Valuation of investments:** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 for a description of fair value measurements under the Accounting Standards Codification ("ASC") 820).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who elected to withdraw from the Plan, but have not yet been paid was \$180,149 and \$10,000, at December 31, 2024 and 2023, respectively.

**Administrative expenses:** The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. The Plan receives a contracted amount of funds from the trustee, which may be used to pay Plan expenses. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

**Subsequent events:** The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

## 3. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination from among the investments currently being offered. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such change could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across various participant-directed investment options. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict.

#### 4. FAIR VALUE MEASUREMENTS

FASB ASC 820-10, *Fair Value Measurements* (“ASC 820-10”), which defines fair value, establishes a framework for measuring fair value under current accounting pronouncements that require or permit fair value measurement and enhances disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy under ASC 820-10 are described as follows:

Level 1	Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> <p>If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Mutual funds** – A mutual fund is an investment company registered under the Investment Company Act of 1940 that pools the capital of many investors and invests it in stocks, bonds, short-term money market instruments and/or other securities. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. These investments are classified within Level 1 of the valuation hierarchy.

**Common trust funds** – A common trust fund is a fund for the collective investment and reinvestment of assets contributed from employee benefit plans maintained by more than one plan. These investments are valued using the NAV provided by the administrator of the common trust fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. The common trust funds are not classified within the fair value hierarchy; however, the amounts measured using NAV is disclosed to permit reconciliation of the fair value of investments to the Statements of Net Assets Available for Benefits.

## 5. TAX STATUS

The Internal Revenue Service (the “IRS”) has informed the Plan by a letter dated December 1, 2015, that the Plan, as amended through May 2015, was designed in accordance with applicable regulations of the Code. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan continues to be qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

## 6. INFORMATION CERTIFIED BY PLAN TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by SIMCO and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the Trustee of the Plan).

## 7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of investments managed by the Trustee or the Plan’s investment advisor, Mercer; therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These party-in-interest transactions qualify for prohibited transaction exemptions under ERISA.

## 8. PLAN AMENDMENT

Effective January 1, 2024, the Plan was amended and restated to include the required adoption of a top-paid group election as a member of the Bechtel National controlled group of corporations. This is used to determine a top 20% pay group for determining highly-compensated employees in alignment with other members of Bechtel’s controlled group.
