## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Atlantic Coast Mortgage, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the Atlantic Coast Mortgage, LLC (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering employees of Atlantic Coast Mortgage, LLC, who are age 21 or older. There is a one-month service requirement for employees to enter the Plan and to be eligible for employer contributions. The Plan excludes part-time, temporary, and seasonal employees who regularly work less than 1,000 hours per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for the oversight of the Plan. The Plan's Management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### Contributions

Each year, participants may elect to contribute up to 100% of their pretax annual eligible compensation, subject to an indexed maximum as allowed under the Internal Revenue Code, to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also designate all or a portion of their 401(k) deferral contributions as Roth elective deferral contributions instead of pre-tax elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible participants are auto enrolled at a deferral rate of 4% unless otherwise directed by the participant. The Plan allows for an automatic increase in elective deferrals. For those participants who have been automatically enrolled, the deferral rate will increase by 1% per year, up to a maximum of 6%, as of the beginning of each subsequent Plan year.

Employer contributions are discretionary and determined by the employer. The Company made matching contributions equal to 50% of the employee's contribution up to a maximum of 6% of eligible compensation that a participant contributed to the Plan.

Participants direct the investment of their elective deferrals and employer contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

## **Notes to Financial Statements**

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching contribution, if any, and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Forfeited Accounts**

Forfeitures of non-vested Company discretionary contributions are used to reduce employer contributions and administrative expenses. There was \$68,128 and \$20,184 of forfeited nonvested accounts as of December 31, 2024 and 2023, respectively. For the year ending December 31, 2024, \$62,226 of forfeited nonvested accounts were used to pay administrative expenses.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of continuous service. A participant is 20 percent vested after one year of credited service, vesting increases 20 percent per year thereafter. A participant is 100 percent vested after five years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the amount of the participant's highest outstanding loan balance during the previous 1-year period. Loan terms range from one to five years. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

On termination of service, if a vested balance in excess of \$5,000 exists at the date of termination, a participant may elect to receive a lump sum amount equal to or a portion of the value of his or her account. A participant whose vested balance never exceeded \$5,000 will be paid out in a lump sum after termination occurs.

## **Note 2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

## **Notes to Financial Statements**

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the loan is deemed to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims filed by terminated employees that had not yet been paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

## Notes to Financial Statements

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuations technique may require the transfer of financial instrument from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

### Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### Note 5. Information Certified by Mid Atlantic Trust Company

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of the investments, interest, and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the custodian and trustee of the Plan.

## Notes to Financial Statements

### Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved defined contribution plan for its original plan documents and amendments. The non-standardized pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service dated November 30, 2020, as to the plan's qualified status. The non-standardized pre-approved defined contribution plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter; the Plan administrator and the Plan's tax counsel believe that the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirement of the Internal Revenue Code.

In accordance with accounting principles generally accepted in United States of America, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Mid Atlantic Trust Company ("Mid Atlantic"). Mid Atlantic acted as the custodian and trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Mid Atlantic provides certain administrative services to the Plan pursuant to an agreement between the Company and Mid Atlantic. Mid Atlantic receives revenue from mutual fund service providers for services Mid Atlantic provides to the funds. This revenue is used to offset certain amounts owed to Mid Atlantic for its administrative services to the Plan.

If the payments received by Mid Atlantic from such mutual funds service providers exceed the amount owed under the agreement, Mid Atlantic remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was \$6,412 deposited into the Plan. The Plan or Plan Sponsor may make payment to Mid Atlantic for administrative expenses not covered by revenue sharing.

Sentinel Benefits Group, LLC (recordkeeper), Lion Street Advisors, LLC (investment advisors), and Yount, Hyde & Barbour, P.C. (Plan auditors) are service providers to the Plan, and, therefore, transactions with these parties qualify as party-in-interest transactions.

## Notes to Financial Statements

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 9. Failure to Timely Remit Participant Contributions**

During the years ended December 31, 2023 and 2022, the Company failed to remit certain participant contributions to the Plan totaling \$54,075 and \$162,794, respectively, within the time period prescribed by the Department of Labor regulations. During the year ended December 31, 2024, the Company corrected these violations by restoring lost earnings to participants.

### **Note 10. Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued.
