NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the 24 Seven, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the following companies (collectively, the "Company"):

- 24 Seven, LLC, (the "Plan sponsor")
- 24 Seven Staffing, LLC
- 24 Seven Talent of California, LLC
- 24 Seven Recruiting, LLC
- Sage Consulting Associates, LLC ("Sage")
- Simplicity Consulting, LLC ("Simplicity")
- 24 Seven Minnesota, LLC ("Minnesota")
- Filter, LLC ("Filter")
- McKinley Marketing Partners, LLC ("McKinley")
- The Cydio Group ("Cydio")
- SketchDeck, LLC ("SketchDeck")

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by the Company. Voya Retirement Insurance and Annuity Company ("Voya") is the custodian and provides record-keeping services for the Plan. From the period January 1, 2023 to November 15, 2023, Reliance Trust Company ("RTC") served as the custodian of certain Plan assets for the Simplicity participants and Transamerica Retirement Solutions, LLC ("TRS") served as the recordkeeper. During November 2023, Plan assets totaling approximately \$8,624,000 were transferred from RTC to Voya.

During 2024, the Plan Sponsor acquired Filter, McKinley, Cydio and SketchDeck, who became participating employers in the Plan effective July 1, 2024, December 2, 2024, December 9, 2024, and December 16, 2024, respectively. Effective December 27, 2024, McKinley terminated participation in the Plan.

Employees who have completed 500 hours of service within the first six months and are age 21 or older are eligible to participate in the Plan. Participants may enter the Plan each January 1 and July 1 after meeting the eligibility requirements.

Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may contribute up to 100% of after-tax compensation, as defined by the Plan. In no event may a participant's pre-tax and after-tax contributions ("Elective Deferrals") exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

1. DESCRIPTION OF THE PLAN (Continued)

Contributions (Continued)

The Company makes safe harbor matching contributions to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's Elective Deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's Elective Deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

Participant Accounts

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options any time. Each participant's account is credited with his or her contributions, Company matching contributions and actual earnings and losses thereon. Participant accounts may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, safe harbor contributions, plus actual earnings thereon.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lumpsum distribution or leave all or part of his or her vested account in the Plan and defer receipt of his or her benefits, unless the account balance does not exceed \$7,000. If the account balance does not exceed \$7,000, the entire vested balance will be paid to the participant in a single lump-sum distribution as soon as practical without regard to the consent of the participant.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59½. Participants may also withdraw any of their rollover contribution balance at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from elective deferral accounts. All hardship withdrawals must comply with specific rules relating to hardships, which are uniformly applicable to all participants.

1. DESCRIPTION OF THE PLAN (Continued)

Forfeitures

Forfeitures relate to an overpayment from a prior year. Forfeited nonvested accounts may be used to reduce future Company contributions or pay Plan expenses. For the years ended December 31, 2024 and 2023, there were no forfeitures used to reduce Company contributions or pay Plan expenses. Forfeited nonvested accounts available as of December 31, 2024 and 2023 were \$70,176 and \$62,922, respectively.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investments and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Benefit Payments

Benefit payments are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

The following information was certified as complete and accurate by Voya for the years ended December 31, 2023 and 2024. RTC certified certain activity for the period January 1, 2023 to November 15, 2023 as complete and accurate until the assets were transferred to Voya during the year ended December 31, 2023.

4. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

Pooled separate accounts: valued at fair value using the NAV per share practical expedient. The pooled separate accounts are valued using Accumulation Unit Value (AUV). AUV represents the underlying fund's daily performance, plus any applicable dividend income, less the daily separate account charge. The investment strategies of the pooled separate account funds are to invest in underlying funds with the goal of producing favorable long-term returns and growth, depending on the overall fund objectives. There are no restrictions on redemption of the pooled separate accounts. There are no unfunded commitments.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan entered into a fully benefit-responsive guaranteed investment contract with Voya. The Plan's total interest in this contract was \$1,108,635 and \$803,275 as of December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by FIS BUSINESS SYSTEMS LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PARTY-IN-INTEREST TRANSACTIONS

RTC served as the custodian of certain Plan investment assets for the period January 1, 2023 to November 15, 2023. Voya served as the custodian of the Plan's investment assets for the period January 1, 2023 to December 31, 2024. As such, transactions between the custodians qualify as party-in-interest transactions. Additionally, Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain classifications may differ between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the year ended December 31, 2023.

10. TRANSFER FROM RELATED PLAN

During 2024, the Plan sponsor merged The Cydio Group 401(k) Plan into the Plan as a result of the new participating employers described in Note 1. The assets transferred into the Plan during 2024 totaled \$3,392,147, which is reported as transfers from related plan in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Assets related to the plans associated with Filter and SketchDeck were not transferred into the Plan as of December 31, 2024.

11. PLAN AMENDMENTS

The Plan was amended to waive eligibility requirements for the participants who merged into the Plan on July 1, 2024 from Filter and December 16, 2024 from McKinley, Cydio, and SketchDeck.

13. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

In February 2025, additional assets totaling \$3,523,099, related to the new participating employers described in Note 1, were transferred into the Plan.
