Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024.

No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

Included in the notes to the financial statements is the methodology used by management to determine plan estimates. We evaluated the key factors and assumptions used to develop plan estimates and determined that they are reasonable in relation to the basic financial statements taken as a whole.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements are:

- Fair Value Measurements disclosure note, which describes the valuation methodologies used to estimate the fair value of investments, income recognition, and risks and uncertainties.
- Prohibited Transactions disclosure note, which describes untimely remittances of participant contributions to the Plan.

Significant Unusual Transactions

We did not identify any significant unusual transactions.

Audit Adjustments and Uncorrected Misstatements

For purposes of this communication, professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. We are not aware of any uncorrected misstatements other than misstatements that are clearly trivial.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedure, as applicable. There were no material, corrected financial statement misstatements identified by us. As an accounting service, we assisted your personnel who recorded the Plan's accrual basis adjustments at December 31, 2024, including adjustments to the employee and employer contributions receivable.

Form 5500 Filing

GAAS requires that we obtain and read a draft of the Plan's Form 5500 that is substantially complete prior to the dating of our auditors' report in order to identify material inconsistencies, if any, with the Plan's audited financial statements. We read the Plan's draft Form 5500 filing for consistency with information in the financial statements. We did not identify material inconsistencies with the audited financial statements.

ERISA-Required Supplemental Schedules

We subjected the information included in the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or the financial statements themselves, and other additional procedures in accordance with GAAS. The objective of these audit procedures was to determine whether the ERISA-required supplemental schedules, other than the certified investment information, is fairly stated in all material respects in relation to the financial statements as a whole, whether the form and content of the ERISA-required supplemental schedules are presented in conformity with the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, and whether the certified investment information in the supplemental schedules agrees to, or is derived from, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). We will include an other-matter paragraph in our auditor's report for the ERISA-required supplemental schedules. We did not identify any inconsistencies with the audited financial statements or with the certified investment information.

Shared Responsibilities: AICPA Independence

The American Institute of Certified Public Accountants (AICPA) regularly emphasizes that auditor independence is a joint responsibility and is managed most effectively when management, audit committees (or their equivalents), and audit firms work together in considering compliance with AICPA independence rules. For Miller, Cooper & Co., Ltd. to fulfill its professional responsibility to maintain and monitor independence, management, the Plan Administrator, and Miller, Cooper & Co., Ltd. each play an important role.

Our Responsibilities

- AICPA rules require independence both of mind and in appearance when providing audit and other attestation services. Miller, Cooper & Co., Ltd. is to ensure that the AICPA's General Requirements for performing non-attest services are adhered to and included in all letters of engagement.
- Maintain a system of quality management over compliance with independence rules and firm policies.

The Plan Sponsor's Responsibilities

- Timely inform Miller, Cooper & Co., Ltd. before the effective date of transactions or other business changes, of the following:
 - o New affiliates, directors, or officers.
 - o New beneficial owners of the Plan Sponsor's stock which have significant influence.
 - o Change in corporate structure impacting affiliates such as add-on acquisitions or exits.
- Provide necessary affiliate information such as new or updated investment structure charts, as well as financial information required to perform materiality calculations needed for making affiliate determinations.

Shared Responsibilities: AICPA Independence (Continued)

The Plan Sponsor's Responsibilities (Continued)

- Understand and conclude on the permissibility, prior to the Plan and its affiliates, officers, directors, or persons in a decision-making capacity, engaging in business relationships with Miller, Cooper & Co., Ltd.
- Not entering into relationships resulting in close family members of Miller, Cooper & Co., Ltd. covered persons, temporarily or permanently acting as an officer, director, or person in an accounting or financial reporting oversight role at the Plan or Plan Sponsor.

Management Representations

We have requested certain written representations from management, which are included in a letter dated October 14, 2025.

Internal Control Matters

Except as discussed in the Our Responsibility in Relation to the Financial Statement Audit section of this letter, in planning and performing our audit of the financial statements of the Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered relevant plan provisions and the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the Plan's compliance with plan provisions or on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of relevant plan provisions and internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all instances that the Plan is not operating in accordance with the Plan's provisions or deficiencies in internal control that might be material weaknesses or significant deficiencies. Therefore, instances that the Plan is not operating in accordance with plan provisions or deficiencies in internal control, including material weaknesses or significant deficiencies, may exist that were not identified.

Instances where the Plan is not operating in accordance with plan provisions may be indicative of a deficiency in internal control. A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing, or (b) an existing control is not properly designed so that, even if the control operates as designed, the control objective would not be met. A deficiency in operation exists when a properly designed control does not operate as designed or when the person performing the control does not possess the necessary authority or competence to perform the control effectively.

A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Internal Control Matters (Continued)

We identified the following significant deficiencies in the Plan's internal control, which are also considered to be reportable findings:

Untimely Remittance of Employee Deferrals

Based on the Plan's internally imposed deadline of seven business days, we noted five instances during the period from January 1, 2022 to December 31, 2022 where the Plan Sponsor remitted employee contributions to the third party administrator timely; however, the employee contributions were not remitted to the Plan's trustee timely and were self-corrected outside of Voluntary Fiduciary Corrections Program ("VFCP") during October 2024. These contributions totaled \$113,741 during 2022.

The DOL continues to focus on the timeliness of remittances of employee contributions in contributory employee benefit plans. Employee contributions are required to be deposited into the Plan as soon as they can reasonably be segregated from an employer's general assets. This means that 401(k) withholdings from each payroll need to be deposited within days after each withholding occurs, similar to the timing for payroll tax deposits. At this time, the DOL has not formally announced the number of days in which the reasonable segregation from employer assets may occur.

Failure to remit or untimely remittance of employee deferral contributions may constitute a prohibited transaction (either a use of plan assets for the benefit of the employer or a prohibited extension of credit). As a Plan Sponsor, you are required to disclose on the Form 5500 whether you deposited the employee deferral contributions in a timely manner. In addition, you may be required to pay an excise tax to the IRS for failing to remit these contributions in a timely manner.

Plan Entry Dates

During the audit, we noted there are insufficient controls in place related to participant eligibility dates and entry dates as defined by plan provisions. We noted that certain employees did not contribute to the Plan within an administratively reasonable period of time relative to their calculated entry date. We discussed with Plan management and they agreed. We recommend Plan management implement policies and procedures to ensure accurate participant demographic data is tracked to determine proper eligibility date and entry date based on plan provisions. We also recommend that Plan management complete a historical review of plan entry dates and initial contributions by employees to ensure no other early entry dates are found that would require correction.

Internal Control Matters (Continued)

We identified the following deficiency in the Plan's internal control that we determined did not constitute a significant deficiency or a material weakness.

Mandatory Distributions

During our audit, we found that there is no procedural control in place to ensure that mandatory distributions are processed following severance of employment for participants with account balances of \$5,000 or less, pursuant to Plan provisions. We noted participant accounts exist at audit year end that belong to terminated employees and do not exceed \$5,000. We recommend Plan management consult with its service provider to develop a procedure to periodically (at least annually) review the accounts of terminated employees and process mandatory distributions pursuant to Plan provisions. If mandatory distributions cannot be made due to missing participants, plan fiduciary must be able to demonstrate compliance with DOL's missing participants guidance (<https://www.dol.gov/agencies/ebsa/employers-and-advisers/plan-administration-and-compliance/retirement/missing-participants-guidance>) regarding efforts made in locating missing participants or the selection of a distribution option for the benefit of missing participants.

Observations and Recommendations

This letter also includes comments and suggestions with respect to matters that came to our attention in connection with our audit of the financial statements. These items are offered as constructive suggestions to be considered as part of the ongoing process of modifying and improving the Plan's practices and procedures.

Meeting Minutes

There are no formal minutes maintained for actions taken by the Plan Sponsor. With the complexity of investment alternatives, the complexity of the tax laws covering the qualifications of the Plan, and fiduciary responsibilities of the Plan Sponsor, it is important that the Plan Sponsor adequately document the due diligence exercised over operations of the Plan, including selection of an investment policy and investment alternatives to offer participants who defer their earnings into the Plan's investments, monitoring investment performance against the Plan's objectives and formal annual decisions on all discretionary Plan Sponsor contributions.

Technology and Data Security Risk Assessment and Management

Technology continues to transform business. However, technology is not only changing business, it is changing who and what has access, custody and control over information. As technology advances, it becomes increasingly important to take ownership and maintain accountability over securing sensitive data and information. Further, the DOL has made cybersecurity a priority for Plan Sponsors over the past year and has published guidelines and considerations on their website. Therefore, employee benefit plans need to evolve in the ways that they manage technology and data security. While there is no way to prevent all data breaches, phishing scams or other risks, Plan management can mitigate the Plan's risks with a thorough understanding of cyber-security, data security, privacy, and protection of its information technology. We recommend Plan management consider developing or enhancing its data security risk management plan.

Observations and Recommendations (Continued)

Technology and Data Security Risk Assessment and Management (Continued)

In developing or enhancing the plan, Plan management may want to consider the following (which is not an exhaustive list):

- Risk assessment
- A written policy
- Careful screening and vetting of third party service providers and their security systems
- Management access to systems
- Effective authentication
- Insurance and cyber-insurance
- Red flags
- Education and training of employees and participants on the available cybersecurity features
- Plan for responding to a breach notification
- Properly backing up data
- Encryption of private information
- Separation of work and personal cyber activities
- Carefully integrating new technologies
- Continued IT system updates and upgrades
- Review of DOL guidelines, considerations, and recommendations

We have performed audits of the financial statements of Freeman's - Hindman 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of Freeman's - Hindman 401(k) Plan, formerly known as the Hindman LLC 401(k) Plan (Note 6) (the Plan) provides only general information. Interested parties should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by International Auction Group Inc., (the Plan Sponsor and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and the adopting participating employers, Hindman, LLC and Samuel T. Freeman and Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company and any participating affiliates are subject to the following eligibility requirements:

- Age: 21
- Service: 1 month
- Status Exclusions:
 - a. Non-resident aliens
 - b. Residents of Puerto Rico
 - c. Interns
 - d. Temporary and seasonal employees

Upon satisfying the eligibility requirements, employees may immediately participate in the Plan and receive discretionary employer matching contributions. Participants are eligible to receive discretionary profit sharing contributions upon satisfying the eligibility requirements and if they are employed as of the last day of the Plan year.

Contributions

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or “rollover” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Contributions (Continued)

The following contribution types are allowed by the Plan:

- Roth deferrals
- Elective deferrals
- Discretionary employer matching
- Discretionary employer profit sharing
- Rollover contributions

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The Plan has an automatic enrollment provision (4% salary deferral) whereby employees must elect out of the Plan if they do not wish to participate.

The Company may make discretionary matching and profit sharing contributions, which will be allocated in accordance with the Plan document provisions. The Company accrued discretionary employer matching contributions of \$193,745 to the Plan for the year ended December 31, 2024. The Company made no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for Company discretionary matching and profit sharing contributions is based on vesting periods of service. Participants are always 100% vested in their Company discretionary matching and profit sharing contributions if they are employed on or after their Normal Retirement Age or if they terminate employment on account of their death or disability.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used as follows:

- Pay administrative expenses
- Reduce Company contributions

At December 31, 2024 and 2023, there were an insignificant amount of unallocated plan assets resulting from forfeited nonvested accounts. Forfeitures of \$17,223 were used to pay administrative expenses related to the Plan year ended December 31, 2024. No forfeitures were used to reduce discretionary Company contributions related to the Plan year ended December 31, 2024.

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 70½ or 72 if the participant is not 70½ prior to January 1, 2020, or (ii) the year in which the participant retires.

Benefits Paid to Participants (Continued)

The following types of distributions are also allowed by the Plan:

- Termination partial withdrawal
- Hardship
- In service (starting at age 59 ½)
- Involuntary cash-outs
- Rollover source withdrawal at any time

Plan Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Plan recognizes employee and employer matching contributions in the period in which the related employee contribution is withheld.

Note 2 – Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statements of net assets available for benefits date that require disclosure in the financial statements.

Note 3 – Certified Investments

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution (the trustee of the Plan).

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund

A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value, this practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Common Collective Trust Funds

Common collective trust funds are valued at the NAV of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant or plan redemption restrictions for these investments.

Note 5 – Related Party and Party-in-Interest Transactions

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under Department of Labor (DOL) regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$36,090 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan. These transactions qualify as party-in-interest.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Note 6 – Plan Amendment and Restatement

Effective April 15, 2024, the Plan was amended and restated to change the Plan Sponsor to International Auction Group Inc. and add Samuel T. Freeman and Company as a participating employer in the Plan. The Plan was also formally renamed to Freeman's - Hindman 401(k) Plan as part of this amendment and restatement.

Other significant provisions of the Plan remain unchanged as a result of the amendment and restatement. Interested parties should refer to the Plan document for a complete description of the Plan's provisions.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Tax Status

The Plan sponsor adopted a plan which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service (IRS) dated October 6, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Note 8 – Tax Status (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

Note 9 – Prohibited Transactions

The Plan Sponsor remitted certain participant contributions timely to the third party administrator; however, the third party administrator failed to deposit participant contributions within the required time frame as stated by the DOL for the period from January 1, 2022 to December 31, 2022. The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplemental schedule information. The Plan Sponsor self-corrected these deficiencies outside of the Voluntary Fiduciary Corrections Program (VFCP) during 2024.
