Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The following description of the Diesel Laptops 401(k) Plan (the “Plan”) provides only general information. Participants may refer to the Plan’s documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Diesel Laptops, LLC (the “Company”). Employees are eligible to make employee elective deferrals immediately upon hire with the Company. Prior to September 29, 2023, employees were eligible to receive employer contributions upon completion of one year of service with the Company, defined as at least 1,000 hours of service during a calendar year. From September 29, 2023 through May 10, 2024, employees were eligible to receive employer contributions upon completion of three months of service with the Company. Effective May 10, 2024, participants are eligible to receive employer contributions upon Plan entry. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows contributions of any portion of a participant’s pre-tax compensation, subject to contribution limitations specified by law. The Plan has an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation, and an annual 1% deferral rate increase thereafter until a deferral rate of 6% is reached. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Company is required to make safe harbor matching contributions equal to 100% of the amount of a participant’s elective deferrals that are not in excess of 1% of the participant’s compensation, plus 50% of the amount of a participant’s elective deferrals that exceed 1% but are not in excess of 6% of the participant’s compensation each plan year. The Company also has the option to make discretionary matching and nonelective contributions to participants. No discretionary matching or nonelective contributions were made by the Company during the years ended December 31, 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer safe harbor matching contributions, discretionary matching or nonelective contributions (if any), allocations of earnings and losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct their contributions into various investment options offered by the Plan. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Effective September 29, 2023, the Plan allows employees to request loans, subject to certain limitations. Participants may borrow from their accounts to the extent that the participant's total loan balance does not exceed the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of Plan loans during a one-year period ending on the day before the loan is made over the outstanding balance of Plan loans on the date the loan is made, or 50% of their vested account balance. Loan terms are not to exceed five years, unless used for the purchase of a primary residence, in which case loan terms are not to exceed ten years. Loans are collateralized by the remaining balance in the participant's account. Interest rates on notes receivable from participants, set by Plan management, follow the prime rate plus 1% at the date of origination. At December 31, 2024 and 2023, notes receivable from participants bear interest at rates ranging from 9.0% to 9.5%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their salary deferrals and safe harbor matching contributions. Upon reaching retirement age, as defined in the Plan documents, permanent total disability, or death while employed, participants are immediately vested in all employer matching contributions, plus actual earnings or losses thereon. Vesting in the remainder of their account balance is based on years of continuous service. Participants are vested in the Company's matching contributions based on a two year cliff vesting schedule (0% vested if participant has less than two years of service, 100% vested after two years of service). Participants are 20% vested in the Company's discretionary matching and nonelective contributions at the end of two years of service, with additional vesting of 20% for each of the next three years, and are 100% vested after six years of service.

Payment of Benefits

Upon retirement, permanent total disability, death, or termination of employment, participants or their beneficiaries may elect to receive their vested portion of Plan assets under several payout options specified in the Plan's documents. Effective September 29, 2023, participants may receive hardship withdrawals from their accounts while employed, subject to certain conditions. Participants who have attained fifty-nine and a half years of age are permitted to withdraw all or part of their vested accounts as in-service distributions.

Forfeitures

Participants withdrawing from the Plan with non-vested balances in their account forfeit their share of such balances and earnings thereon. The Plan's provisions allow these amounts to be used for administrative expenses of the Plan or to reduce any employer contributions. During the years ended December 31, 2024 and 2023, \$0 and approximately \$8,000, respectively, in forfeited non-vested accounts were used to reduce administrative expenses. Unallocated forfeited non-vested accounts totaled approximately \$24,000 and \$400 at December 31, 2024 and 2023, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the accompanying financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in all employer contributions.

2. Basis of Presentation and Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for plan benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Upon termination of an applicable participant, delinquent participant loans outstanding are classified as distributions.

Payment of Benefits

Benefit payments are recorded when paid.

3. Trustee Certifications

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 related to investments, notes receivable from participants, net appreciation in fair values of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The methods used to measure fair values of the Plan's investments may produce amounts that may not be indicative of net realizable value or may not be reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's mutual fund investments and money market fund were valued using Level 1 inputs, based on quoted market prices.

The Plan's investments also include collective trusts, whereby the underlying investments primarily consist of guaranteed interest contracts. The collective trusts are valued at the net asset value ("NAV") of units of the collective trust. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the collective trusts' liabilities. This practical expedient is not used when it is determined to be probable that the collective trusts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the account provider reserves the right to temporarily delay withdrawal from the collective trusts in order to ensure that security liquidations will be carried out in an orderly business manner.

5. Income Tax Status

The Plan is a non-standardized profit sharing plan, provided by the trustee, designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") determined that the non-standardized plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

During both 2024 and 2023, management discovered certain errors relating to contributions that resulted in an underpayment of employer contributions to the Plan. Management is taking the necessary corrective actions to ensure that these errors have no impact on the Plan's tax status and to ensure that the impacted participants are made whole.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress.

6. Party-in-Interest Transactions

Certain Plan investments were managed by the Plan's trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for trustee, custodial, recordkeeping, and investment advisory services amounted to approximately \$28,000, annually, for the years ended December 31, 2024 and 2023. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

7. Subsequent Events

Management evaluated events and transactions after December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued, for subsequent events.

Effective January 1, 2025, the Plan was amended to change the calculation of safe harbor matching contributions to 100% of the amount of a participant's elective deferrals up to 4% of eligible plan compensation each plan year.

There were no other subsequent events to report.
