Note 1 - Plan Description

The following description of Corium, LLC 401(k) Plan (the "Plan") provides only general information. The Plan is a single-employer plan. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 1977 and is a defined contribution plan covering all eligible employees of Corium, LLC and Corium Pharma Solutions (collectively, the "Company") who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make maximum matching contributions to the Plan of up to 25 percent of the participant deferrals up to 6 percent of participants' compensation. At the beginning of 2024, the Plan changed the matching contributions to a safe harbor match equal to 100 percent of the first 4 percent of compensation that is contributed to the Plan. The Company may also make an additional discretionary contribution in amounts approved by the board of directors. For the year ended December 31, 2024, the Company did not make any additional discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings. Allocations are based on participants' contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan. Specific fees may be charged to a participant's account for certain requested services.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover, and safe harbor matching contributions and any income or loss thereon.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. The Plan also allows withdrawals of certain moneys upon the attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used equally between each participating employer to reduce future company contributions or to pay administrative expenses of the Plan.

Note 1 - Plan Description (Continued)

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Participant Notes Receivable

The Plan allows participants to borrow money from the Plan up to the lesser of \$50,000 less the highest outstanding participant note receivable balance over the prior 12 months or one-half of the participant's vested account balance. Participant notes receivable must have a term of no longer than 5 years, with the exception of participant notes receivable used to acquire, construct, or reconstruct the participant's residence, which may have a term of 10 years and must bear a reasonable interest rate.

Party-in-interest Transactions

Fees incurred for accounting and other services rendered by parties in interest have been based on customary and reasonable rates for such services. Fees not paid for by the use of forfeitures were paid by the Company.
