Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Avantik 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) Description of Plan

The following description of the Avantik 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Belair Instrument Company, LLC dba Avantik (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees are responsible for oversight of the Plan. The plan trustee also determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All of the Company's employees, except nonresident aliens, leased employees, and employees subject to a collective bargaining agreement, who have completed three months of service and attained an age of twenty-one. New participants may enroll on the first day of the month upon meeting the eligibility requirements.

Contributions

Each year, participants may make elective salary deferral contributions as a percentage of annual compensation (pre-tax and Roth), as defined in the Plan, and subject to the maximum amount allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may roll over amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan with a 3% pre-tax deferral rate unless they affirmatively elect not to participate in the Plan. Participants direct their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution to the Plan. Matching contributions are determined annually. During 2024, the Company approved a discretionary matching contribution equal to 35% of a participant's elective deferral up to 3% of the participant's compensation. In order to receive employer match contributions, participants must complete 1,000 hours of service and be employed at the end of the year unless employment ends due to retirement, death, or disability. The Company may also make qualified non-elective contributions. Discretionary matching contributions totaled \$295,747 for the 2024 plan year, to be paid in 2025.

Participant Accounts

Each participant's account is credited with the participant's elective deferral, the Company's matching contributions as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Plan's employer matching contributions and non-elective contributions portion of their accounts plus earnings thereon is determined as follows:

Notes Receivable from Participants

Loans are available to participants subject to plan administrator approval. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The notes are secured by the balance in the participants' accounts and bear interest at rates ranging from 8.75% to 9.50% as of December 31, 2024. The loan interest rate is set at 1% above the prime rate, as defined, which remains fixed through the term of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service a participant with an account balance in excess of \$5,000 may elect to receive a lump-sum amount equal to the vested value of his or her accounts. A terminated participant with an account balance less than \$5,000, which excludes the participant's rollover balance, will receive a lump-sum payment of the balance through either a rollover contribution or direct cash out, depending on the value of the account. Benefits payable upon retirement, death, disability, or termination. The Plan allows for in-service distributions if a participant reaches 59 ½ and hardship distributions. Hardship distributions are limited to the employee portion of their account. The plan also allows participants to withdrawal amounts representing rollover contributions.

Forfeited Accounts

Forfeiture of non-vested account balances of former participants remain with the Plan and are used to reduce the Plan's contributions for the plan year following the year in which the forfeiture occurs and, to the extent they are not used, to pay administrative expenses other payable by the employer. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,444 and \$1,579, respectively. There were no forfeitures were used to reduce employer contributions nor administrative expenses during 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment Valuation and Income Recognition, Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If the participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default based upon the terms of the Plan Document, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant transaction fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

(3) Group Annuity Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with Transamerica Financial Life Insurance Company Inc. (Transamerica). Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annual basis for resetting. The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

(4) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at fair value, investments held at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica, a qualified institution.

(5) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

quoted prices for similar assets or liabilities in active markets;

quoted prices for identical or similar assets or liabilities in inactive markets;

inputs other than quoted prices that are observable for the assets or liability;

observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(5) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The Plan's accounts provide a cumulative record of the number of units credited to the account and the number of units allocated or withdrawn from the account. The balance of the Plan's units multiplied by the unit value equals the Plan's pooled separate account balance. The unit value is based upon the quoted market values of the underlying assets in the account. Participant transactions (purchases and sales) may occur daily.

(6) Related Party and Party-In-Interest Transactions

Certain plan investments are managed by Transamerica. Transamerica is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of investments. Fees paid by the Plan for the participant initiated transactions and recordkeeping services amounted to \$33,882 for the year ended December 31, 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(8) Income Tax Status

The Plan uses a non-standardized, pre-approved plan document sponsored by TAG Resources LLC. TAG Resources LLC received a letter from the Internal Revenue Service (IRS) dated August 17, 2021, which states the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment instruments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such a change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
