INDEPENDENT AUDITORS' REPORT

To the Participants, Administrator and Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Hospital Damas, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of plan

The following brief description of the Hospital Damas, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Hospital Damas, Inc. (the Company), who have completed six (6) months of service and have reached their twenty-one (21) birthday. The Plan became effective on January 1, 1999 and has been subsequently amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute an amount of their compensation, as defined in the Plan, not exceeding the maximum deferred amount specified by local law. Participants may also contribute amounts representing distributions from other qualified plans.

The amount of the Company's contributions allocated to each participant is based upon 10 cents of every dollar up a maximum of 6% of the participant basic compensation. Also, the Company will only contribute amounts to participant employees.

The Company may make a discretionary contribution, which is not limited to its current or accumulated net profit. Contributions are subject to certain limits.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of plan – (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service. Before reaching the three years of service, the participant has no vested interest in the Company's matching and discretionary contributions plus actual earnings.

Participants shall be 100 percent vested, without regards to the aforementioned limitations, after becoming eligible for normal retirement, early retirement, incurring a disability prior to termination, death or plan termination.

Investment options

Upon enrollment in the Plan, a participant may direct employee contributions in any of various investment options offered by the Plan, which at December 31, 2024 and 2023 are participant-directed investments.

Loans to participants

Loans to participants are not permitted.

Payment of benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeited accounts

At December 31, 2024 and 2023, forfeited accounts totaled \$2,775 and \$2,736, respectively. These accounts shall be used to pay accrued administrative expenses, and any remaining part, to reduce the Company's matching contributions, or within the Company's discretion, distributed proportionally among the remaining active participants based in the ratio that each participant's matching contribution account bears to the total matching contribution account balances for all of the participants. During the year ended December 31, 2023, \$10,001 from the forfeited account were distributed proportionally, as Company's matching contributions, among the remaining active participants. No distributions from the forfeited account were made during the year ended December 31, 2024.

Plan expenses and administration

The Company is responsible for the general administration of the Plan and for carrying out the provisions thereof. The Company's contributions are held and managed by the Custodian, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts and benefits will be payable strictly under the terms of the Plan.

Declared disaster contributions

Upon a written determination by the Puerto Rico Secretary of the Treasury by regulation, administrative determination, circular letter or informative bulletin of general application after a declaration of disaster by the Governor of Puerto Rico, as defined in Section 1031.01(b)(16)(C) of the Puerto Rico Internal Revenue Code (Puerto Rico Code), the Plan administrator shall review the Governmental Disaster Guidance and communicate to participants if declared disaster distributions will be available from the Plan and the conditions and limitations applicable to such distributions.

Plan amendment

Effective February 22, 2024, a new Plan Adoption Agreement was signed to include automatic enrollment for new participants who enrolled effective January 1, 2024. In addition, in-service withdrawals from pre-tax contributions and catch-up contributions will now be allowed for any reason after age 59 ½ while distributions from after-tax contributions and rollover contributions will be allowed for any reason.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investments valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Benefits payable

The Plan accounts for benefits payable in accordance with guidance provided by the American Institute of Certified Public Accountants, Audit and Accounting Guide, Audits of Employee Benefit Plans. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024 and 2023, there are nil and \$3,666 benefits payable owed to participants who have elected to withdraw from the Plan but have not yet been paid.

Note 3 - Information certified by the plan's Custodian (Unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian of the Plan, Empower Trust Company, LLC, (the Custodian), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements of as December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024. The Custodian maintains all records, executes investment transactions, and holds all the assets of the Plan. In addition, the Custodian, upon authorization from the plan administrator, distributes benefit payments to the participants.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$383,017.

Note 4 - Party-in-interest transactions

Certain Plan's investments are fixed annuities managed by the Custodian. Therefore, these transactions qualify as party-in-interest.

Note 5 - Company contributions

The Company contributions may be paid in lump-sum or installments, but the total amount should be paid to the Custodian no later than the earlier of, the time (including extensions thereof) prescribed by law for filing the Employer's Puerto Rico income tax return for its taxable year ending with or, within the plan year.

Note 6 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) *Topic of Fair Value Measurement* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the above-mentioned standard are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at the year end.

Fixed annuities: Values are reported daily and are based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 - Delinquent participant contributions

During the years ended December 31, 2024 and 2023, participants' contributions were remitted to the Custodian within the period prescribed by the Department of Labor's Rules and Regulations.

On February 2, 2023 participants' contributions amounting to \$15,154 corresponding to late remittances of the year ended December 31, 2019, were corrected by making the corresponding lost earnings and interests deposits amounting to \$8, which were made outside the Voluntary Fiduciary Correction Program (VFCP).

Note 8 - Non-discrimination test

During the years ended December 31, 2024 and 2023, the Plan complied with the non-discrimination test required by Section 1081.01 of the Code, as amended.

Note 9 - Tax status

The Plan is subscribed under A & A Employee Benefits Consulting Corporation Prototype Retirement Plan, which has been qualified under the appropriate sections of the Puerto Rico Internal Revenue Code (the Code). The Plan obtained its latest determination letter on September 23, 2024, in which the Puerto Rico Treasury Department stated that the Plan, as then designed and after 2024 amendments was in compliance with the applicable requirements of the Code. The Plan Administrator believes that the Plan, as currently designed and being operated, is in compliance with the applicable requirements of Section 1081.01 of the Code. Therefore, no provision for income taxes and provision for asserted and unasserted claims and assessments affecting the plan assets that might result from the loss of tax-exempt status have been included in the Plan's financial statements.

Note 10 - Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits and through the date the financial statements were available to be issued, that would require additional adjustment to, or disclosure in, the financial statements.
