NOTE A - DESCRIPTION OF THE PLAN

The following description of the Mitsui & Co. (U.S.A.), Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan covering substantially all full and part-time employees of Mitsui & Co. (U.S.A.), Inc. and certain affiliated employers that have adopted the Plan (collectively, the "Company" and "Employer"). All newly hired newly eligible employees are automatically enrolled in the Plan at a deferral rate of 5%, and annually, there will be an increase of 1% up to 15%. The Plan excludes collectively bargained employees, leased employees, employees on rotational assignments and employees who are non-resident aliens. Vanguard Fiduciary Trust Company serves as the trustee of the Plan, and Vanguard Group is the Plan's recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

[2] Contributions:

Each year, participants may contribute a percentage of their compensation up to the maximum allowed subject to certain Internal Revenue Code ("IRC") limitations. Such contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan also provides for a Roth 401(k) option to the participants. Roth contributions are included in the participant's taxable income for federal income tax purposes.

The Company contributes a safe harbor matching contribution of 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. Effective January 1, 2024, the Plan was amended to provide for an employer contribution which includes a fixed contribution of 1% and an employer discretionary contribution, not to exceed 3% in total. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. The employer matching contribution will be made on catch-up contributions and will provide for a true-up employer matching contribution.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of participant and employer contributions.

[3] Participant accounts:

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's contribution, allocation of Plan earnings, and is charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[4] Vesting:

Participants are vested immediately in their contributions and in the Company's contributions, plus actual earnings thereon. Effective April 30, 2018, the Mitsui & Co. (U.S.A.), Inc. Savings Account Plan ("Savings Account Plan") was merged into the Plan. Company matching contribution accounts of participants not employed with the Company as of May 1, 2018 that were transferred from the Savings Account Plan to this Plan are subject to a five year graded vesting schedule at 20% per year.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[5] Forfeitures:

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of approximately \$4,400 were used to reduce employer contributions. Forfeited nonvested accounts available at December 31, 2024 and 2023 were approximately \$1,200 and \$0 respectively.

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum loan amount of \$1,000 and not exceeding the lesser of 50% of the participant's vested account or \$50,000, less any outstanding loan balance. The loans are secured by an assignment of the balance in the participant's account and bear interest based on the prime rate at the date the loans are made. Principal and interest are paid ratably through payroll deductions. Loan terms shall not exceed five years, except for primary residential loans. As of December 31, 2024, participant loans have maturities through July 2042, with interest rates ranging from 3.25% to 9.50%. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

[7] Payment of benefits:

On termination of service due to death, disability or retirement, or for other reasons, a participant or the beneficiary of the participant may elect a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment distributions or a partial lump sum.

Participants are eligible to make in-service distributions upon attaining age 59½ and are also eligible to make hardship withdrawals from their deferred contribution and rollover accounts in the event of certain financial hardships.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

[4] Administrative expenses:

Administrative expenses of the Plan are paid by either the Plan or the Company as provided in the Plan document. The Company provides accounting and other administrative services to the Plan at no charge. Management fees and operating expenses charged to the Plan for investments in the registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. During the year ended December 31, 2024, certain participant related transactions, such as loan fees, distribution fees, investment advisory fees and recordkeeping fees, were charged to the related participants' accounts in the amount of \$73,526.

[5] Payment of benefits:

Benefits are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE C - FAIR VALUE MEASUREMENTS (CONTINUED)

Common/collective trust funds: Valued at the NAV of units of the trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the trust, minus its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to make a full accumulated book value withdrawal from Vanguard Retirement Savings Trust III, a 12-month notice is required. For participant level transactions relating to the Vanguard Retirement Savings Trust III, reinvesting in a competing investment is prohibited for 90 days.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and units of common collective trusts managed by an affiliate of Vanguard Fiduciary Trust Company, the Plan's trustee, and Vanguard Group, the Plan's recordkeeper. Transactions related to the Plan investments qualify as party-in-interest transactions. During the year ended December 31, 2024, certain participant related transactions, such as loan fees, distribution fees, investment advisory fees, and recordkeeping fees, were charged to the related participants' accounts in the amount of \$73,526.

NOTE E - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE F - TAX STATUS

The Plan has adopted a Nonstandardized profit sharing/401(k) Plan sponsored by The Vanguard Group. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a governmental authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, the trustee, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE I - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE J - TRANSFER IN

In September 2024, the T&E Enterprises, Inc. Profit Sharing Plan merged into the Plan.

NOTE K - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
