NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 (AUDITED) AND DECEMBER 31, 2023 (COMPILED)

1. DESCRIPTION OF PLAN

The following brief description of Campus Construction Management Group Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers substantially all employees of Campus Construction Management Group Inc. (the Company) who have completed six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are entitled to defer up to the maximum annual dollar contribution allowed by ERISA and the Internal Revenue Service of \$23,000 for the year ended December 31, 2024, into the Plan as a qualified pre-tax contribution. If a participant is age 50 or over, the ceiling was \$30,500 for the year ended December 31, 2024.

Employees are automatically enrolled to make tax-deferred contributions of 6% unless the employee opts out of the Plan.

The Company may make a discretionary matching contribution. The Company matched a tiered percentage, up to 6%, based on eligible participants' contribution percentage for the year ended December 31, 2024. Additionally, the Company has the option of making annual qualified nonelective contributions to the Plan. There were no nonelective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) plan earnings (losses), and charged with allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are limited to one outstanding at any given time. The loans are payable in their entirety upon the occurrence of a distributable event and bear interest at a rate to be determined by the loan administrator. Principal and interest is paid ratably through monthly payroll deductions. Terms of the loans shall be up to five years, unless for the purchase of principal residence, in which case the term is ten years.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of services and continues to vest in increments of 20% until 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments for a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may withdraw any part of their vested account which does not result from discretionary contributions after reaching the age of 59½. Rollover contributions may be withdrawn at any time.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to reduce administrative fees or reduce employer contributions. In 2024 and 2023, there were forfeitures of non-vested Company contributions and earnings on unused amounts totaling \$24,086 and \$41,291, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$12,893 and plan administrative expenses were reduced by \$11,193. For the year ended December 31, 2023, employer contributions were reduced by \$37,921 and plan administrative expenses were reduced by \$3,370. At December 31, 2024 and 2023, there were no remaining forfeited nonvested accounts.

Diversification Transfers from Employee Stock Ownership Plan (ESOP)

During the plan year ended December 31, 2024, the Plan accepted diversification transfers from the Campus Holdings, Inc. Employee Stock Ownership Plan, an employee stock ownership plan sponsored by Campus Holdings, Inc. The total value of the diversification transfers received during the year was \$287,259.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balance and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions in accordance with the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENT INFORMATION

Principal Trust Company, the custodian, has certified to the completeness and accuracy of those investments reflected on the statement of net assets available for benefits at December 31, 2024 and the accompanying schedule of assets held at end of year, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, as follows:

4. FAIR VALUE MEASUREMENTS

GAAP establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds - Valued at the quoted market price on an active market. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 for fair value hierarchy purposes.

Common Collective Trust – Stated at fair value using net asset value (NAV), which is derived from the fair values of its underlying investments, including mutual funds, separate accounts and another collective trust fund. The mutual funds are valued using Level 1 inputs, as they have publicly quoted prices. While the separate accounts and the underlying collective trust do not have publicly quoted pricing inputs, their fair values contribute to the overall NAV. Although the common collective trust itself is not publicly traded, its NAV is available to current investors through the employer's website or when plan participants access their account values. Given that the common collective trusts are valued similarly to mutual funds and have a readily determinable fair value, they are classified as Level 1 for fair value hierarchy purposes.

Poole separate accounts – Stated at fair value using NAV, which is derived from the fair values of the underlying investments, which are primarily stocks or mutual funds. The majority of the underlying securities are valued using Level 1 inputs, as they have observable quoted prices. Although the NAV of the pooled separate account is not publicly quoted, it is available to current investors through the employer's website of when plan participants access their account values. The NAV is the basis for current transactions, and the account can be redeemed at NAV as of the measurement date. Given that the pooled separate accounts are valued similarly to mutual funds and have a readily determinable fair value, they are classified as Level 1 for fair value hierarchy purposes.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. INCOME TAX STATUS

The Company has adopted a pre-approved plan document offered by Principal Life Insurance Company that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

7. PARTIES-IN-INTEREST TRANSACTIONS

Principal Trust Company is the custodian as defined by the Plan and the Company is the Plan sponsor. As such, transactions between Principal Trust Company, the Company and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

Significant Findings

Qualitative Aspect of Accounting Policies

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we will advise management about the appropriateness of accounting policies and their application. The significant accounting policies used by the Campus Construction Management Group Inc. 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024.

We noted no transactions entered into by the Plan during the year that were both significant and unusual, and of which, under professional standards, we are required to inform you, or transactions for which there is a lack of authoritative guidance or consensus. In addition, we did not identify any significant findings or issues during the audit in connection with the Plan's related parties.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

Management's estimate of the fair value of the Plan's investments in (i) mutual funds is valued at the quoted market price on an active market (Level 1); (ii) common collective trusts are stated at fair value using net asset value which is derived from the fair values of the its underlying investments (Level 1); and (iii) pooled separate accounts are stated at fair value using net asset value which is derived from the fair values of the underlying investments (Level 1).

The disclosures in the financial statements are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Significant Unusual Transactions Identified During the Audit

We identified no significant unusual transactions during the audit.

Difficult, Contentious or Other Matters Encountered During the Audit

We encountered no difficult, contentious, or other matters for which we consulted outside the engagement team that were, in our professional judgment, significant and relevant to those charged with governance regarding the responsibility to oversee the financial reporting process.

Corrected and Uncorrected Misstatements

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.
