We have audited the financial statements of HCI-Bulldog, LLC Employee Benefit Qualified High Deductible Health Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets (deficit) available for benefits and plan benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets (deficit) available for benefits and changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of HCI-Bulldog, LLC Employee Benefit Qualified High Deductible Health Plan as of December 31, 2024 and 2023, and the changes in net assets (deficit) available for plan benefits and changes in plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HCI-Bulldog, LLC Employee Benefit Qualified High Deductible Health Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTE 1 - PLAN DESCRIPTION

The following description of HCI-Bulldog, LLC Employee Benefit Qualified High Deductible Health Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a High Deductible Health Plan that provides health and prescription drug coverage to eligible employees of HCI-Bulldog, LLC (the "Company") and covered dependents, who have completed 90 days of service. HCI-Bulldog, LLC is the Plan Sponsor.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). The HCI-Bulldog, LLC Health Benefit Trust (the "Trust") serves as a conduit through which the benefits provided by the Plan are paid.

Plan Amendment

The Plan was originally adopted by the Company, effective March 23, 2010. The Plan was amended January 1, 2019 to reinstate the Plan as of January 1, 2020. All eligible employees were allowed to participate in the Plan on January 1, 2020. The Plan was amended on January 1, 2023, to adopt the third party administrator provider, MedCost Benefit Services, LLC.

Benefits and Eligibility

The Plan provides health benefits (medical and prescription drug) coverage to full-time employees following 90 days of continuous employment. The Plan has optional coverage for dependents of qualifying employees.

Contributions

In addition to the deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective elections based on group rate premium costs established annually. The Company pays the full cost of the stop-loss insurance.

Self-insured Benefits

All Plan benefits are self-insured. The Plan offers self-insured medical benefits for all eligible employees. Eligible employees select their benefits under the self-insured medical benefit. Claims for most self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust.

Stop-Loss Coverage

HCI-Bulldog, LLC Employee Benefit Qualified High Deductible Health Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The stop-loss coverage has a specific deductible of \$85,000 per eligible person and \$1,000,000 aggregate benefit.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Sponsor's management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, eligibility credits, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Company or VEBA trust are recorded as insurance premium payments in the accompanying statement of changes in net assets available for benefits and plan benefit obligations. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of net assets available for benefits and plan benefit obligations.

Stop-Loss

Premiums for stop-loss insurance are included in insurance premium payments in the accompanying statement of changes in net assets available for benefits and changes in plan benefit obligations.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to health insurance administrative and management fees, trust fees and professional fees.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 4 - TAX STATUS

The Plan is intended to qualify as an employee welfare benefit plan as defined in ERISA. The Plan benefits are funded out of the general assets of the Company and employee contributions. The health benefits are paid in part of the trust established by the Company. The trust established under the Plan to hold the Plan's assets is a taxable trust.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 5 - CLAIMS INCURRED BUT NOT REPORTED

Plan benefit obligations at December 31, 2024 and 2023, for claims incurred but not reported are estimated by the Plan Sponsor's management based on data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payments. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 6 - RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

HCI-Bulldog, LLC is the Plan Sponsor; therefore, transactions with the sponsor qualify as parties-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company provided contributions to the Plan to fund costs in excess of the related participant contributions and paid certain administrative expenses of the Plan.

NOTE 7 - CONCENTRATIONS OF CREDIT RISK

The Trust maintains cash in financial institutions insured by the Federal Deposit Insurance Corporation. The deposit account, at times, may exceed federally insured limits.
