**NOTE A - DESCRIPTION OF PLAN**

The following description of the Center for Breakthrough Medicines 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan, which commenced January 1, 2022, and was restated January 1, 2023. All employees age 21 and over who have completed one month of service – elapsed time (not to exceed twelve months) are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute to the Plan up to 100% of their gross compensation on a pre-tax basis through salary reduction. Participants’ elective deferrals are subject to the limitations of Internal Revenue Code Section 402(g). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants may designate a percentage of after-tax compensation as Roth contributions. The Company can make a discretionary match as a uniform percentage of matched employee contributions and a non-elective contribution in an amount determined by the Company, as defined in the Plan. The Company contributions are determined annually by management. Participants’ contributions were \$2,557,176 for the year ended December 31, 2024. There were \$838,055 in Company contributions for the year ended December 31, 2024, net of forfeitures of \$398,767.

**Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant’s contribution, an allocation of the Company’s matching contribution and an allocation of Plan earnings as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately 100% vested in their own contributions to the Plan. Participants will be considered to have earned a year of service based on the elapsed time method from their date of hire. Vesting in the Company’s matching and profit-sharing contribution is determined as follows:

Year 1.....	20%
Year 2.....	40%
Year 3.....	60%

#### **Vesting (Continued)**

Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age.

#### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be fully repaid through payroll deductions within 5 years unless the loan is used to purchase the participant's primary residence. Loans used to purchase a primary residence, the administrator may permit a longer repayment term of up to 30 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate + 2% as published in The Wall Street Journal. The loans bear interest at rates that range from 7.50% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. The maximum number of loans outstanding at any one time is one.

#### **Payment of Benefits**

Participants are eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Adoption Agreement,
- The participant's termination of employment, or
- Termination of the Plan.

The normal retirement age under this Plan is 65.

#### **Forfeitures**

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan as specified in the Adoption Agreement. Forfeitures will be applied to reduce employer contributions or reduce administrative expenses. The forfeiture nonvested account balances for the years ended December 31, 2024 and 2023, was \$14,679 and \$147,319, respectively. The forfeitures are maintained in an account separate from individual participant accounts. Forfeitures applied to reduce the employer matching contribution and administrative expenses for the year ended December 31, 2024 was \$418,555.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participants' accounts shall be in accordance with the Plan document.

#### **Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act; however, plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation**

Plan investments in mutual funds are stated at fair value. Shares of mutual funds are valued at quoted market prices. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principle market is open and available to any participant in the Plan.

The Plan's investment in the group annuity contract is valued daily at book value with a market value adjustment.

Purchases and sales of mutual funds shares and the group annuity contract are recorded at end of day net asset value. Dividends are recorded as of the record date.

#### **Participant loans receivable**

Participant loans receivable is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses are subtracted from the participants' accounts.

#### **Party-in-Interest Transactions**

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions allowable under ERISA guidelines.

#### **Date of Management's Review**

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

### NOTE C - RELIANCE ON TRUSTEES' REPORT

The administrator of the Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by AdvisorTrust, Inc., the trustee of the Plan, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, other than comparing such information to that contained in the financial statements and supplemental schedules.

### NOTE D - TAX STATUS

The Plan is a Volume Submitter plan sponsored by PCS Retirement LLC. The Volume Submitter Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed, and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management is aware of certain operational failures with employee and employer contributions. The company is working with the recordkeeper to correct these failures in accordance with Department of Labor Guidelines.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The company is working with the recordkeeper to correct the operational failures therefore, the Plan Administrator analyzed the tax positions by the Plan and has concluded that as of October 14, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE E - FAIR VALUE MEASUREMENTS

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

*Level 1* inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The group annuity contract is categorized as Level 2 and is valued at cost plus accrued interest and a market value adjustment as defined in the contract, which approximates fair value.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
