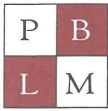

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of VRF Eye Specialty Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Note A – Description of Plan

The following description of the VRF Eye Specialty Group (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more detailed description of the Plan’s provisions.

General

The Plan is a defined contribution plan funded by employee and employer contributions and administered by VRF Eye Specialty Group, PLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Participation in the Plan is available to all employees who have completed one year of service (1,000 hours) and have attained the age of 18. Entry dates for eligible participants following completion of requirements are the first day of the first and seventh months.

Contributions

Eligible employees may elect to contribute a maximum of 100% of compensation to the plan, subject to annual deferral limits imposed by the Internal Revenue Service. “Catch-up” contributions are permitted for participants age 50 and above. The employer’s matching contribution (which qualifies as a Safe Harbor Basic Match under the Internal Revenue Code) is equal to 100% of deferrals up to 3% of participant compensation, plus 50% of deferrals from 3% to 5%. The employer may also contribute an additional profit sharing amount determined annually at the discretion of the Board of Directors for those participants employed on the last day of the plan year. No profit sharing contributions were made during the years ended December 31, 2024 and 2023.

Participant Accounts

The employer remits contributions to the Plan custodian, Charles Schwab Bank Trust Company (the Custodian). The Custodian holds plan assets and executes investment transactions as directed. The Custodian maintains records of participant activity and participant data. Participants direct the investment of their account through a choice of mutual funds and guaranteed accounts offered by the Plan. The plan document provides for allocation provisions and the disposition of forfeitures.

Payment of Benefits

In the event the Plan is terminated, or the Company permanently discontinues contributions, the amounts then credited to the accounts of participating employees become fully vested, although

Note A – Description of Plan - Continued

the time for distribution may be deferred. A participant becomes fully vested in their account upon the participant's termination, death, permanent and total disability, or attainment of normal retirement age. Upon the participant's termination, death, permanent and total disability, or retirement, the vested benefits allocated to the participant's account may be paid in a lump sum payment or in installments, depending on the vested account balance.

Vesting

Vesting is based on years of service, as defined by the Plan. Employer profit sharing contributions to a participant's account do not fully vest until the completion of six years of service. Participants are immediately vested in their employee deferral contributions and qualified matching contributions. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited and used to pay any administrative expenses or reduce the amount of employer contributions.

Forfeitures

Forfeiture allocations may be used to offset employer contributions and pay administrative expenses. Forfeitures of \$55 and \$30 were available as of December 31, 2024 and 2023, respectively. No forfeitures were applied to contributions in 2024.

Administrative Expenses

Administrative expenses may include Plan administration fees, investment management fees and/or transaction-based fees. Other administration fees are paid by the Company and are not charged to the Plan. Contract administrative fees of \$5,121 were paid by the Plan in 2024 and are reflected in the statement of changes in net assets available for benefits. Investment management fees on mutual funds are typically reflected as a reduction in the respective fund's net asset value and are paid by the participants.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of VRF Eye Specialty Group 401(k) Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Financial Statement Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Note B – Summary of Significant Accounting Policies - Continued

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments in the Plan are participant directed. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

Contributions

Employer and employee contributions are reported in the year services are rendered to the Company by plan participants.

Payment of Benefits

Benefits are reported in the year paid.

Date of Management's Review

Plan management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. There were no material events requiring recognition or disclosure.

Note C – Information Prepared and Certified by Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments at fair value
- Interest and dividends
- Net appreciation (depreciation) in fair value of investments
- Schedule H, line 4i - Schedule of Assets (Held at End of Year)

The plan administrator instructed the independent auditors not to perform, and they did not perform, any auditing procedures with respect to this information, except for comparing it with related information included in the financial statements and supplemental schedule.

Note D – Fair Value Measurements

FASB ASC Section 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset, including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds, Self-Directed Brokerage Accounts – Valued at the daily closing price which represents the net asset value of the shares held reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Related Party and Party in Interest Transactions

Plan investments consist of mutual funds and self-directed brokerage accounts managed by the Custodian, Charles Schwab Trust Bank. Therefore, these transactions qualify as party-in-interest transactions.

Note F – Plan Tax Status

The Plan uses a volume submitter document provided by The Retirement Plan Company. The document is approved by the Internal Revenue Service as being designed in accordance with applicable sections of the Internal Revenue Code. The plan administrator believes the Plan is currently operated in compliance with the approved plan document. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. The plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal tax examinations for years before 2022.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their entire account.

Note H – Risk and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and other investment securities. Generally, all investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances, the amounts reported in the statements of net assets available for benefits, and the amounts reported in the statement of changes in net assets available for benefits.

Note I – Reconciliation of Financial Statements to Form 5500

Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 at December 31, 2024 and 2023.
