The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of the Plan

The following brief description of the Del Papa Distributing Company, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of the Company who have a minimum of sixty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Profit Sharing Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s participants. The Plan was restated June 1, 2022.

B. Contributions

Each year, participants may contribute, pretax, up to a specified dollar amount determined by the Internal Revenue Service, as defined in the Plan. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company’s board of directors. Participants direct the investment of their contributions and the Company matching contribution into various investment options offered by the Plan. All employer contributions are invested in accordance with the investment options listed below. Employees are automatically enrolled in the Plan at a deferral rate of 3%, unless they opt out or change the deferral percentage. An automatic increase shall not apply.

C. Participant accounts

Each participant’s account is credited with the participant’s contributions and Company matching contributions and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting of Benefits

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is 20 percent vested after two years of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service.

E. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

F. Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,024 and \$18,926, respectively. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$48,340 from forfeited nonvested accounts.

G. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from 1-5 years, or up to 15 years for the purchase of a primary residence. The loans are secured by the participant's account balance and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator at origination. Interest rates are 1% over prime. Principal and interest is paid ratably through bi-weekly payroll deductions. Interest rates range from 4.25% to 9.5%.

Note 2 – Summary of Significant Accounting Policies

A. Basis of Presentation

The Financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan that are fully benefit responsive are required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit responsive investment contracts.

B. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Profit Sharing Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if applicable, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

F. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance has been recorded as of December 31, 2024 and 2023 for these notes receivable. Delinquent loans are treated as distributions in the quarter following the calendar quarter in which the participant missed the scheduled payment based upon the terms of the plan document.

G. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025 the date the financial statements were available to be issued.

Note 3 - Plan Advisory Committee and Custodian

The Plan provides for selection of an Administrative Committee and Custodian by the Board of Directors of the Company. The Administrative Committee is responsible for the administration of the Plan. Ameritas Life Insurance Company administers the Trust Fund, which consists of all assets owned by the Plan. Ameritas Life Insurance Company has been granted full authority concerning purchases and sales of investments of the Plan's assets. Ameritas Life Insurance Company is the Custodian of all of the Plan's investments.

Note 4 - Information Certified by Custodian (Unaudited)

The following is a summary of the unaudited information regarding the Plan that was prepared by Ameritas Life Insurance Corporation, the Custodian of the Plan. The Plan Administrator obtained certifications from the Custodian that such information is complete and accurate.

Note 5 – Fair Value of Plan Assets

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at net asset value.

Pooled separate accounts: Valued at the Net Asset Value (NAV), as provided by the insurance company who holds the pooled separate account. These funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAV's are received daily from fund managers, and the managers stand ready to transact at these quoted amounts. Were the plan to initiate a full redemption of the trust, the insurance company custodian (Ameritas Life) reserves the right to temporarily delay payment from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The insurance company custodian (Ameritas Life) transacts in these funds on a daily basis as part of the separate account trading activity. The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices.

Note 6 – Guaranteed Investment Contract with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Ameritas Life Insurance Company. The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. Ameritas maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Investment contracts held by a defined contribution plan that are fully benefit responsive are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023, was \$1,495,608 and \$1,429,326, respectively. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,502,422 and \$1,434,866, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events for example, divestitures or spin-offs of a subsidiary that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at contract value with participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Ameritas is contractually obligated to pay principal and a specified interest that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4.52%. Such interest rates are reviewed on a quarterly basis for resetting.

Note 7 – Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Ameritas Life Insurance Company. Ameritas is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management, recordkeeping, and audit services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the plan's operations.

Note 8 - Termination of the Plan

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

Note 9 – Tax Status

The Plan is using a prototype plan dated May 1, 2002. The prototype plan most recently received an opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code. The Plan has been amended since that letter. However, the Plan administrator and the Plan's tax counsel believe that the prototype plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
