Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Domtar US Salaried 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the Domtar US Salaried 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

General

The Plan was established on August 4, 2001 pursuant to an agreement between Georgia-Pacific Corporation and Domtar Industries LLC (the "Company" and "Plan Sponsor") to purchase four paper mills. Accordingly, assets were transferred to the Plan from the Georgia-Pacific Corporation Salaried 401(k) Plan (the "Georgia-Pacific Plan") on behalf of participants previously covered by such plan. Any employee who was a participant in the Georgia-Pacific Plan as of August 3, 2001, was automatically eligible to be a participant in the Plan. The Plan document was amended and restated as of January 1, 2022.

Employees of the Company and affiliates who are on a regular salaried basis become eligible to participate in the Plan as of their date of hire. Employees who are eligible to participate in the Domtar US Hourly 401(k) Plan are excluded from participation in the Plan.

Employees of the Company who are eligible for the Plan and who do not participate in the Domtar US Salaried Pension Plan, receive from the Company an automatic contribution varying from 4% to 6% of eligible compensation, based on age. Furthermore, all eligible employees receive a matching Company contribution of 100% of the employee contribution, up to a maximum of 5.5% of eligible compensation. Employees are automatically enrolled at a 5.5% contribution rate, increasing by 1% per year until it reaches 9.5%, unless the employee affirmatively elects otherwise. All contributions made are immediately vested.

As of April 27, 2020, West Carrollton salaried employees are covered under the Plan. West Carrollton employees receive an automatic contribution varying from 1% to 5.5% of eligible compensation, based on age and service. Furthermore, all eligible employees receive a Company matching contribution of 50% of the employee contribution, up to a maximum of 6% of eligible compensation. West Carrollton employees are automatically enrolled at a 4% contribution rate, increasing by 1% per year until it reaches 10%, unless the employee affirmatively elects otherwise.

As of January 1, 2021, salaried and non-union hourly employees of EAM Corporation ("EAM") became eligible for participation in the Plan. Employees of the Company who are eligible for the Plan and who do not participate in the Domtar US Salaried Pension Plan, receive from the Company an automatic contribution of 3% of eligible compensation. Furthermore, all eligible employees receive a matching Company contribution of 50% of the employee contribution, up to a maximum of 5% of eligible compensation. Employees are automatically enrolled at a 5% before tax contribution rate, unless the employee affirmatively elects otherwise.

Asset Transfers In/Out

During 2024, transfers out to the Domtar US Hourly 401(k) Plan were \$401,988 and transfers in were \$4,280,027. These represent the transfer of participant account balances for participants whose status changed during the year.

Contributions

The Plan has a voluntary salary deferral 401(k) feature in which participants may elect to contribute from 1% to 60% (in 0.5% increments) of their eligible compensation, as defined in the Plan document, to their elective contribution account in the Plan, subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participants who have attained age 50 before the close of the Plan year shall be eligible to make catch up contributions in accordance with, and subject to, the limitations of the Internal Revenue Code (the "IRC").

Employees are permitted to request loans and hardship withdrawals from amounts in their before-tax employee accounts. Loans and hardship withdrawals are not permitted from matching contribution accounts or automatic contribution accounts.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings and losses and may be charged with an allocation of administrative expenses. Allocations of expenses are based on the account balances in each participant's account and the expense ratio applicable to the chosen fund(s). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

For West Carrollton employees, Company automatic and matching contributions gradually vest over five years of service and employee contributions are immediately vested. For all other employees, all contributions that are credited to a participant's account are considered fully vested.

Payment of Benefits

Upon termination of employment, death or disability, a lump sum in cash or a rollover distribution are permitted. If a participant's account balance is less than \$7,000 upon termination of employment, and that participant does not elect to receive or rollover the balance of his or her account, it will be paid in cash if the amount does not exceed \$1,000 or rolled over to an IRA if the amount exceeds \$1,000 but not \$7,000. If a participant reaches age 59.5, the Plan allows withdrawals of all or a portion of the account. Upon reaching age 73, participants will need to begin taking a portion of their balance out of the Plan each year. The Plan provides for hardship withdrawals for specific hardship situations and are subject to certain restrictions.

Notes Receivable from Participants

Participants may borrow up to one half of their vested interest or \$50,000, whichever is lower, with a minimum loan amount of \$1,000. The loans are secured by the vested balance in the participant's account. Interest on the loan is set at one point above the prime rate effective the first day of the month of the loan. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest is paid ratably primarily through payroll deductions. Loan repayment periods are no longer than five years for general purpose loans and no more than 15 years for primary residence loans. No more than one loan from the Plan and all other Company employee benefit plans may be outstanding at any one time. The participant is charged a loan initiation fee that is deducted from the loan proceeds at the time that funds are disbursed. In addition, an annual loan maintenance fee is deducted from the participant's account each year after the first year of the loan.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in 1% increments. Participants direct the investment of their account into the various investment options offered by the Plan. Participants may change their investment elections on a daily basis.

The Pension Administration Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The following accounting policies, which conform with accounting principles generally accepted in the United States of America ("US GAAP"), have been used consistently in the preparation of the Plan's financial statements.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment funds, it is at least reasonably possible that changes in the values of investment funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the Plan's interest in the Domtar US 401(k) Master Trust ("Master Trust") is based on the specific interest that it has in the underlying participant-directed investments. Refer to Note E - Fair Value Measurements for valuation details of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year. Net investment income (loss) is allocated to the Plan based on the Plan's interest in the net assets of the Master Trust.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation in fair value of investments.

NOTE C - INFORMATION CERTIFIED BY VANGUARD FIDUCIARY TRUST COMPANY

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certifications received from Vanguard Fiduciary Trust Company ("VFTC" or "Trustee") meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the accompanying financial statements are complete and accurate:

- Plan interest in the Master Trust and notes receivable from participants included in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Plan interest in the Master Trust investment income and interest income on notes receivable from participants included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Total investments, at fair value and total investment income in the Master Trust included in Note D.
- Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan interest in the Master Trust and notes receivable from participants included in the Statements of Net Assets Available for Benefits as of December 31, 2024, included in-kind transfers that were recorded prior to the effective merger date. The Plan interest in Master Trust was reduced by \$22,726,131 and notes receivable from participants was reduced by \$1,083,591 from the certified amount. Refer to Note I - Subsequent Events for further details.

NOTE D - INTEREST IN THE MASTER TRUST

The Master Trust was established effective August 4, 2001, for the investment of assets of the Plan and other Company affiliated retirement plans. The assets of the Master Trust are held by the VFTC. Use of the Master Trust permits the commingling of assets for the participating plans. Although the assets are

commingled in the Master Trust, the Trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans. Investment income (loss) and administrative expenses relating to the Master Trust are allocated to the individual plans based upon the balances of participant accounts in each plan.

NOTE E - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These investments are classified within Level 1 of the valuation hierarchy.

Collective trusts: Valued at the NAV of units of a collective trust. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments consist of their share of investments in the Master Trust. Refer to Note D for details of the fair value of all assets within the Master Trust.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

NOTE G - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The majority of the Master Trust's investments are managed by an affiliate of VFTC. VFTC acts as trustee for all investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Participant loans also qualify as exempt party-in-interest transactions.

NOTE H - TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated October 17, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC and are exempt from federal income tax. The Plan has been amended and restated since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE I - SUBSEQUENT EVENTS

The Plan Administrator evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Company merged Resolute FP US Savings Plan, Atlas Paper Mills LLC 401(k) Plan and the Catalyst Paper (USA) Inc. 401(k) Plan into the Plan. The mergers included a mix of in-kind transfers of \$22,726,131, cash of \$160,659,323, and participant loans of \$1,083,591.

The Plan Administrator is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.
