## INDEPENDENT AUDITOR'S REPORT

To the Participants, Plan Administrator, and 401(k) Committee  
BlackHawk Industrial Distribution, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BlackHawk Industrial Distribution, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### Note 1 – Description of the Plan

BlackHawk Industrial Distribution, Inc. (the Company or Employer) sponsors the BlackHawk Industrial Distribution, Inc. 401(k) Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established for the benefit of the Company's employees, except for leased employees, seasonal employees, internship employees, temporary employees, summer employees, collectively bargained employees not covered by an agreement that provides for their participation in the Plan, residents of Puerto Rico, nonresident aliens who do not have any U.S. source income, and employees acquired in an asset or stock acquisition, merger or similar transaction described in Internal Revenue Code (the Code) Section 410(b)(6)(C). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The 401(k) Committee is responsible for the oversight of the Plan. T. Rowe Price Trust Company (the Trustee) serves as the trustee of the Plan and holds the Plan assets. T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price), an affiliate of the Trustee, maintains the records of the participant data.

#### Eligibility

Nonexcluded employees who have reached 18 years of age are eligible to participate in the Plan. Effective January 1, 2024, seasonal, temporary, internship, and summer employees who have reached 21 years of age and have completed at least 500 hours of service in three consecutive years are eligible to participate in the Plan for participant deferrals. Nonexcluded union employees who have reached 18 years of age and completed three months of service, as defined in the Plan document, are eligible to participate in the Plan. Participants are automatically enrolled in the Plan on the first day of the month after satisfying eligibility requirements.

#### Contributions

Participants may contribute 1% up to 80% of their compensation, as defined in the Plan document, as either pretax deferrals, Roth deferrals, or after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Eligible employees are automatically enrolled in the Plan with a 6% deferral rate. Eligible employees who do not wish to participate in the Plan may affirmatively elect to opt out, or they may elect a different deferral percentage. Eligible employees with a deferral rate less than 6% are automatically increased to 6% annually.

The Plan also provides for Employer safe harbor matching contributions equal to 100% of deferrals up to 1%, plus 50% of deferrals in excess of 1% up to 5% of a participant's compensation.

Effective February 12, 2024, the Plan also provides for Employer matching contributions equal to 100% of deferrals up to 1% of a participant's compensation plus 50% of deferrals for the next 5% of a participant's compensation, up to a maximum of 6% of compensation for eligible employees. Effective December 22, 2024, Employer matching contributions are equal to 50% of a participant's compensation, up to a maximum of 4% of compensation for eligible employees.

Additional amounts may be contributed by the Employer under the Plan's nonelective provisions at the discretion of the Company's board of directors. Unless termination is due to death, disability, or retirement, participants must be employed on the last day of the Plan year to receive an allocation of Employer nonelective contributions. Allocations of Employer nonelective contributions are based on the proportion of each participant's compensation to the total of all eligible participants' compensation. For the year ended December 31, 2024, there were no Employer nonelective contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Code.

#### Participant accounts

Each participant's account is credited with participant contributions, Employer safe harbor matching contributions, Employer matching contributions, and allocations of Employer nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Effective January 1, 2023, Employer safe harbor matching contributions are fully vested after one year of service. Vesting in Employer safe harbor matching contributions for participants who terminated employment prior to January 1, 2023, are based upon years of continuous service as follows:

Effective February 12, 2024, Employer matching contributions made between February 12, 2024, and December 21, 2024, are fully vested after one year of service, and Employer matching contributions made after December 21, 2024, are based upon years of continuous service as follows:

Vesting in Employer nonelective contributions is based upon years of continuous service as follows:

Five, but less than six	80%
Six years or more	100%

Participants automatically become 100% vested upon retirement (attainment age of 65), disability, or death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

#### Notes receivable from participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance during the preceding 12-month period over the outstanding loan balance on the date of the loan, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 10.00%, which is based the prime rate on the date of origination. Participants may only have one loan outstanding at any given time. Terms range from one to five years or up to 15 years for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$5,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Participants who were automatically enrolled in the Plan have the option to withdraw their deferrals without penalty within 90 days of their automatic enrollment date.

#### Forfeitures

Forfeitures are used to reduce Employer contributions, to pay Plan administrative expenses, or may be reallocated among participants. The Plan had \$63,150 and \$146,024 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$41,265 and \$108,433 were used to pay Plan administrative expenses and to reduce Employer contributions, respectively.

#### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participates in an agreement with the Trustee, where excess revenue may be returned and deposited into an unallocated expense budget account. The amounts in the unallocated expense budget account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. There were \$28,854 and \$16,646 of unallocated funds in the expense budget account as of

December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan used \$32,275 from the expense budget account to pay certain Plan expenses.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes herein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for delinquent notes receivable from participants has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

### Contributions

Participant contributions, the related Employer safe harbor matching contributions and Employer matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation. Employer nonelective contributions are recorded as contributions once approved by the Company's board of directors for the respective Plan year.

### Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

### Subsequent events

The Plan administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, seasonal, temporary, internship, and summer employees who have reached 21 years of age and have completed at least 500 hours of service in two consecutive years are eligible to participate in the Plan for participant deferrals.

### Note 3 – Information Certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

### Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

---

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

*Collective trust fund* – Stated at fair value as determined by the issuer of the collective trust fund based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of units of the collective trust fund. The NAV is used as a practical expedient to

estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Exchange traded funds* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds* – Valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 6 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Certain administrative expenses, totaling approximately \$96,000, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses.

Certain investments are managed by the Trustee. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

## Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution portion of their accounts.

## Note 8 – Tax Status

The Company adopted a preapproved defined contribution plan (the Preapproved Plan) sponsored by T. Rowe Price. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated August 19, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. The Plan administrator has indicated that it will take the necessary steps, if any, to maintain the Plan's tax-exempt status.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
