NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of The Fiesta Tableware Company (“Company”) 401(k) Profit Sharing Plan (“Plan”) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing and 401(k) plan established to provide retirement benefits for eligible employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and is administered by the Retirement Plan Committee appointed by the Board of Directors of the Company.

Eligibility

The Plan covers all nonunion employees of the Company. The only eligibility requirement for each nonunion employee to participate in the Plan as an active participant is that the employee must be at least 21 years of age. Unless and until such eligible employee files a written election with the Retirement Plan Committee either to contribute at a rate other than 3% or to not contribute and not participate in the Plan, the eligible employee shall automatically be a participant under the Plan who has elected to participate by contributing at a rate of 3% of the participant's monthly compensation into a Vanguard Target Retirement Fund commensurate with the participant's projected retirement date.

Contributions

Participants may elect to contribute, on a pre-tax basis, up to 100% of their total compensation via payroll deductions, subject to certain maximum limitations (\$23,000 and \$22,500 for 2024 and 2023, respectively) of the Internal Revenue Code (“Code”). Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024 and 2023). Participants are also permitted to make rollover contributions into the Plan from other qualified plans.

Effective January 1, 2024, the Company may, but shall not be obligated to, provide matching contributions based on deferral contributions as follows: 50% of the participant’s before tax contributions made on the first 3% of compensation. Effective January 1, 2024, the Company shall make a nonelective 3% Safe Harbor contribution to each eligible participant. Prior to the amendment to the Plan effective January 1, 2024, employer contributions were only made as directed by the Company’s Board of Directors. The Company’s contributions to the Plan totaled \$208,616 and \$6,175 for 2024 and 2023, respectively.

Participant accounts are credited with the participant's contributions and an allocation of employer contributions, if any, and Plan earnings as defined in the Plan document. Participants are immediately 100% vested in their voluntary contributions, allocated employer contributions, and allocated earnings thereon. Participants direct all contributions into various investment options offered by the Plan.

Loans

The Plan does not permit loans to participants.

Benefits and withdrawals

The benefit to which a participant is entitled is that benefit which can be provided from the participant's account. Participants are entitled to withdraw any portion of their vested account prior to retirement via hardship withdrawals, permanent disability, termination of employment, or death.

Situations which qualify for hardship withdrawals include educational expenses, purchase of a principal residence, extraordinary medical expenses, burial or funeral expenses, repair or damage to a participant's principal residence, as defined by the Code, and other similar financial emergencies. Upon reaching normal retirement age, participants may elect distributions from their accounts via lump-sum cash payments or various installment methods.

Plan termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their share of the trust.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of changes in assets during the reporting period. Actual results could differ from those estimates.

Corrective distributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as excess participant contributions payable on the statements of net assets available for benefits and included with benefits and withdrawals paid to participants on the statements of changes in net assets available for benefits.

Administrative expenses

Certain administrative expenses are paid directly by the Company or the Plan, as provided by the Plan document.

Benefits and withdrawals

Benefits and withdrawals paid to participants are recorded when applications for withdrawals are processed and paid.

Investments

Investments are reported at value as determined by Transamerica Life Insurance Company (“TLIC”). Shares of mutual funds are stated at fair value as measured by quoted market prices. The Plan’s investment in the Transamerica Stable Value Focus Option fund is a fully benefit-responsive investment contract and is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment transactions are recorded on a trade-date basis. Net appreciation in fair value of investments includes realized gains and losses on investments that were both bought and sold during the year. Gains, losses, and interest income incurred on investments at contract value are included in interest and dividend income within the statement of changes in net assets available for benefits. Interest and dividend income are recorded as earned.

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Contributions

Participant contributions are recorded in the month withheld from the participant's wages. Employer contributions, if any, are recorded in the same month.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 15, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The Plan provides participants the opportunity to direct their contributions into separate investment funds. However, the investing activity within the funds is discretionary, and individual fund managers have the authority to make investment decisions.

Fair value measurements

Market price observability is affected by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. Investments measured and reported at fair value are classified and disclosed in one of the following categories based on the extent of market price observability.

Level I - Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments included in Level I include listed mutual funds.

Level II - Inputs are other than quoted market prices included within Level I, however, are observable, either directly or indirectly for the investment. The Plan does not have any investments which fall under this category.

Level III - Pricing inputs are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. The Plan does not have any investments that fall under this category.

Transamerica stable value focus option

The Plan holds a fully benefit-responsive stable value option with TLIC. The stable value focus option is included in the financial statements at contract value. The stable value focus option fund is a deposit liability of TLIC. The assets are based on the general unallocated account of TLIC and the risk of the investment is based on TLIC insurance ratings.

Prior to January 1<sup>st</sup> and July 1<sup>st</sup> of each year, the effective annual rate of interest is established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate for the stable value focus option.

The TLIC stable value focus option is backed by the general account of TLIC. TLIC declares rates periodically and backs the principal and interest of these investment choices; any guarantees are subject to the claims paying ability of the insurance company. The nature of the stable value focus option is such that the Plan participants may withdraw assets without restrictions, TLIC may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The occurrence of an event that limits the ability of the investment to transact at contract value between TLIC and a participant holding the investment is not probable.

NOTE 4 - FEDERAL INCOME TAX EXEMPTION

The Plan obtained its latest determination letter dated February 8, 2016, in which the Internal Revenue Service stated that the Plan, as designed, is in compliance with the applicable requirements of the Code. Accordingly, the accompanying financial statements do not include a provision for federal income taxes. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is being operated in accordance with the terms of the Plan.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. Plan management is not aware of any uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for periods prior to 2021.

NOTE 5 - CERTIFICATION

The investment information contained in the financial statements and Schedule of Assets Held at End of Year as of and for the years ended December 31, 2024 and 2023, has been certified as accurate and complete by Reliance Trust Company, on behalf of TLIC, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For the years ended December 31, 2024 and 2023, Reliance Trust Company and TLIC are party to a Service Agent Agreement under which Reliance Trust Company administers certain administrative duties on behalf of TLIC, including the certification of investments in accordance with 29 CFR 2530.103-8 of the Department of Labor's Rules and Regulations for Reporting and disclosure under ERISA.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by TLIC. TLIC is the custodian as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions. The Plan also paid administrative expenses to TLIC, which qualify as party-in-interest transactions.

NOTE 7 - PARTICIPANT CONTRIBUTIONS

The Company discovered \$4,705 of participant contributions that were remitted to the Plan after a period demonstrated to be administratively feasible during the year ended December 31, 2024. The Company plans to correct these prohibited transactions outside of the Voluntary Fiduciary Correction Program during the Plan year ending December 31, 2025.
