## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of IDM Companies LLC 401(k) Profit Sharing Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

# IDM COMPANIES LLC 401(k) PROFIT SHARING PLAN TRUST

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1 – PLAN DESCRIPTION

The following brief description of the IDM Companies LLC 401(k) Profit Sharing Plan Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of IDM Companies, LLC (the Company), who meet the eligibility requirements, with the exception of union employees, nonresident aliens and independent contractors. Prior to January 1, 2024, employees were eligible to participate in the Plan on the first entry date after attaining 21 years of age. The age requirement was removed with the January 1, 2024 Plan amendment. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendment** - Effective January 1, 2024, the Plan was amended to remove the age requirement for eligibility purposes.

**Contributions** - Contributions consist of employee elective deferrals, Roth elective deferrals, and employer matching contributions. Employee elective deferrals and employer matching contributions are recorded in the year in which the contributions are withheld from compensation. Employees may voluntarily contribute up to 90% of their compensation, limited to \$23,000 in 2024 and \$22,500 in 2023, annually, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make additional catch-up contributions of \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company makes employer matching contributions in an amount equal to the sum of 100% of the participant's deferral on the first 3% of the participant's eligible compensation and 50% of the participant's deferral contributions on the next 4% of the participant's eligible compensation. In addition, contributions are subject to certain limitations as prescribed by the IRC.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocation of Plan earnings is based upon participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in employer contributions plus actual earnings thereon at a rate of 33% after each year of credited service. A participant is fully vested after three years of credited service. Participants vest immediately in all contributions plus actual earnings when they reach normal retirement age or in the event of death or total and permanent disability.

**Payment of Benefits** - Upon reaching retirement age, termination of service, or death, a participant may be paid a lump sum amount equal to the participant's vested account value. Upon reaching age 59½, participants may take in-service withdrawals of part or all of their vested account balance. The Plan further provides for qualified reservist and hardship distributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs. Account balances that are under \$7,000 may be transferred to an IRA at the discretion of the Company.

**Expenses** - Certain administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from participants' accounts. In addition, certain expenses of plan administration, including computer services, professional fees, office supplies, and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

**Forfeitures** - Forfeited, non-vested accounts may be used to pay administrative expenses of the Plan or to reduce employer matching contributions. Forfeited accounts totaled \$0 and \$87,958 at December 31, 2024 and 2023, respectively. During 2024 and 2023, forfeitures of \$160,596 and \$44,594 were used to reduce employer matching contributions, respectively. During 2024 and 2023, forfeitures of \$0 and \$13,675 were used to pay administrative expenses, respectively.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual basis of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common trust funds:* Valued at the NAV of units held by the Plan at year end as reported by the investment managers. The NAV for each of the common/collective trust funds is provided by the trustee and is used as a practical expedient to estimate fair value. Units in common/collective trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in common/collective trust funds represents the value of the Plan's interests in the overall value of the common/collective trust fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner.

Investments in common/collective trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity, then the fund may defer honoring any payment request until liquidity is sufficient.

*Fixed annuity contract:* The values for this fixed annuity investment option are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

#### **NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN OF THE PLAN**

The following is a summary of unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), that was certified by the trustee and custodian of the Plan, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, as of December 31, 2024 and 2023 and for the years then ended, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee and custodian that such information is complete and accurate at December 31:

#### **NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their accounts up to the lesser of 50% of the present value of the borrower's vested interest in amounts held under the Plan at the time of loan origination or \$50,000. Loans must be repaid within five years unless for purchase of a primary residence. Loan provisions provide for interest rates, repayment schedules and collateral similar to those offered by financial institutions that grant similar loans. Interest rates range from 5.25% to 10.50%, on loans outstanding at December 31, 2024. Loans are secured by the vested account balance of the participant.

#### **NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments of the Plan are shares of the fixed annuity contract or mutual fund managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower). Empower is the trustee and custodian of the Plan, and therefore, these transactions represent exempt party-in-interest transactions. Fees for investment management services for the investments held and charged by the trustee or an affiliate of the trustee were at a rates that range from 0.27% to 0.35% and are netted against Plan earnings.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were three and two investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

## **NOTE 9 – TAX STATUS**

The Plan document is a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Independent Retirement Consulting LLC. The prototype Plan document obtained an opinion letter June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 10 – PROHIBITED TRANSACTIONS**

During 2024, 2023, 2021 and 2020, elective deferrals and loan repayments withheld from employee's payroll totaling \$5,722, \$135,167, \$43,773 and \$33,010, respectively, were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrences and has taken the appropriate steps to correct the occurrences in October 2025.
