Independent Auditor's Report

To the Plan Administrator and Plan Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of RHG Consolidated, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1) Description of the Plan

The following description of RHG Consolidated, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees RHG Consolidated, LLC (the “Employer” or the “Company”) who complete six consecutive months of service, with no minimum age required. Related employers who also participate in the Plan include Cooper County Community Hospital, LLC; Sumner Community Hospital; Crittenden Community Hospital, LLC; Hillsboro Hospital, LLC; Drumright Community Hospital; and Lauderdale Community Hospital, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective February 1, 2024, the Plan was restated, amending the match from a safe harbor matching contribution to a discretionary matching contribution. The Company made a discretionary match of 50% of the first 4% of deferrals for the period February 1, 2024 through December 31, 2024. The Company made a safe harbor matching contribution equal to 100% of participant contributions up to 1% of compensation plus an additional amount equal to 50% of an employee’s contribution between 1% and 6% for the year ended December 31, 2023 and for the month ended January 31, 2024.

The Plan also includes an auto-enrollment provision whereby all eligible participants who have not entered into a deferral election will have their deferral rate set at 3% of their eligible compensation unless they affirmatively elect not to participate in the Plan. An automatic 1% increase in deferral rates will be made each year for those participants who were automatically enrolled in the Plan, with a maximum of 6% deferral.

Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are always fully vested in their own contributions, plus actual earnings thereon. Participants are 100% vested in the Company's safe harbor matching contribution portion of their accounts plus earnings thereon after two years of continuous service. Effective with the February 1, 2024, plan amendment and restatement, discretionary matching contributions made on or after February 1, 2024, are also 100% vested after two years of continuous service.

Vesting in the Employer's matching and discretionary contributions, plus actual earnings thereon, are based on a five-year graded schedule. Participants also become fully vested in Employer contributions upon death or becoming disabled while employed.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding at any given time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly or bi-weekly payroll deductions.

Payments of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account as allowed for under the Plan. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump sum distribution.

Forfeitures

Forfeited nonvested accounts are used to pay plan expenses, reduce future Employer contributions, or are reallocated to participants in the same manner as employer contributions. Forfeitures of \$17,817 were used to reduce the Employer contributions during the year ended December 31, 2024. The balance in the Plan's forfeiture account as of December 31, 2024 and 2023, was \$624 and \$0, respectively.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with the accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. The Employer paid a portion of the Plan's expenses for the year ended December 31, 2024 and 2023, which are excluded from the financial statements. Fees paid by the Plan for investment related services are included in net appreciation (depreciation) in fair value of investments.

Reclassification

A reclassification has been made to the 2023 financial statements to conform to the 2024 financial statement presentation for the fair value presentation in Note 3. This reclassification had no effect on changes in net assets available for benefits.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 15, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

Pooled Separate Accounts – The net asset value (NAV) of pooled separate accounts (PSA) is based on unit values reported by the Plan custodian as determined by the investment manager based on the fair value of the underlying assets net of liabilities divided by the number of outstanding units of the trust on its valuation date. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not assigned a level in

the fair value hierarchy. There are no unfunded commitments for the PSA. There is no redemption notice period and an immediate redemption frequency for any purchases and sales that occur.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, the Plan had no investments valued at fair value based on the fair value hierarchy. The investments measured at NAV as of December 31, 2024 and 2023, were \$10,942,651 and \$9,498,450, respectively.

4) Information Prepared and Certified by the Custodian (Unaudited)

Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by John Hancock Life Insurance Company, a qualified institution, and certified as complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net Investment income and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants reflected on the supplemental schedule of assets held at end of year.

5) Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions and earnings thereon.

6) Tax Status

The Plan is operating under a prototype document with a non-standardized adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype plan sponsor. The Plan was amended after the IRS issued the opinion letter to the Plan sponsor. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, no uncertain tax positions have been taken and none are expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7) Party-in-Interest and Related Party Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A), the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services rendered by the custodian, were \$43,905 for the year ended December 31, 2024. The Plan also paid approximately \$61,791 of recordkeeping and investment advisory fees to parties-in-interest during the year ended December 31, 2024.

Additionally, the Employer provides certain accounting, administrative, and management services to the Plan for which no fees are charged.

8) Delinquent Participant Contributions

As disclosed in the supplemental schedule of delinquent participant contributions, three pay periods of participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 20 CFR 2510.3-102, thus constituting nonexempt transactions between the Employer and the Plan. As such, these transactions represent non-exempt transactions between the Employer and the Plan as identified in Schedule H, Line 4(a), Schedule of Delinquent Participant Contributions. All delinquent 2024 participant contributions were remitted to the Plan no later than December 31, 2024.
