Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of The Silvercrest Center for Nursing and Rehabilitation Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of The Silvercrest Center for Nursing and Rehabilitation Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees (as defined in the Plan document) of The Silvercrest Center for Nursing and Rehabilitation (Silvercrest). Employees are eligible to participate in the Plan immediately for purposes of making salary deferred contributions. For employees who were first credited with an hour of service prior to July 1, 2011, an employee shall be eligible for employer contributions upon the completion of 90 days of employment. For employees who were first credited with an hour of service on or after July 1, 2011, an employee shall be eligible for employer contributions upon the completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In March 2020, the plan was amended and restated in its entirety effective as of January 1, 2018.

Contributions

Each year, participants may elect to have a percentage or specified pre-tax dollar amount deducted from their compensation as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend deductions according to procedures established by Silvercrest. Participants may also contribute amounts representing distributions from other qualified retirement plans. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code (IRC).

Silvercrest will determine in its sole discretion how much, if any, it will make as an employer contribution.

1. Description of Plan (continued)

Vesting

Participants are fully vested at all times in their salary deferral contributions plus actual earnings thereon. For employees who were first credited with an hour of service prior to July 1, 2011, a participant is 100% vested in the employer contributions after one year of service. For employees who were first credited with an hour of service on or after July 1, 2011, a participant's vested percentage in a portion of their account attributable to employer contributions shall be determined under the following schedule:

1	20%
2	40%
3	60%
4	80%
5	100%

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$40,372 and \$4,585, respectively. These accounts may be used to reduce Plan administrative expenses or employer contributions. During 2024, \$701 of forfeitures were used to reduce employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (1) the employer contributions and (2) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

Notes Receivable From Participants

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of the vested account balance or \$50,000 (whichever is less). The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or Silvercrest, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by Silvercrest. Expenses that are paid by Silvercrest are excluded from the accompanying financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contracts and pooled separate account, which are valued at contract value since they are fully benefit-responsive. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The mutual funds and money market funds held by the Plan are valued based on the daily closing price as quoted on an active market. All of the funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

All investments held in the Plan are participant-directed. See Note 4 for the composition of investments held in the Plan.

Certain investment and participant notes receivable information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, guaranteed investment contracts and the pooled separate account at contract value, and participant notes receivable at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividends, and interest on participant notes receivable for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company (on behalf of Transamerica Retirement Solutions, LLC), Transamerica Financial Life Insurance Company (TFLIC), and Variable Annuity Life Insurance Company (VALIC) Trust Company, the custodians of the Plan.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

4. Fair Value Measurements (continued)

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level of input that is significant to the fair value measurement in its entirety.

Financial assets carried at fair value are classified in the table below in one of the three categories described above as of December 31, 2024 and 2023:

5. Fully Benefit-Responsive Investment Contracts

The Plan invests in the following fully benefit-responsive guaranteed investment contracts: the VALIC Fixed Interest Option (the VALIC Option), the TFLIC Fixed Fund (the Fixed Fund), and the TFLIC Government Fixed Fund (the Government Fund); the Government Fund is maintained separately from TFLIC’s general assets in a pooled separate account. These investment contracts are recorded at contract value. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus earnings, less participant withdrawals and administrative expenses.

Each issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. Both principal and interest are guaranteed by TFLIC for its contracts. The Government Fund invests in obligations of the U.S. government and its agencies, and provides a book value guarantee in all market environments. The Government Fund seeks to provide higher yields than short-term fixed maturity alternatives. Participants are generally permitted to make benefit distributions at contract value from the Government Fund. However, participant elected withdrawals for any reason other than benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

The crediting rates are based on formulas established by the contract issuer but may not be less than 3% for the VALIC Option, 3.5% for the Fixed Fund, and 3% for the Government Fund; the crediting rates are reviewed on an annual basis for resetting. The contracts cannot be terminated before the scheduled maturity dates.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of a contract
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

Refer to the plan sponsor financial statements for information regarding status of an asset purchase agreement related to the plan sponsor.

In addition, certain events allow an issuer to terminate its contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The plan administrator does not believe that the occurrence of any such events that would limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants is probable.

6. Plan Termination

Silvercrest is the plan administrator. Although it has not expressed any intent to do so, Silvercrest has the right to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

7. Income Tax Status

The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated April 5, 2018, stating that the written form of the underlying prototype document is qualified under Section 403(b) of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the Code, and, therefore, the related custodial accounts are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

7. Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Related-Party and Party-in-Interest Transactions

The Plan holds certain investments managed by the custodians of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the accompanying statements of net assets available for benefits.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

9. Risks and Uncertainties (continued)

Effective January 1, 2009, the IRS issued final regulations for purposes of determining common control for qualified retirement plans sponsored by tax-exempt organizations. In general, tax exempt entities that are under common control are treated as one entity for certain of the requirements of qualified plans. The regulations determine control based on facts and circumstances; for this purpose, common control would exist if, among other situations, at least 80% of the directors or trustees of one organization were either representatives of, or directly or indirectly controlled by, another organization. These regulations could have an effect on the operations of the Plan and the responsibilities of those entities for associated liabilities, such as Silvercrest acting as the Plan sponsor, although such effects are uncertain at this time.

10. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the accompanying financial statements were available to be issued. No subsequent events have occurred that require disclosure in, or adjustment to, the accompanying financial statements.
