## **Independent Auditor's Report**

To the Plan Administrator and Board of Trustees  
Alphacoin 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Alphacoin 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alphacoin 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of Alphacoin 401(k) Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

Alphacoin 401(k) Plan has not maintained sufficient accounting records and supporting documents related to prior years. Because of inadequacies in the plan's prior years' records regarding historical deferral rates, we were unable to perform auditing procedures with respect to individual participant's contribution allocations for 2020 nor their account balances accumulated from inception of the plan or to satisfy ourselves as to the basis on which participants' accounts are stated as of December 31, 2024 and 2023.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alphacoin 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


### ***Auditor's Responsibilities for the Audit of the Financial Statements***

### 1. DESCRIPTION OF PLAN

The following description of the Alphacoin 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan, as recently amended and restated on April 1, 2023, is a defined contribution plan established on January 1, 1995, covering eligible employees, as defined by the plan document, of Alphacoin (the plan sponsor).

The plan sponsor merged another plan of its affiliate into the Plan during August 2022, and most of the other plan's assets were rolled over to John Hancock Life Insurance Company of New York (John Hancock). Remaining assets were held at Principal Life Insurance Company (Principal). Collectively, John Hancock and Principal (the Custodians) serve as the custodians of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC), as amended. The board of trustees is responsible for oversight of the Plan.

**Eligibility** - All employees, excluding members of union employees and nonresident aliens, are eligible to participate in the Plan upon the attainment of age 21 and the completion of 6 months of eligibility service. An eligible employee becomes a participant on the entry date coincident with or following the satisfaction of the eligibility requirements, provided that he or she is still an eligible employee as of such date. The plan entry date is quarterly starting on the first day of the plan year, coinciding with or next following the date such requirements are satisfied. As employees become eligible, they are automatically set-up with an account on John Hancock. The employees are afforded the opportunity to contribute to their account as of their eligibility date, and the plan sponsor contributes the safe harbor to all eligible employees.

The Plan does not include an auto-enrollment provision.

**Contributions** - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the IRC. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are invested in various investment options as directed by the participants.

The Plan provides for a safe harbor nonelective contribution for eligible employees. The safe harbor nonelective contributions are equal to 3 percent of an employee's eligible compensation, as defined in the plan document.

**Participant accounts** - Each participant's account is credited with their elective contributions, the plan sponsor's safe harbor nonelective contributions, and plan earnings on such contributions and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled to is represented by the vested balance in the participant's account. Upon enrollment in the Plan, and anytime thereafter, a participant may elect from among several investment vehicles offered by the Plan to which contributions on their behalf shall be directed.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. The plan sponsor's discretionary matching and profit-sharing contributions are subject to a graduated vesting schedule whereby an employee vests 20 percent each year after two years of vesting service until year six, when they become fully vested. Participants also become 100 percent vested upon retirement, early retirement, death or permanent disability.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of a) \$50,000 or b) 50 percent of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar loans. Principal and interest are paid ratably through payroll deductions. Participant loans generally must be fully repaid within five years. Participants can have no more than one loan outstanding at any given time.

**Payment of benefits** - Upon termination of service due to death, disability or retirement, a participant or a participant's beneficiary may elect to receive 100 percent of the participant's vested interest in his or her account balance in a lump sum amount.

**Hardship withdrawals** - The Plan provides for withdrawal of funds from a participant's individual account for the purpose of relieving financial hardship subject to the Plan's rules as outlined in the summary plan description.

**Forfeited accounts** - Forfeitures of the non-vested portion of terminated participants' accounts are used by the plan sponsor to offset employer contributions, pay for the Plan's administrative expenses or restore forfeited account balances of rehired employee. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,404 and \$12,324, respectively. In 2024, \$2,920 from forfeited nonvested accounts was properly distributed to restore account balances that had been incorrectly forfeited, in accordance with the provisions of the Plan.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimates.

**Investment valuation and income recognition** - The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investment in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute to fully benefit-responsive investment contracts. The contract value is the relevant measurement since it represents the amount that the participant would receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. As of December 31, 2024 and 2023, participants defaulted on loans amounting to \$3,452 and \$925, respectively. The Custodians have issued 1099s to report the income generated from the defaulted loan balances to the participants.

**Benefits paid to participants** - Benefits are recorded when paid.

**Plan expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements. Transaction fees for loan transactions are paid by the participants by reducing the account balances of those participants initiating the transactions. Investment-related expenses are netted against "Net appreciation in fair value of investments."

**Subsequent events** - Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the net asset value (NAV) of such pooled accounts held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although they are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy.

### 4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the plan documents (including complete or partial plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or
4. a material amendment to the agreement without the consent of the issuer.

### **5. INFORMATION CERTIFIED BY CUSTODIANS**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock and Principal, the Custodians of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by the trustees, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan.

### **7. PLAN TERMINATION**

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their employer contributions.

### **8. TAX STATUS**

The Plan operates under a prototype plan document sponsored by Datair Employee Benefit Systems Inc., who received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, which stated that the prototype document satisfied the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since the determination letter was received for the prototype plan. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

### **10. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the plan sponsor did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified in Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, which totaled \$5,725, were pending correction in 2024. The plan sponsor will be compensating participants for lost earnings resulting from the delay in contributions.

### **11. ACCOUNTING AND PAYROLL RECORDS**

Various accounting and payroll records relating to the year ended December 31, 2020 and prior periods were not adequately maintained by the Plan. Due to these recordkeeping deficiencies, we were unable to perform sufficient audit procedures to verify individual participant account balances accumulated since the Plan's inception. Accordingly, the financial statements have been prepared based on the available records analyzed by plan management. As certain historical records were not available from the inception of the Plan, we were unable to determine the potential impact, if any, on the completeness and accuracy of the Plan's financial statements.
