Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The following description of the Collins Medical Associates 2, P.C. 401(k) Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the Plan Document for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan is a defined contribution plan which covers all eligible (as defined in the Plan document) employees of Collins Medical Associates, 2 P.C. (the Company or Plan Sponsor).

The Plan Sponsor's Operations Committee has overall responsibility for the operation and administration of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan Sponsor is responsible for the general administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Reliance Trust Company was the trustee for the Plan for the period January 1, 2023 through June 30, 2024 and Transamerica Trust Company was the trustee for the period from July 1, 2024 through December 31, 2024.

Eligibility

Employees become eligible to participate for purposes of salary deferrals and safe harbor matching contributions on their date of hire with no service or age requirements.

Contributions

Each year, participants may contribute a portion of their pretax annual compensation not to exceed the individual deferral dollar limit in accordance Internal Revenue Code (IRC). The maximum allowable contribution for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as prescribed by the IRC. The maximum allowable catch-up contribution for 2024 and 2023 was \$7,500. Participants direct their elective contributions and the Company's contributions into various investment options offered by the Plan and may change their investment options on a daily basis.

The Company makes a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation as defined by the Plan. For purposes of calculating the safe harbor matching contribution, compensation and deferrals are determined on an annual basis.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Contributions (continued)

The Company may also make a discretionary profit-sharing contribution in an amount determined annually by the Operations Committee. The Company elected to make a one-time discretionary profit-sharing contribution to all employees as of the end of the 2024 and 2023 plan years. The Operating Committee determines each participant's profit-sharing contribution subject to non-discrimination testing. The contribution for all shareholder and non-shareholders employees was 9.00% and 3.00% of eligible compensation, respectively, for 2024 and 7.62% and 3.00% of eligible compensation, respectively, for 2023. For the years ended December 31, 2024 and 2023, the Plan recorded the profit-sharing contribution as a receivable in the amount of \$648,113 and \$625,000, respectively.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, employer matching contributions, safe harbor matching contributions, and discretionary profit-sharing contributions, plus actual earnings thereon upon entering the Plan.

Participant Accounts

Participants direct their individual contributions to any of various mutual funds and stable value fund investment options offered by the Plan. Each participant's account is credited with any elective participant contributions, employer matching contributions, as defined, an allocation of Plan earnings (losses), and an allocation of administrative expenses. Allocations are based on methods as defined in the Plan agreement. A participant's benefit is equal to that amount that can be provided from the participant's vested account.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement or termination, subject to certain requirements of the Plan, a participant may elect to receive a single lump-sum payment, installment payments, annuity payments or a direct rollover. If the value of the vested account balance does not exceed \$5,000, then a distribution will be made regardless of the participant's election.

Withdrawals from a participant's salary deferral account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

Participants who are at least 59½ years of age or disabled may withdraw all or a portion of their salary deferral and vested employer matching account balances prior to termination.

1. Description of the Plan (continued)

Notes Receivable from Participants

Participants may apply for loans from the Plan. The loans must be approved by the Plan Administrator and are subject to various terms. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum number of Plan loans that a participant may have outstanding at any one time is two. Loans bear interest at 1% above the prime rate. Loan terms currently permitted range from 1 to 5 years but may be increased if the loan is used for the purchase of a primary residence. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through monthly payroll deductions. For the year ended December 31, 2024 interest rates on loans outstanding ranged from 4.25% to 9.5%.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Certain mutual funds offered by the Plan invest in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than similar types of securities in comparable U.S. companies.

Notes Receivable from Participants

Notes receivable from participants are valued at their outstanding balances, plus accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) in fair value of mutual funds.

3. Information Prepared and Certified by Trustees

Information presented in the accompanying statements as of and for the years ended December 31, 2024 and 2023, for investments, net appreciation (depreciation) and investment income was derived, without audit, from information certified to be complete and accurate by Reliance Trust Company and Transamerica Trust Company, the trustees of the Plan, as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

The Plan follows FASB ASC 820, Fair Value Measurement and Disclosures (ASC 820), for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

In addition to defining fair value, ASC 820 requires disclosures around fair value and establishes a fair value hierarchy for valuation inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety.

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs are based upon unadjusted quoted prices for identical instruments traded in active markets.

Level 2 - Inputs are based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The fair values are therefore determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

4. Fair Value Measurements (continued)

The assets or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's mutual funds are stated at fair value, which is based on quoted market prices in an active market.

The Plan's investment in the Putnam Stable Value Fund is a common collective trust valued at NAV per unit, as determined by the external fund manager at year-end. The NAV is used as the practical expedient to estimate fair value.

5. Income Tax Status

The Plan has adopted a prototype plan sponsored by Pension Consultants, Inc. The prototype plan obtained its latest determination letter on March 15, 2021, in which the Internal Revenue Service (IRS) stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

6. Party-In-Interest and Related Party Transactions

Plan investments in certain mutual funds and the stable value fund were held and managed by the trustees and were considered exempt party-in-interest transactions. As described in Note 2, the Company paid certain expenses related to plan operations and investment activity to various service providers. In addition, the Plan allows participants to take loans against their account balances. These transactions are also considered party-in-interest transactions under ERISA and are exempt from the prohibited transaction rules.

7. Plan Termination

The Plan Sponsor reserves the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan available after payment of any Plan expenses shall be distributed to the participants in accordance with the value of their accounts as of the date of termination.

8. Subsequent Events

Events subsequent to December 31, 2024 have been evaluated through October 15, 2025, the date that the financial statements were available to be issued.
