## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Women's Healthcare Associates, LLC 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of Women's Healthcare Associates, LLC 401(k) and Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established April 1, 2000 and maintained for the benefit of eligible employees of Women's Healthcare Associates, LLC (the Company). Employees are eligible to participate in the Plan after they have attained age 18 and are not covered by a collective bargaining agreement. Employees are eligible to participate in the Plan, make deferral contributions and receive safe-harbor employer contributions after three months of service. Employees become eligible to receive profit sharing contributions and employer matching contributions after completing six months of service. The Plan's trustees and the Plan administrator are also plan participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** - Effective November 15, 2023, the Plan adopted several SECURE Act 2.0 features. These include, increasing the limit of account balances between \$1,000 and \$5,000 that will be automatically transferred to an IRA, at the discretion of the Company, from \$5,000 to \$7,000, adding the ability for participants to receive a penalty free in-service distribution up to \$10,000 if the participant is the victim of domestic abuse, adding relief from top-heavy rules for defined contribution plans having early eligibility, allowing Roth balances to not be included when calculating required minimum distributions and allowing surviving spouse elections to be treated as an employee for required minimum distributions. The Plan has not yet been amended for these features and is in process of formally amending the Plan document by the required due date as required for the SECURE 2.0 provisions.

**Contributions** - Contributions consist of employee elective deferral contributions, Roth 401(k) contributions, employer matching contributions, non-discretionary safe-harbor employer contributions, and discretionary non-elective employer contributions. Employee elective deferrals and employer matching contributions are recorded in the year in which the contributions are withheld from compensation. The amount of employer matching contributions and discretionary non-elective employer contributions are determined annually by the Company's Management Committee. Matching contributions may not exceed 4% of eligible compensation or 6% of the participant's elective deferral. Employees may voluntarily contribute up to 100% of their eligible compensation limited to \$23,000 in 2024 and \$22,500 in 2023, respectively, as prescribed by the Internal Revenue Code (IRC), along with annual catch-up contributions for participants age 50 and over. Catch-up contributions are not eligible for matching contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Contributions are subject to certain limitations as prescribed by the IRC.

The Company made a discretionary non-elective contribution of \$1,465,749 and \$1,573,066 for 2024 and 2023, respectively. In 2024 and 2023, the Company made non-discretionary safe-harbor contributions of 3% of eligible wages. No matching contributions were made in 2024 or 2023.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, all employer contributions, and an allocation of plan earnings. Allocation of plan earnings and expenses is based upon participant account balances. Allocation of matching contributions is based on participants' contributions. Allocation of discretionary non-elective contributions is based on a participant's eligible compensation in relation to total eligible compensation using a formula integrated with the Social Security wage base. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are fully vested in their voluntary and rollover contributions, the employer non-discretionary safe-harbor contributions, and actual earnings thereon. The employer matching contributions and employer's discretionary non-elective contributions credited to participants' accounts become vested and nonforfeitable 20% after one year (or 1,000 hours) of service and 20% annually thereafter, until 100% vested after five years of service. Participants are 100% vested upon death, total and permanent disability or after attaining normal retirement age.

**Expenses** - Administrative costs not paid by the Company are charged to participants' accounts. Certain expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administration and clerical personnel are provided by the Company without charge to the Plan. Administrative and investment expenses not paid by the Company are satisfied in part through fees received by the Plan through revenue sharing with various mutual funds and the remainder charged to participant accounts based upon relative account values on a monthly basis. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant's account and are included in administrative expenses.

**Payment of Benefits** - On termination of service, retirement, permanent disability or death, a participant will be paid a lump sum amount equal to the vested value of his or her account. The Plan further provides for hardship distributions and participant loans. Participants may request a hardship distribution of their account balance attributable to their elective deferral contributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs. If a participant's vested account exceeds \$1,000 and is not more than \$7,000 upon termination of employment, the plan administrator will automatically rollover the entire vested interest to an individual retirement account (IRA), unless otherwise directed by the participant. If a participant's vested account is \$1,000 or less upon termination of employment, the entire vested interest will be distributed in a lump sum payment to the participant, unless otherwise directed.

**Forfeitures** - The balances of terminated participants' nonvested accounts are forfeited and may be used to reduce employer matching contributions, reduce employer discretionary non-elective contributions, and reduce Plan expenses. At December 31, 2024 and 2023, the balance of forfeited nonvested accounts totaled \$32,229 and \$60,123, respectively. Forfeitures of \$60,123 and \$43,787 were used to reduce employer discretionary non-elective contributions in 2024 and 2023, respectively. No forfeitures were used to reduce Plan administrative fees in 2024 and 2023.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for the benefit-responsive investment contract, which is carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. There were no amounts payable to participants at December 31, 2024 and 2023, respectively.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

## NOTE 3 – NOTES RECEIVABLE FROM PARTICIPANTS

The Plan makes loans to participants based on their vested account balance. The minimum loan amount is \$1,000 and is limited to 50% of their vested account balance or \$50,000, whichever is less. Loans are payable within five years through at least quarterly payroll deductions, unless the loan is used to acquire a primary residence. Interest is charged at the *Wall Street Journal* prime rate plus 2%. The rate of interest on outstanding loans ranged from 5.25% to 10.50% at December 31, 2024. Loans are secured by the vested account balance of the participant.

## **NOTE 4 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive, group annuity contract with Standard Insurance Company (the Issuer). The Issuer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of a contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the Issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Contract value is the relevant measurement attributable for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the Issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan's ability to receive amounts due is dependent on the Issuer's ability to meet its financial obligations. The Issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include, but are not limited to layoffs, Plan termination, business closings, re-organizations, liquidations and the failure of the Plan to qualify under Section 401(a) or Section 401(k) of the IRC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the Issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an unsecured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment of the agreement without the consent of the Issuer.

The group annuity contract does not permit the Issuer to terminate the agreement prior to the scheduled maturity date. The average yield earned based on the change in the net asset value between the beginning and the end of the year was 3.08% and 2.80% for the years ended December 31, 2024 and 2023, respectively. The average yield earned with an adjustment to reflect the actual interest rate credited to participants was 3.08% and 2.80% for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 6 – INFORMATION CERTIFIED BY THE CUSTODIANS OF THE PLAN**

Certain information related to investments at fair value, the investment at contract value and non interest-bearing cash, as disclosed in the accompanying financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank and Standard Insurance Company, the custodians of the Plan.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested.

#### **NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were shares of mutual funds managed by Charles Schwab Trust Bank or The Standard Insurance Company, or an affiliate of the custodians, and therefore, these investments represented exempt party-in-interest transactions. Fees for investment management services charged by the custodians or an affiliate of the custodians are netted against plan earnings and range from 0.0125% up to 0.10% of the average daily balances.

#### **NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participants' account balances. There were two and one investment that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

**NOTE 10 – INCOME TAX STATUS**

The Plan document, a non-standardized pre-approved profit sharing Plan sponsored by CCH Inc. dba ftwilliam.com, obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.

**NOTE 12 – PROHIBITED TRANSACTIONS**

During 2024, elective deferrals and loan repayments withheld from employee’s payroll totaling \$87,784, were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrence and is in the process of taking the appropriate steps to correct the situation.
