Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about **Brown Wilbert, Inc. Profit Sharing Plan and Trust's** ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTE 1**      **DESCRIPTION OF PLAN**

The following brief description of **Brown Wilbert, Inc. Profit Sharing Plan and Trust** (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

**1.      General**

The Plan is a defined contribution plan covering all employees of Brown Wilbert, Inc. (the Company) except some union employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the administrator and sponsor of the Plan and has appointed the owner of the Company as the Trustee of the Plan and Empower Trust Company, LLC and Voya Retirement Insurance and Annuity Company as the custodian and recordkeeper of the Plan.

**2.      Eligibility**

Employees are eligible to participate in the salary deferral portion of the Plan upon completion of two months of service. Employees are eligible to participate for purpose of matching and profit sharing contributions upon the completion of one year of service. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service.

**3.      Entry date**

Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

**4.      Contributions**

Each year, participants may make contributions of the pretax annual compensation, as defined in the Plan. There are no Plan imposed limits on the amount that participants may defer. However, contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Additional matching contributions and profit sharing amounts may be contributed at the discretion of the Company's management. For the years ended **December 31, 2024** and 2023, the Company made a discretionary match contribution which contributed 100% of the first 3% of base contribution that a participant contributed to the Plan for specified employees. The amount of the Company match was **\$7,447** and \$6,679 for the years ended **December 31, 2024** and 2023, respectively. No additional discretionary profit sharing contributions were made for the years ended **December 31, 2024** and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)**

**5.      Investment Options**

Upon enrollment into the Plan, a participant may direct employee and Company contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

**6.      Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution; (b) Plan earnings; and, (c) forfeitures of terminated participants' earnings or account balances. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**7.      Vesting**

Participants are immediately vested 100 percent in their salary reduction (pre-tax and Roth), catch-up, and rollover contributions. Vesting for Company match contributions is based on years of continuous service. A year of service is defined as a Plan year in which the employee works at least 1,000 hours. A participant is 100 percent vested after six years of credited service.

**8.      Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested interest in the Plan or \$50,000, whichever is less. The loans are secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates at the time funds are borrowed, as determined quarterly by the Plan administrator, generally prime plus 2%. All remaining loans have an interest rate of 10.5%. Principal and interest is paid ratably through payroll deductions over a period not to exceed 5 years, unless the proceeds were used to acquire the participant's residence, in which case the loan may be longer. A participant may have no more than two outstanding loans at any time.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)****9.      Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments as defined in the Plan document. An active participant is allowed to receive a distribution from the Plan prior to termination of employment provided they have obtained age 59 1/2, have reached normal retirement age, or in the event of a qualified hardship event, as defined in the Plan document. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. In the event of termination of employment (other than for death, disability, or retirement after age 65), participants are entitled to all of the elective deferral account balance and their vested percentage of their matching contributions and nonelective employer contribution account balances.

**10.     Forfeited Accounts**

Forfeitures will be used to reduce Plan expenses or future Company contributions. For the years ended **December 31, 2024** and 2023, forfeited nonvested accounts totaled **\$1,773** and \$582, respectively. During the years ended **December 31, 2024** and 2023, forfeitures of **\$0** and \$0, respectively were used to reduce Plan expenses.

**11.     Death Benefits**

The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

**12.     Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at anytime and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES  
AND USE OF ACCOUNTING ESTIMATES****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Accounting Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

AND USE OF ACCOUNTING ESTIMATES (CONTINUED)****Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the Net Assets Available for Benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of **December 31, 2024** and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution and not accrued upon termination of employment.

**NOTE 3      FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)**

- Level 2      Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

**Level 1 Fair Value Measurements**

The fair value of mutual funds and common collective trusts is based on quoted net asset values of the shares held by the Plan at year-end.

Common collective trusts are valued at the respective NAV as reported by such trusts/funds, which are reported at fair value. The value of each unit is determined by subtracting total liabilities from the total value of the assets, including accrued income, and dividing the amount remaining by the number of units outstanding on the valuation date. The NAV is a quoted price in a market that is active and classified within Level 1 of the valuation hierarchy. Participant transactions (purchases and sales) may occur daily.

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

**NOTE 4 RELATED PARTY TRANSACTIONS**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investment options are investments offered by the Custodian of the Plan. Additionally, fees incurred by the Plan for investment manager services are included in administrative expenses for the audit periods. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 5 PLAN EXPENSES**

Certain administrative expenses of the Plan are paid by the Plan's sponsor as provided in the Plan document.

**December 31, 2024** and 2023**NOTE 6**      **TAX STATUS**

The Plan uses a volume submitter Plan document sponsored by Tax Sheltered Compensation, Inc., who received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated the volume submitted document satisfies applicable regulations of the Internal Revenue Code (IRC). The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

US GAAP requires the Company to evaluate tax positions taken by the Plan. The effects of an uncertain tax position are recognized in the financial statements when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of **December 31, 2024** and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 7**      **INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income and Security Act of 1974. Accordingly, the Custodians (Empower Trust Company and Voya Retirement Insurance and Annuity Company) have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of **December 31, 2024** and 2023 and the supplementary Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of **December 31, 2024** and 2023, and investment income and interest income on notes receivable from participants reported in the accompanying Statements of Changes in Net Assets Available for Benefits for the years ended **December 31, 2024** and 2023.

**NOTE 8**      **INSURANCE CONTRACTS WITH INSURANCE COMPANIES**

The Plan has a fully benefit-responsive insurance contract with Empower as of and for the years ended **December 31, 2024** and 2023. The Plan also has a fully benefit-responsive insurance contract with Voya for the year ended **December 31, 2024**. The Custodians maintain the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance contracts are included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Custodian insurance contracts have certain restrictions that impact the ability of the Plan to collect the full contract value. Such events include contract termination. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

**NOTE 8    INSURANCE CONTRACTS WITH INSURANCE COMPANIES (CONTINUED)**

Either party to the insurance contracts may terminate the contract with at least 60 days advance written notice to the other party. The contract may also be terminated due to a termination of the Plan.

The Custodians are contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rating, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

**NOTE 9        RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market conditions, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan had investments of **\$4,333,608** and \$4,113,314 that were concentrated in **eight** and three funds at **December 31, 2024** and 2023, respectively.

**NOTE 10        RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Certain amounts reported in the financial statements are different from the amounts reported in Form 5500. These differences are as follows:

In the current year, a defaulted loan was deemed distributed for financial statement purposes, but not on the Form 5500. During the current year, a deemed distributed loan from the prior year (which was recognized as distributed for financial statement purposes, but not on the Form 5500) was distributed and recognized on the Form 5500. Additionally, accrued expenses were recognized on the financial statement, but not on the form 5500 for the current year ended.
