NOTE A – DESCRIPTION OF THE PLAN

The following description of Financial Designs, Inc. (“Company”) 401(k) Profit Sharing Plan & Trust (“Plan”) is provided for general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan covering employees of the Company who are aged twenty-one or older and have completed three months of eligible service. Entry dates into the plan are allowed once monthly, following the date such employee meets the eligibility requirements. The Plan is sponsored by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Participants may contribute up to 100% of their annual eligible compensation, as defined in the Plan document, to the Plan up to \$ 23,000 and \$22,500 for the plan years ended 2024 and 2023, respectively. Participants 50 years of age or older may contribute up to \$30,500 and \$30,000 of their annual eligible compensation, as defined in the Plan document, to the Plan for the years ended 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). During the years ended December 31, 2024 and 2023, the employer elected to make discretionary voluntary contributions to the Plan of \$53,121 and \$47,562. The employer contributes 25% of the first 2% of employee contributions.

3. Participants’ Accounts

Each participant’s account is credited with their employee deferrals and an allocation of the participant’s earnings in their self-directed accounts. Profit sharing contributions are allocated to participant’s accounts in the same ratio as each participant’s compensation bears to the total of all participants’ compensation.

NOTE A – DESCRIPTION OF PLAN - CONTINUED

4. Participant Loans

Participants are entitled to borrow from the Plan up to the lesser of \$50,000 or 50% of their vested account balance at a rate equal to one that a bank or other professional lender would charge for making a loan in a similar circumstance. Funds borrowed from the plan as well as the applicable interest are repaid by payroll deductions over a period no longer than five years and are secured by the participant's vested account balance.

5. Vesting

Participants are immediately vested in their voluntary employee deferrals plus earnings in their self-directed accounts. Participants are 20% vested in voluntary employee contributions after two years. Each following year, the participant vests an additional 20%, until being fully vested after six years.

6. Investment Options

Upon enrollment in the Plan, a participant is permitted to self-direct employee contributions in any of the designated investment options that are available under the Plan.

7. Payment of Benefits

Upon retirement, death or disability, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account balance, periodic installments of the vested account balance over a period of years, or payments of the vested account balance made over the participant's life expectancy. In service withdrawals of the participant's entire vested account balance are allowed to participants who reach age 59 1/2 without terminating employment. If a participant's account balance is less than \$5,000, a single lump sum payment is required.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with generally accepted accounting principles. Investments held by defined contribution plans are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. Investment Valuation

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation involves the plan's gains and losses on investments bought and sold as well as held during the year.

The Voya Fixed fund has investments in a fully benefit-responsive investment contract and is reported at contract value. Please refer to Note F for the contract value disclosure regarding this Plan investment.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

4. Payment of Benefits

Benefits are recorded when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at period end, if any. At December 31, 2024 and 2023, no terminated participants had amounts payable.

5. Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation of the fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

6. Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Subject to the provisions of the Plan, a participant may borrow against his/her account balances provided that the amount requested is at least \$1,000 but not more than the lesser of 50% of the vested balance or \$50,000.

Each loan will bear a reasonable rate of interest as prescribed by the Plan's provisions. The interest rate must be one a bank or other professional lender would charge for making a loan in similar circumstance. The rate earned as of December 31, 2024 and 2023 was 8.50% and 3.25% for loans recorded during these periods, respectively.

If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, a deemed distribution is recorded, which is a taxable event for the participant. A loan offset is recorded to reduce the participant's account balance by the outstanding amount of the loan when the loan has been determined to be in default and the participant account incurs a distributable event as defined in the Plan agreement.

6. Notes Receivable from Participants- continued

The notes receivable from participants are secured by the vested account balances of the borrowing participants. No allowance for credit losses was recorded as of December 31, 2024 and 2023.

7. Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,661 and \$2,176, respectively. These accounts will be used to reduce future plan expenses.

8. Subsequent Events

The plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. No such significant events or transactions were identified.

NOTE C – FINANCIAL INFORMATION CERTIFIED BY INSURANCE COMPANIES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Voya Retirement Insurance and Annuity Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits, the supplemental Schedules H, Part IV, Line 4i – Schedule of Assets Held at End of Year, the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the net appreciation in value of investments and interest income on notes receivable for participants for the years ended December 31, 2024 and 2023.

NOTE D – INCOME TAX STATUS

The Internal Revenue Service (IRS) has opined that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to income tax under present income tax laws. The Plan has been amended since receiving its original determination letter from the IRS.

NOTE D – INCOME TAX STATUS – CONTINUED

The Plan has received subsequent determination letters covering any new amendments except for amendments incorporating IRS pre-approved language for which determination letter requests were not required. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the net assets of the Plan must be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

NOTE F – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has investments in fully benefit-responsive investment contracts. The contract value of the Voya Fixed fund at December 31, 2024 and 2023 was \$423,204 and \$403,872, respectively. Voya Retirement and Insurance Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE F – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES – CONTINUED

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value due to credit risk of the contract issuer or otherwise.

The average yield and crediting interest rates for 2024 and 2023 was approximately 1.46% and 1.38%, respectively. The credited interest rate is based on a formula that is revised quarterly.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The Plan Administrator does not believe there exists the occurrence of an event which would limit the Plan's ability to transact at contract value with participants.

NOTE G – PLAN SPONSOR

The Plan sponsor is Financial Designs, Inc.

NOTE H – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value of hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

NOTE I – RISKS AND UNCERTAINTIES

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE J – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Voya Retirement Insurance and Annuity Company acts as trustee of the Plan assets and administers the assets and the income therefrom and Voya Retirement Insurance and Annuity Company also provides accounting and record-keeping services for individual plan participants' accounts and processes and distributes fund transfers and withdrawals based on information provided by the Company. The Plan assets at December 31, 2024 and 2023 include investments in mutual funds managed by Voya Retirement Insurance and Annuity Company, and therefore, the related transactions qualify as party-in-interest.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.
