## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of  
Midway/Parkway 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Midway/Parkway 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

### Basis for Opinion on the 2024 Financial Statements

#### 1. DESCRIPTION OF THE PLAN

The following description of the Midway/Parkway 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan established on October 1, 1996, and covers all eligible employees of Midway Holdings, LP, Parkway Ventures, LLC and affiliated employers (collectively, the "Company"). The Plan was recently amended and restated effective January 1, 2024, which changed the employer match formula. The Plan is administered by the Company which is responsible for oversight of the Plan. Voya Retirement Insurance and Annuity Company ("Voya") is the custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

##### **Eligibility**

Employees who have completed six months of service and attained 21 years of age are eligible for the Plan. Participants may participate on the first of the month once eligibility requirements are met. Employees of R&D KH, LLC and Midway PSG, LLC, union employees, nonresident aliens, and leased employees are excluded.

##### **Contributions**

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan Document, on a pretax or after-tax basis. Pre-tax contributions and after-tax contributions shall not exceed certain limits set forth by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes employer safe harbor matching contributions as defined in the Plan Document. For the year ended December 31, 2024, the Company contributed employer safe harbor matching contributions to the Plan equal to 100% of the first 4% and 50% of the next 2% of participant's compensation contributed to the Plan. Annually, a true up contribution is made for the safe harbor matching contributions. The Company may also make discretionary profit sharing and additional matching contributions. There were no discretionary profit-sharing contributions or additional matching contributions made during 2024.

A participant who receives a qualifying distribution from a former employer's retirement savings plan may contribute the distribution to the Plan as a rollover contribution.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, rollover contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions as well as the employer's contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, a guaranteed investment contract with Voya and self-directed brokerage accounts with Charles Schwab & Co., Inc. as investment options for participants.

##### **Vesting**

Participants are immediately vested in their contributions, employer safe harbor matching contributions and rollovers plus actual earnings thereon. Participants become 20% vested in their discretionary employer contributions after two years of service, with an additional 20% vesting each subsequent year and are 100% vested after six years of service.

#### **Forfeitures**

Forfeitures are used to reduce future employer contributions and to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,158 and \$889, respectively. For the year ended December 31, 2024, forfeitures of \$2,867 were used for Plan expenses.

#### **Payment of Benefits**

Upon termination of employment, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. If the value of the participant's vested account balance is less than \$5,000, the Company is allowed to distribute the entire vested account balance out of the Plan. If the value of the participant's vested account balance is more than \$1,000 but less than \$5,000 and the participant does not consent to a lump sum distribution, the account balance will be distributed to an individual retirement account for the benefit of the participant at the direction of the Company. If the participant's vested account balance is greater than \$5,000, the participant may elect to receive a lump sum distribution, roll the balance into another qualified retirement plan or an individual retirement account, or leave the vested balance in the Plan. In addition, the Plan allows for hardship distributions if certain criteria are met.

## **2. SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, which was the date that the financial statements were available to be issued. See subsequent events disclosed in Note 11.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board's Accounting Standards Codification Topic 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Self-Directed Brokerage Accounts* – These accounts are valued at the daily quoted closing price as reported by individual securities held in the account. Self-directed brokerage accounts allow participants to invest in publicly traded stocks, ETFs, fixed-income securities, mutual funds, and money market funds, which are registered with the Securities and Exchange Commission. These investments are required to publish their daily fair value and to transact at that price and are deemed to be actively traded.

*Pooled Separate Accounts* – Valued at the net asset value (“NAV”) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the accounts less its liability. This practical expedient is not used when it is determined to be probable that the accounts will sell the investment for an amount different from the reported NAV.

**4. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Voya.

**5. INVESTMENT CONTRACT WITH VOYA**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract (the "Contract") with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the Contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Voya. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow Voya to terminate the Contract with the Plan and settle at an amount different from contract value. However, the Company is not aware of the occurrence or likely occurrence of such events in which Voya would terminate the Contract.

**6. TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan with CODA, which obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as designed, was in compliance with the applicable requirements of the IRC. The Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya. Voya is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**9. RISK AND UNCERTAINTIES**

The Plan invests in various pooled separate accounts, a guaranteed investment contract account and self-directed brokerage accounts. Investment securities are exposed to various risks such as interest rate, market and credit risks. Additionally, the value, liquidity and related income of these securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest values. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value in the near term would materially affect the amounts reported in the statements of net assets available for benefits and participants' accounts.

As of December 31, 2024 and 2023, two investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.

**10. PLAN TERMINATION**

Although the Company intends to maintain the Plan indefinitely, the Company may terminate the Plan at any time in its sole discretion. If the Plan is terminated, all amounts credited to participants' accounts will become 100% vested.

**11. SUBSEQUENT EVENTS**

Effective January 31, 2025, the Plan was amended and restated. In connection with the Company's corporate restructuring, certain participating employers are no longer allowed to participate in the Plan and the name of the Plan sponsor was changed to Midway Holdings, LP and Parkway Services, LLC. There were no other significant changes to the provisions or operations of the Plan as a result of this restatement.
