Benefits under the plan are provided by a trust fund. Plan expenses were \$105,632. These expenses included \$5,496 in administrative expenses, \$93,574 in benefits paid to participants and beneficiaries, and \$6,562 in other expenses. A total of 322 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$430,470 as of December 31, 2024, compared to \$254,838 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$175,632. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$281,264, including employee contributions of \$207,462, earnings from investments of \$46,067, and other income of \$27,735.
