Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Proactive MD Management Services 401(k) Profit Sharing Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Note 1—Plan description

The following description of the Proactive MD Management Services 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees of the following (collectively, the “Company”):

- Proactive MD Management Services, LLC;
- Proactive MD GA, LLC;
- Proactive MD SC, PA;
- Proactive MSO, LLC;
- Proactive MD WI, SC;
- Proactive MD KY, PSC;
- Proactive MD OH, LLC;
- Proactive MD MI, PLLC;
- Proactive MD TN, PL;
- Proactive MD OK, LLC;
- Proactive MD LA A Medical Corporation;
- Proactive MD PENN, PC;
- Proactive MD MS, LLC;
- Proactive MD IA, PC;
- Proactive MD TX Professional Corporation;
- Proactive MD NM, LLC;
- Proactive MD FL, LLC
- Proactive MD CO, PC; and
- Proactive MD NC, PC.

Eligibility – Employees of the Company become eligible to participate after attaining the age of 21. The term eligible employee shall not include Union employees, nonresident aliens, and residents of Puerto Rico. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration – The Company is the Plan sponsor and Plan administrator. As of December 31, 2024, the assets of the Plan are held by Reliance Trust Company and Standard Insurance Company, the “qualified institutions” of the Plan. Certain administrative functions are performed by employees of the Company, who receive no compensation from the Plan.

Note 1—Plan description (continued)

Contributions – The Plan allows for pre-tax 401(k) deferrals and Roth 401(k) deferrals. Each year, participants may contribute up to 100% of their pretax and Roth annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contracts as investment options for participants. Participants may change their investment options at any time. The Plan has a fixed matching Company contribution of 100% of the first 1% of base compensation that a participant contributes to the Plan plus 50% of contributions over 1% up to 6% that a participant contributes to the Plan. The fixed matching Company contributions are participant directed as above. The Company may also elect to make nonelective profit

sharing contributions to the Plan. There were no nonelective profit sharing contributions for the year ended December 31, 2024. The Company's nonelective profit-sharing contributions are participant directed as stated above. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts – Each participant's account is credited with the participant's contributions and the Company's contributions and an allocation of (a) the Company's nonelective profit-sharing contribution, (b) Plan earnings or losses, (c) administrative expenses, and (d) participant withdrawals. Allocations are based on participant earnings or account balances, as defined.

Vesting – Participants are vested immediately in their contributions, including rollovers, along with the Company's matching contributions, and actual earnings thereon. Participants are unvested in employer profit sharing contributions, if any, until satisfying the three years of service requirement, at which time they become 100% vested.

Investments Options – Participants direct the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, a participant may elect to receive withdrawals upon reaching the age of 59 ½.

Hardship Distributions – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the IRS determines is deemed an immediate and financial need of the participant. Any distributions will be taken first from the participant's pre-tax deferral account and then from the participant's Roth deferral account.

Forfeitures – Amounts forfeited from a participant's account shall be used to reduce Company contributions, or to pay reasonable Plan expenses. As of December 31, 2024 and 2023, the forfeiture balance was \$9 and \$7, respectively.

Note 1—Plan description (continued)

Notes Receivable from Participants – Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. At December 31, 2024, the interest rate was 3.25% to 8.50% for all outstanding loans.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Risks and Uncertainties – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivable from Participants – Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition – Investments, except for the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are recognized in the period in which they occur. Interest and dividends are recognized in the period earned and realized gains or losses on securities are recorded in the period of sale. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment advisory and management fees are charged to the Plan for investments in mutual funds and are deducted from participant accounts based on Plan investment balances on a quarterly basis. The amount of investment advisory fees for the year totaled \$28,428.

Payment of Benefits – Benefit payments are recorded when paid.

Administrative Expenses – Professional and other fees of the Plan are typically paid by the Company; however, the Plan is allowed to pay for such expenses. For the year ended December 31, 2024, the administrative expenses paid by the Plan were \$73,193. Personnel and facilities of the Company are used by the Plan for its accounting and other activities at no cost to the Plan.

Note 3—Information prepared and certified by the Plan’s qualified institutions (unaudited)

The Plan sponsor has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Standard Insurance Company, the qualified institutions, have certified to the completeness and accuracy of the following data included in the accompanying financial statements.

- Non-interest bearing cash, investments at fair value, fully benefit-responsive investment contract at contract value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, other interest income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

Note 4—Fair value measurements

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability and in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 4—Fair value measurements (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – These investments are public investment vehicles valued using net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Below are the Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels described above as of December 31:

The Plan recognizes transfers between levels as of the actual date of the event or change in circumstances that caused the transfer. There were no transfers between levels during the year ended December 31, 2024.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Note 5—Investment contract with insurance company

The Plan holds a traditional fully benefit-responsive guaranteed investment contracts with Standard Insurance Company (“Standard”) totaling \$779,472 and \$633,391 at December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The crediting rate is declared by Standard on a quarterly basis and is guaranteed to never be below 1% annually. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to giving a 30-day notice.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5—Investment contract with insurance company (continued)

Certain events limit the Plan's ability to transact at contract value with Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with the contract issuer are probable of occurring. The contract can be terminated at any time with written thirty-day notice by either the Plan or the contract issuer for reasons as defined by the contract.

Note 6—Tax status

The Plan adopted a prototype non-standardized profit sharing with a cash or deferred arrangement plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Plan termination

Although the Company intends to maintain the Plan indefinitely, the Company may amend or terminate the Plan at any time in its sole discretion, subject to the provisions of ERISA. If the Plan is terminated, all amounts credited to participants' accounts will become 100% vested.

Note 8—Related party and party-in-interest transactions

Certain expenses are paid to the qualified institution of the Plan for investment management services. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. During 2024, the Plan paid \$48,327 of administrative expenses to the qualified institution.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 9—Nonexempt transactions

During 2024, there were no late remittances identified. During 2023, employee withholdings totaling \$56,717 were not remitted to the Plan with the appropriate time period by the sponsor. This transaction constituted a prohibited transaction as defined by ERISA. The sponsor remitted lost earnings to the Plan in 2024.

Note 10—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of December 31, 2024 through October 8, 2025, which is the date these financial statements were available to be issued.
