### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Club FutureSave Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements

December 31, 2024

### 1. Plan Description

The following description of Club FutureSave Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

#### General

The Plan was adopted on January 1, 1990, as a voluntary employee contribution plan for the benefit of employees of the Automobile Club of Southern California (the Plan Sponsor), its wholly controlled subsidiaries, and certain related employers (collectively, the Company).

The Plan is a defined contribution plan established by the Plan Sponsor under the provision of Section 401(k) of the Internal Revenue Code (IRC). The Plan is administered by the Benefits Administration Committee of the Company. Investment transactions are authorized by the Plan's Financial Committee who are appointed by the Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). T. Rowe Price Trust Company (the Trustee) is responsible for the custody of the Plan's assets.

#### Eligibility

The Plan generally covers all employees of the Company and that are not a member of a collective bargaining unit. There is no waiting period to enroll in the Plan.

#### Participant Contributions

Participants can contribute up to 75% of their pretax or Roth basis annual compensation, as defined in the Plan, subject to an annual dollar limit set by the Internal Revenue Service (IRS) and certain other restrictions and limitations. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Contributions can be stopped as of any payroll period. Contributions can be resumed on the next payroll period, and the contribution percentages can also be changed at any time. Participants may also generally contribute amounts representing distributions from other qualified plans, other than Roth distributions. Participants direct their elective contributions into various investment options offered by the Plan.

## Club FutureSave Plan

### Notes to Financial Statements (continued)

#### 1. Plan Description (continued)

##### Employer Contributions

The Plan provides matching contributions, discretionary matching contributions and true-up matching contributions for eligible employees hired by the Company after one year of service.

For eligible employees (excluding Pleasant Holidays, LLC (PH), Hawaii World LLC (HW), and Tidewater) the employer matching contribution formula is equal to 100% of an employee's deferrals up to 4% of eligible compensation. The employer matching contribution formula for employees of Tidewater is equal to 50% of an employee's deferrals up to 6% of eligible compensation. For the year ended December 31, 2024, the Company contributed matching contributions totaling \$29,555,524 including amounts funded by forfeitures.

Employees of PH and HW are eligible for matching contributions if approved by the board for the fiscal year, although historically it has not been approved. They are also eligible for a discretionary matching contribution, which historically has been equal to 100% of the first 3% of the employee's deferrals. For the year ended December 31, 2024, the Company contributed discretionary matching contributions totaling \$235,747 including amounts funded by forfeitures.

For the year ended December 31, 2024, an additional employer discretionary matching contribution of up to 1% (depending on the employee's deferral percentage) was approved for the employees of the Company totaling \$7,794,995 including amounts funded by forfeitures.

The Plan requires the Company to make a year-end true-up matching contribution to ensure participants have maximized the eligible employer match based on the participants' contributions for the year. For the year ended December 31, 2024, the true-up matching contributions were \$694,371 including amounts funded by forfeitures.

##### Participant Accounts

Individual accounts are maintained for each participant's pretax and/or Roth contributions, rollovers from qualified plans of the participant's previous employers, and Company matching and discretionary contribution balances. Earnings of the various funds are allocated to the participant balances according to the ratio that a participant's account balance in a given fund bears to the total of all account balances in the fund.

### Notes to Financial Statements (continued)

#### 1. Plan Description (continued)

##### Vesting

Participants are immediately vested in their voluntary pretax and Roth contributions. Employer discretionary matching contributions are also immediately vested, except for employees of the Automobile Club of Missouri (ACMO), AAA Northern New England (NNE), PH, and HW, whose discretionary matching contributions are subject to a three-year cliff vesting schedule. Regular matching contributions for all participants are subject to a three-year cliff vesting schedule. However, all participants become fully vested in both employer discretionary and regular matching contributions upon reaching age 65 or in the event of death.

##### Notes Receivable From Participants

Certain participants may generally borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from 1 to 5 years for general notes and up to 15 years for residential notes. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%. Interest rates on notes outstanding at December 31, 2024, ranged between 4.25% and 9.50%. Principal and interest are generally paid ratably through payroll deductions. Participants are allowed to have up to two outstanding notes at a time (one residential and one general note).

##### Payment of Benefits

Upon retirement, attaining age 59½, termination, death, certain hardship cases, or certain qualifying disabilities, participants or their beneficiaries are entitled to receive their vested balances in a lump-sum, installment, or partial withdrawal distribution. If a participant's vested account balance at termination of service is or less than \$7,000, then the balance shall automatically be distributed in the form of a direct rollover to an individual retirement account. If a participant's vested account balance at termination of service is \$7,000 or greater, the participant may defer distribution of their vested account.

##### Forfeitures

Forfeitures result from an employee terminating from the Plan before fully vesting in the Company's matching contributions. Forfeited balances of terminated participant's nonvested accounts are used to reduce future Company contributions. As of December 31, 2024, and 2023, forfeited nonvested accounts totaled \$4,152 and \$14,148 respectively. During the year ended December 31, 2024, forfeitures of \$603,803 were used to reduce employer contributions.

#### **1. Plan Description (continued)**

##### **Administrative Expenses**

Administrative expenses are paid directly by either the Plan Trustee or by the Plan, as defined in the Plan document.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual method of accounting and in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Contributions by the participants and the related employer contributions are recognized in the period the participants' wages are earned. Withdrawals from the Plan for participant distributions are recognized when the amounts are paid to the participant, except for cases where refunds are due to the participants in order for the Plan to conform to IRC provisions. In addition, investment income is recorded when received by the Trustee. The Plan expenses are recorded when incurred.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

Management fees and operating expenses charged to the Plan for its investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

#### **Notes Receivable From Participants**

Participant notes are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administration deems the participant note to be a distribution, the participant note balance is reduced and recorded as a deemed distribution.

#### **Benefits Paid to Participants**

Benefit payments to participants are recorded when paid and are reflected in the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, there were no benefits payable to participants who elected to withdraw from the Plan.

#### **Other Income**

The Trustee receives administrative fees from certain registered investment companies and common trust funds offered under the Plan. The administrative fees received by the Trustee are included in the expense ratios of such investments. The Plan receives Administrative Fee Payments (AFP) from the Trustee for investments offered under the Plan. Once AFP are calculated, any participants invested in the designated funds as of the last day of the quarter will receive, as soon as administratively feasible, credits back to their accounts that are approximately equivalent to the amount of AFP that was received by the Plan for the participant's investment in the designated funds. For the year ended December 31, 2024, AFP of \$1,088,968 is reflected as other income in the accompanying statement of changes in net assets available for benefits.

#### **Risks and Uncertainties**

The Plan provides participants with various investment options. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the

fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### 3. Investments

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024; the related investment activity and interest income on participant notes reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### 4. Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The following are the levels of the hierarchy and a brief description of the type of valuation information (inputs) that qualifies a financial asset for each level:

- **Level 1** – Unadjusted quoted prices for identical assets or liabilities in active markets where the specific security is traded.
- **Level 2** – Inputs other than Level 1 that are based on observable market data. These include: quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets, inputs that are observable that are not prices (such as interest rates, credit risks, etc.), and inputs that are derived from, or corroborated by, observable markets. Financial models are often used to develop these prices.
- **Level 3** – Developed from unobservable data, reflecting the Plan's assumptions.

#### 4. Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for financial assets measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy.

- Common collective trusts are valued at net asset value (NAV) as a practical expedient and therefore are not classified in the hierarchy table.
- Registered investment companies are valued at the quoted daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish daily NAV and transfer at that price. The registered investment companies held by the Plan are deemed to be actively traded.

#### 5. Transactions with Parties-in-Interest

The Plan Trustee is a party-in-interest with respect to the Plan. Certain Plan investments are shares of registered investment companies, or units of common collective trusts, managed by the Trustee or its affiliates. Administrative fees related to the Plan's existence that are paid by the Plan to the Trustee are considered a related-party transaction. Fees paid by the Plan to the Trustee amounted to \$513,523 for the year ended December 31, 2024. Notes receivable from participants and the related interest income of \$2,206,464 for the year ended December 31, 2024 are also considered related-party transactions.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination

would receive distributions of their account balances and become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

#### **7. Tax Status**

The Plan received a determination letter from the IRS dated May 2, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Sponsor believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Subsequent Events**

The Plan management has determined that there were no subsequent events that would require disclosure or adjustments to the accompanying financial statements through October 8, 2025, the date the financial statements were available to be issued.
