Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of Rimkus Consulting Group, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the legal plan document for a more complete description of the plan’s provisions.

General

The Plan is a qualified retirement plan originally effective on January 1, 1992, and amended and restated on March 1, 2023, covering all full-time employees of Rimkus Consulting Group, Inc. and affiliates (collectively the “Company”) to provide them with the opportunity to save for retirement on a tax-advantaged basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

With the exception of part-time, temporary, and seasonal employees, employees of the Company are eligible to participate in the Plan after attainment of age 21 and completion of one month of service. An employee’s entry date will be the first day of the month coinciding with or next following the date they satisfy the age and service requirements.

Contributions

Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed a dollar limit that is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may defer additional amounts as catch-up contributions. Participants may make modifications to or revoke their salary deferral election at any time. The Plan includes an automatic salary deferral feature. The amount to be automatically withheld from a participant’s pay each payroll period is 3% of their compensation. The participant may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer under the Plan.

The Company may make a discretionary matching contribution equal to a percentage of a participant’s salary deferrals. During 2024, the Company matched up to 100% of the participant’s contribution each pay period, up to a maximum of \$200 each pay period. The Company may also make a discretionary profit-sharing contribution to the Plan. During 2024, there were no profit-sharing contributions to the Plan.

A participant is also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, rollovers, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their entire interest in the Plan into investment securities offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed investment contract with the trustee as investment choices for participants.

Vesting

Participants are always 100% vested in their contributions and rollovers plus actual plan earnings thereon. Participants are vested in employer contributions based on years of service.

Participants begin vesting at 25% after one year of service, increasing 25% each year thereafter, with the participant 100% vested after four years.

Notes Receivable from Participants

Loans are available to participants on a reasonably equivalent basis. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum limited to the lesser of \$50,000 reduced by the highest outstanding note receivable balance in the participant's account during the prior one-year period or half of the participant's vested interest in the Plan. Additionally, a participant may not have more than one note receivable outstanding at any time. Note terms may not exceed five years unless the loan is for the purchase of a principal residence. The notes are adequately secured by the balance in the participant's account and charged a reasonable rate of interest.

Payment of Benefits

Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. Benefits under the Plan will generally be paid to participants in cash only. If the value of the participant's vested account balance does not exceed \$7,000, then the vested account balance may only be distributed in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000, the participant may elect to receive a single lump-sum payment, partial withdrawals, or installments.

Participants may be entitled to receive an in-service distribution. Generally, participants may receive a distribution from the Plan for certain accounts prior to their termination of employment provided that have attained age 59½. Participants may also withdraw money for financial hardship if they satisfy certain conditions.

Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,685 and \$133,929, respectively. Also in 2024, employer contributions were reduced by \$254,899 from forfeited non-vested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income and other income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. See Note 11 for discussion of subsequent events.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest and other income for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts - Valued at net asset value ("NAV") of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liability. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV.

5. GROUP ANNUITY CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (“VRIAC”) totaling \$5,591,508 and \$5,629,555 as of December 31, 2024 and 2023, respectively. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. VRIAC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawals or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on VRIAC’s ability to meet its financial obligations. VRIAC’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with VRIAC. Such events include amendments to the plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan’s prohibition on completing investment options or deletion of equity wash options, bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with VRIAC and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow VRIAC to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan’s investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of VRIAC.

6. RELATED PARTY TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by Voya Investment Management Co. and VRIAC. These transactions qualify as party-in-interest transactions. The Plan also engages in transactions with participants related to notes receivable, which are party-in-interest transactions with respect to the Plan. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA.

Voya Financial (“Voya”) provides certain administrative services to the Plan pursuant to a service agreement between the Company and Voya. Voya receives revenue from mutual fund service providers for services Voya provides to the funds. This revenue is used to offset certain amounts owed to Voya for its administrative services to the Plan.

If the revenue received by Voya from such mutual fund service providers exceeds the amount owed under the service agreement, Voya remits the excess to the Plan. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During 2024, there were \$40,801 in excess amounts. The Company may make a payment to Voya for administrative expenses not covered by revenue sharing.

7. TAX STATUS

The Plan adopted a pre-approved plan which obtained its latest opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the pre-approved plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, two investments represented a concentration of greater than 10% of the Plan’s net assets available for benefits.

9. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants’ accounts will become 100% vested. The Company will direct the distribution of participants’ accounts in a manner permitted by the Plan as soon as practicable.
