## Report of Independent Auditors

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Presbyterian Homes & Family Services, Inc. dba HumanKind 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Presbyterian Homes & Family Services, Inc. dba HumanKind 403(b) Plan's financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1 - Description of Plan**

The following description of the Presbyterian Homes & Family Services, Inc. dba HumanKind 403(b) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Presbyterian Homes and Family Services, Inc. (the "Company"). The Plan was established January 1, 1986 to provide certain retirement and other benefits for employees eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The most recent amendment to the plan was effective January 1, 2021.

**Eligibility**

All employees are eligible to participate in the Plan at the entry date coinciding with the beginning of their employment. Employees may begin elective deferrals at their employment start date and may receive employer contributions after one year of employment.

**Contributions**

The Plan provides for both pre-tax and ROTH participant contributions. The Plan requires an automatic deferral arrangement of 3% unless a separate election is made. Eligible employees may contribute a dollar amount or a percentage of annual compensation up to certain limitations in the Internal Revenue Code. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. In addition, the Company may make discretionary matching contributions and nonelective contributions not to exceed the Federal statutory maximum. The Company made 4% discretionary match contributions of \$184,600 and \$173,729 during 2024 and 2023 and 4% nonelective contributions of \$217,804 and \$208,530 in 2024 and 2023, net of forfeitures of \$-0- and \$1,739 during 2024 and 2023.

**Participant accounts**

Each participant's account is credited with (a) the participant's contribution and the Company's contribution and (b) Plan earnings and then charged with an allocation of administrative expenses. Investment earnings are allocated to the account on a daily basis. Certain expenses directly reduce the company's account and other expenses directly reduce the investment earnings that are allocated. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants**

Participants may borrow from their fund accounts up to a maximum equal to fifty percent of their vested account balance or \$50,000, whichever is less. Participants must borrow a minimum of \$1,000. The loans are secured by the participant's vested account balance. The interest rate will be determined on the first business day of each month and apply to all loans applied for in that month. The interest rate will be the current prime rate listed by the trustee plus 1%. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of benefits**

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability, or retirement, as defined in the Plan. In-service distributions are allowed for participants attaining age 65. Up to 100% of the participant's vested account balance can be paid in installment or lump-sum, direct rollover to another qualified plan, or partial withdrawal, with the minimum being \$5,000, to the participant or their beneficiaries. Benefit claims are recorded as deductions when they have been approved for payment and paid by the Plan.

**Vesting**

Participants are immediately 100% vested in the voluntary deferral plus actual earnings thereon. Vesting in the Company's matching and nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

**Forfeitures**

At December 31, 2024 and 2023, the forfeited nonvested account balances were \$2,256 and \$7,281. Forfeitures received in 2024 and 2023 totaled \$28,652 and \$30,923. Forfeiture account balances can be used to reduce employer contributions or administrative expenses or allocated as additional employer contributions. During 2024 and 2023, forfeitures of \$-0- and \$1,739 were used to offset employer contributions and \$33,887 and \$34,370 were used to pay administrative expenses in 2024 and 2023.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States.

**Investment valuation and income**

The Plan's registered investments are stated at fair value as of the last day of the Plan year. During 2024 and 2023, investments are valued based on share values as reported by American Trust Company. During 2024 and 2023, the insurance company generally account is a fully benefit-responsive investment contract and reported at contract value. This contract is credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment, interest and dividend income are recorded on the accrual basis.

As described under FASB ASC 962-325-35 "*Plan Accounting – Defined Contribution Pension Plans*", the Plan values all fully-benefit responsive contracts at fair value, which is contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Notes receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statement of changes of net assets available for benefits.

**Payment of benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Substantially all administrative expenses are paid through forfeitures from participant accounts. Certain transaction fees are paid by the participants.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Concentration of credit risk**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

All of the plan investments are invested in marketable securities, which are subject to the financial risk of the United States financial market.

**Note 3 – Fair value measurements**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Investment in insurance company general account**

The Plan has a benefit-responsive investment contracts in an insurance company general account with Standard Insurance Company called the Standard Stable Asset Fund II. The account is credited with earnings at the rate specified in the contract and charged with the price of annuities when participants retire with any incidental benefits disbursed directly from the account. Because the deposit administration contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the deposit administration contract. The deposit administration contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by American Trust, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$1,466,853 and \$1,226,759, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Interest rates are reviewed quarterly for resetting and ranged from 2.85% to 3.10% during 2024.

Certain events limit the Plan’s ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

**Note 5 – Plan termination**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

**Note 6 – Income tax status**

The Internal Revenue Service is currently not issuing determination letters on 403(b) plans. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 7 – Information prepared and certified by the trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 were obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Company (the trustee of the Plan).

**Note 8 – Party-in-interest transactions**

For the years ending December 31, 2024 and 2023, fees incurred by the Plan for administrator services were paid to American Trust Company, the plan administrator. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these services amounted to approximately \$37,728 and \$35,182. Fees paid to Financial Designs for investment advisory fees were \$16,062 and \$13,523.

The Plan sponsors, owners and key management are also participants in the Plan. Their account balances totaled approximately 12% and 11% of the net assets available for benefits as of December 31, 2024 and 2023, respectively.

**Note 9 – Subsequent events**

The Plan has evaluated subsequent events through October 12, 2025, the date which the report was available for issuance. No other events requiring disclosure have been noted.
