***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of Serena & Lily, Inc. 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Serena & Lily, Inc. 401(k) Plan (the “Plan”) provides only summarized general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Serena & Lily, Inc. 401(k) Plan became effective January 1, 2010, to provide retirement benefits for employees of Serena & Lily, Inc. (the "Plan Sponsor"). The Plan is a defined contribution plan covering all eligible employees. The Plan is designed to comply with Section 401(k) of the Internal Revenue Service Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Newport Trust Company served as the Plan’s trustee and Ascensus Trust Company served as the Plan’s sub-custodian until December 31, 2023. Effective January 1, 2024, ADP Retirement Trust Services, LLC assumed custodial and trustee responsibilities of the Plan. On January 18, 2024, the Plan’s assets were transferred from Ascensus Trust Company to ADP Retirement Trust Services, LLC. In addition, the Plan adopted a new prototype plan as of January 1, 2024, however, there were no significant changes to the provisions of the Plan.

**Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

**Eligibility**

Employees are eligible to participate in the Plan upon attaining 18 years of age. Employees are eligible to receive employer matching contributions and employer profit sharing contributions upon attaining 21 years of age and completion of one year of service. Union employees, nonresident aliens, leased employees, and part-time, temporary and seasonal employees are excluded from participation in the Plan.

**Contributions**

The Plan allows for the following types of contributions:

- **Employee Salary Deferral 401(k) Contributions**  
The Plan includes an automatic elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees are automatically enrolled at a rate of 4% of eligible compensation and may contribute up to 90% of their eligible wages. The automatic deferral amount of 4% is increased by 1% each Plan year after completion of one year of service up to a maximum of 10% of eligible compensation. Employees may affirmatively elect to not have the auto-enrollment and auto-escalation provision apply and/or voluntarily contribute a different percentage of their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code. Participants may make Roth after-tax elective deferral contributions.
- **Employer Discretionary Matching Contributions**  
The Plan Sponsor may make matching contributions equal to a discretionary uniform percentage of a participant’s salary deferrals. The Plan Sponsor elected not to make employer matching contributions to the Plan for the years ended December 31, 2024 and 2023.
- **Employer Discretionary Profit Sharing Contributions**  
The Plan Sponsor may make a discretionary profit sharing contribution in an amount determined by the Plan Sponsor. The Plan Sponsor elected not to make profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

**Contributions (Continued)**

- Employee Rollover Contributions  
Participants may make rollover contributions from another qualified plan.
- Employer Qualified Non-Elective Contributions  
The Plan Sponsor may make corrective contributions to correct for administrative errors and lost earnings. Total corrective contributions were \$0 and \$18,694 in 2024 and 2023, respectively.

**Participant Accounts and Allocations**

The Plan allows participants to self-direct their account balances and contributions among various investment options in their designated accounts. Participants are allowed to direct their investments to a single fund or a combination of funds. Investment earnings and losses are allocated to participants' accounts based on the earnings or losses of the investments selected. Participant accounts may be charged with an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participants vested account balance.

**Vesting**

Participants are always 100% vested in their voluntary salary deferrals and rollover contributions. Employer discretionary contributions and gains/losses credited thereon, vest as follows:

Less than 2 years of credited service	0%
After 2 years of credited service	20%
After 3 years of credited service	40%
After 4 years of credited service	60%
After 5 years of credited service	80%
After 6 years of credited service	100%

For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year.

**Forfeitures**

The Plan Sponsor may use forfeitures to pay Plan expenses or to reduce employer contributions. There were \$2,990 and \$368 in forfeitures available for the reduction of employer contributions at December 31, 2024 and 2023, respectively. Forfeitures were not used during the years ended December 31, 2024 nor 2023.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts. Participants may borrow an amount equal to 50% of the participants' vested account balance up to a maximum of \$50,000. Borrowings bear interest at rates established by the Plan trustee and are due within five years unless the loan is taken for the purchase of a primary residence. Principal and interest are paid through payroll deductions.

**Retirement**

Normal retirement under the Plan is age 65.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment; 3) death or disability; 4) in-service upon attainment of age 59 1/2; or 5) demonstration of financial hardship. Participants' vested accounts that do not exceed \$5,000 shall be distributed upon severance from employment. The manner of distribution is determined by the vested account balance and can either be a lump sum or substantially equal installments.

*NOTE 1: DESCRIPTION OF PLAN (Continued)*

**Administrative Expenses**

Administrative expenses are paid by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

*NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES*

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

Investments in mutual funds and the money market account are stated at fair market value as determined by quoted market prices when available. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Increases in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees charged to the respective participant's account. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases making loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Income Taxes**

The Plan has adopted a volume submitter defined contribution plan which has obtained a favorable opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U. S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEES**

**NOTE 4: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5: FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

**NOTE 5: FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Account:* Underlying short term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

**NOTE 6: PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS**

Fees are paid by the Plan for investment management and recordkeeping services. Notes receivable from participants and fees paid by the Plan for investment management and recordkeeping services qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8: RECONCILIATION TO FORM 5500**
