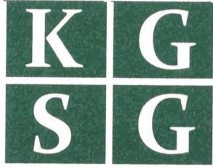

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

(1) DESCRIPTION OF THE PLAN

The following description of the Juniper Health Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Juniper Health, Inc. (the “Company”). Employees may enroll in the Plan on their first day of hire. There are no service or minimum age requirements to enter the Plan.

The Plan is a 403(b) volume-submitter plan sponsored by FIS Business Systems LLC. Broker’s commissions associated with investment transactions and investment management fees are paid by the Plan. The Plan is regularly updated to comply with tax legislation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Each year, participants are able to contribute a percentage of their annual compensation to the Plan, up to the maximum allowable contribution, as defined in Federal legislation. The Plan has an automatic deferral provision equal to 3.00% of the participant’s compensation, unless the employee makes a contrary election or opts out contributing.

Participants who will attain age 50 before the end of the Plan year will be eligible to make additional “catch-up” contributions up to certain tax code limits.

Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Such amounts and any earnings or losses shall be fully vested at all times.

Employer Contributions

At the same time participant contributions are contributed, the employer makes a regular matching contribution to the participant’s account of 100% of the participant’s contribution up to 3.00% of the participant’s compensation.

Any discretionary nonelective contributions will be allocated to eligible employees based on the percentage of the employee’s compensation relative to the total compensation of all participants eligible to share. No discretionary contributions were made by the Company during the Plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, any Company matching contribution, and an allocation of investment earnings based upon the participant’s choice of investment options and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The Plan does not currently allow Participants to borrow from their accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Investment Options

The participants are able to direct the investment of their entire interest in the plan. Various investment choices are available to the participants through Nationwide. If participants do not direct the investment of their account balances, then the account balances are invested in accordance with the default investment alternatives established under the plan.

Payment of Benefits

On termination of service due to death, disability, or normal retirement, a participant or beneficiary will receive his or her account balance in a lump-sum payment in cash. Retiring or disabled participants whose account balances exceed \$5,000 will receive the distribution within a reasonable amount of time after termination. In the event of death, timing of distributions is based on tax law.

On termination of service before normal retirement age, participants will also receive their account balance in a lump-sum payment in cash. Participants whose account balance does not exceed \$5,000 will receive a distribution as soon as administratively feasible following termination of employment.

Forfeited Accounts

Nonvested accounts of terminated employees are used to offset plan expenses or reduce the employer's contributions. Forfeited nonvested accounts totaled \$13,956 and \$12,992 at December 31, 2024 and 2023, respectively. During 2024, \$8,411 in forfeitures were utilized to offset plan expenses or employer contributions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using U.S. generally accepted accounting principles and the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2024 and 2023, the Plan held no contracts that are considered fully benefit-responsive.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.

(3) INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Nationwide (the "Custodian") held the Plan's investment assets as of December 31, 2024 and 2023 and executed investment transactions during the year ended December 31, 2024. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule(s), including investments from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's Trustee.

(4) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

- Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability, d)

inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Obligation Trust - Book value equals fair market value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Juniper Health, Inc., the Plan sponsor, provides to the Plan certain accounting and administrative services for which no fees are charged. Additionally, the Plan sponsor paid fees on behalf of the Plan during the year ending December 31, 2024.

Some of the Plan expenses not paid by the Plan sponsor are offset against investment income (loss) on the Statement of Changes in Net Assets Available For Benefits as follows:

As of December 31, 2024, Nationwide is the Plan's custodian. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$31,014 to Nationwide during the year ending December 31, 2024.

As of December 31, 2024, Proaccount is the Plan's investment advisor. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$923 to Proaccount during the year ending December 31, 2024.

As of December 31, 2024, Retirement Management Services, LLC is the Plan's third party administrator. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$1,350 to Retirement Management Services, LLC during the year ending December 31, 2024.

As of December 31, 2024, Iron-Co-Fid-Flexible Adv Foundations who take on the fiduciary responsibility of selecting and monitoring the funds in the Plan. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$2,144 to Iron-Co-Fid-Flexible Adv Foundations during the year ending December 31, 2024.

As of December 31, 2024, Nationwide Life Insurance Company is the Plan's record keeper. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$536 to Nationwide Life Insurance Company during the year ending December 31, 2024.

As of December 31, 2024, MML Investors Services, LLC. is the Plan's investment advisor. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid indirect fees of \$26,063 to MML Investors Services, LLC. during the year ending December 31, 2024.

In addition, the following Plan expenses were paid by the Plan and are included in the Statement of Changes in Net Assets Available for Benefits as administrative expenses:

As of December 31, 2024, Nationwide Life Insurance Company is the Plan's record keeper. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$5,198 to Nationwide Life Insurance Company during the year ending December 31, 2024.

As of December 31, 2024, Retirement Management Services, LLC is the Plan's third party administrator. Therefore, transactions with them qualify as party-in-interest transactions. The Plan paid direct fees of \$8,411 to Retirement Management Services, LLC during the year ending December 31, 2024.

(6) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) TAX STATUS

The Plan is 403(b) volume submitter plan provided by FIS Business Systems LLC. The Plan provider obtained its latest opinion letter dated March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been preapproved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(8) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
