### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the ALKU 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). - the certified investment information in the supplemental schedules agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the ALKU 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a qualified defined contribution 401(k) plan covering substantially all employees of ALKU, LLC (the “Company” or “Plan Sponsor”) who have 30 days of service and are age 18 (reduced from 21 effective October 1, 2024) or older. Employees are eligible to participate in the Plan beginning on the first day of each quarter after becoming eligible, as defined by the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The plan administrator is responsible for oversight of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. Fidelity Management Trust Company (“Fidelity”) serves as the Plan’s trustee and recordkeeper.

#### *Contributions*

Each year, participants may contribute up to 100% of their annual compensation, as defined by the plan document, on a pre-tax or post-tax (Roth) basis. Participants who are at least age 50 or who will attain age 50 on or before December 31 of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants may direct the investment of their contributions into various investment options offered by the Plan.

At its discretion, the Company may elect to make matching contributions equal to a percentage of eligible participant deferrals or a total dollar amount allocated to participants based on their respective eligible participant deferrals in proportion to total eligible participant deferrals. For the years ended December 31, 2024 and 2023, the Company made matching contributions to participants totaling \$941,486 and \$1,035,929, respectively, of which \$91,486 and \$114,746, respectively, was funded using forfeitures. Total employer contributions per the statements of changes in net assets for the years ended December 31, 2024 and 2023, also reflect immaterial corrections related to prior year contributions. Although the Company may elect to make additional profit-sharing contributions to the Plan, none were made for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions and company contributions, as well as an allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting and Forfeitures***

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions is based upon years of service according to the following schedule:

Participants become fully vested immediately upon death, disability, or normal retirement, as defined by the plan document.

A participant who leaves the Company forfeits any non-vested balance. Forfeitures may be used to reduce employer contributions or pay eligible administrative expenses. If any forfeitures remain, such forfeitures will be re-allocated to participant accounts in accordance with the provisions of the Plan. For the years ended December 31, 2024 and 2023, \$91,486 and \$114,746 of forfeitures were utilized to reduce employer contributions made subsequent to the years then ended. Additionally, \$62,137 and \$10,552 of forfeitures were used to pay eligible administrative expenses during the years ended December 31, 2024 and 2023, respectively. No forfeitures were re-allocated to participant accounts during 2024 or 2023. At December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$91,486 and \$114,746, respectively.

### ***Payment of Benefits***

On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The Plan provides for the direct rollover to an individual retirement account ("IRA") for terminated participants with balances greater than \$1,000 and not more than \$7,000 (increased from \$5,000 effective January 1, 2024), unless directed otherwise by the participant. In addition, the Plan allows the plan administrator to automatically distribute to terminated participants their entire vested balance which does not exceed \$1,000. Participants who have attained the age of 59½ may elect to withdraw part or all of their vested account balance from the Plan without penalty. In addition, a participant may elect to withdraw all or part of his or her account in the case of immediate and heavy financial need. Hardship withdrawals are subject to taxes. In general, participants must begin receiving required minimum distributions upon reaching a certain age, unless they are still employed. For individuals who reached age 70½ on or before December 31, 2019, that age is 70½. For individuals who reach age 70½ on or after January 1, 2020, in accordance with the Setting Every Community Up for Retirement Enhancement ("SECURE") Act of 2019, that age is 72. For individuals who reach age 72 on or after January 1, 2023, in accordance with the SECURE 2.0 Act of 2022, that age is 73.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### *Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by investment advisers and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the plan year.

#### *Contributions*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant’s compensation. Profit-sharing, non-elective contributions, and other employer contributions, if any, are recorded in the relevant period in accordance with the terms in the plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

### 3. Certified Investments

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution as defined by ERISA, has certified as to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the ERISA-required supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

### 4. Fair Value Measurements

The Financial Accounting Standard Board Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

The asset or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### ***Common/Collective Trust***

Valued at the NAV of units held by the Plan at year-end, as provided by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is considered a readily determinable fair value as it is made readily available by the fund administrator to current investors and is the basis for current transactions. There are no unfunded commitments, and participant transactions (purchases and sales) may occur daily with no advance notice requirements. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity, and therefore, these transactions qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the Company and Fidelity. Fidelity receives revenue from mutual fund and collective trust fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by revenue sharing. The Plan made direct payments to Fidelity totaling \$39,404 and \$44,030 during the years ended December 31, 2024 and 2023, respectively.

### 6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### 7. Tax Status

The Plan has adopted a pre-approved plan document sponsored by Fidelity, who has received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the preapproved plan is qualified under Section 401(a) of the Internal Revenue Code (“IRC”), and therefore, the related trusts are tax exempt. Although there have been amendments to the Plan since receiving the most recent opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been made in the financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax provisions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### 9. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently submitted duplicate requests for reimbursement of fees pertaining to audit services provided to the Plan, resulting in excess payments totaling \$30,990 being made from the Plan's assets. As defined by ERISA, these payments are considered prohibited transactions. As of October 15, 2025 the Plan Sponsor is in the process of correcting the error by reimbursing the Plan for excess payments, including lost earnings and any associated administrative expenses. The Plan Sponsor is also in the process of completing a filing under the DOL's Voluntary Fiduciary Correction Program and filing the appropriate Form 5530 with the IRS. The plan administrator believes these prohibited transactions do not affect the tax status of the Plan.
