Note 1 Description of Plan

The following description of Liquor Management (the “Company” or “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 2015, is a defined contribution 401(k) plan covering employees of the Company who have completed three months of employment and are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan oversight is performed by an officer of the Company and ADP, Inc, the third-party administrator (“TPA”). Reliance Trust Company (“Trustee”) receives and invests the contributions and plan earnings, as directed by the participants.

Contributions to the Plan

The Plan allows participants to make tax-deferred contributions and both contributions (compensation deferrals) up to the maximum limits imposed by the Internal Revenue Code. Participants direct the investment of their contributions into various investments offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. For 2024, the Company provided a matching contribution equal to 100 percent of the employee contribution up to 4% of employees’ eligible earnings.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollovers

The Plan permits participant-designated rollover contributions into the Plan. For the year ended December 31, 2024, there were no participant-directed rollovers.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participant accounts is based on the following schedule:

Forfeited Accounts

Forfeitures of non-vested participant account balances can be used to pay administrative expenses of the Plan and/or to reduce contributions otherwise required of the Employer. At December 31, 2024, there was \$39,412 of forfeitures for non-vested participant account balances. During 2024, \$37,081 of forfeitures were used to reduce employer contributions and \$2,331 were used to reduce administrative fees. At December 31, 2024, there were no unused forfeitures.

Distribution of Benefits

Participants or their beneficiaries are eligible to receive distributions from their account upon normal retirement (age of 65), permanent and total disability, death, or financial hardship, as defined. Employees who terminate employment prior to the occurrence of one those events have 60 days from the date of their account distribution to invest the funds in a qualified tax deferred investment without taxation or penalty. A hardship withdrawal may also be taken to satisfy an immediate and heavy financial need that cannot be satisfied from other financial resources.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.25%, which is commensurate with monthly rates as determined by the Company. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are considered parties-in-interest transactions.

Note 2 Liquidity and Going Concern

The financial statements of the Liquor Management 401(k) Plan have been prepared assuming that the Plan will continue as a going concern. However, the Company has experienced significant financial difficulties that raise substantial doubt about its ability to continue as a going concern. The Company has reported significant losses which may impact its ability to meet its obligations, including those related to the 401(k) Plan.

The continuation of the Plan is dependent on the Company's ability to continue as a going concern. Should the Company be unable to continue its operations, this could have a material adverse effect on the Plan, including potential termination of the Plan, changes in plan provisions, or reduced employer contributions.

Management of the Plan is monitoring the situation closely and will take necessary actions to protect the interests of plan participants.

Note 3 Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with U.S.GAAP requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets, liabilities, income and expenses, as well as related disclosures. Because these estimates are inherently subjective and based on currently available information, actual results could differ materially from these estimates.

Note 3 Summary of Significant Accounting Policies (Continued)

Use of Estimates (Continued)

Key estimates applicable to the Plan include, but are not limited to:

- Fair value measurements of investments, particularly those without readily determinable market value
- Valuation of self-directed brokerage accounts and other participant-directed investments
- Assessment of collectability for participant loans
- Accruals for pending contributions or distributions

Management regularly evaluates these estimates and make adjustments as necessary to reflect current conditions. Changes in these estimates are recognized in the period in which they become known.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and insurance company. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses were considered necessary as of December 31, 2024. At December 31, 2024 and 2023 notes receivable from participants were \$45,478 and \$9,840, respectively.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments on accompanying Statement of Changes in Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Note 4 Information Prepared and Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year then ended December 31, 2024, was obtained or derived from information supplied to the Company and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire plan balance.

Note 6 Tax Status

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- * quoted prices for similar assets or liabilities in active markets;
- * quoted prices for identical or similar assets or liabilities in inactive markets;
- * inputs other than quoted prices that are observable for the asset or liability;
- * inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (“Level 1”)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8 Collective Investment Trust

The Plan holds an interest in a collective investment trust (Invesco Stable Value Fund) to maintain a portion of plan contributions in guaranteed investment contracts, synthetic guaranteed investments contracts, and separate account investment contracts. The account is credited with contributions and earnings on the underlying investments and charges for participant withdrawals and administrative expenses charged by the plan custodian of the collective investment trust. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The investment contracts in the collective investment trust are fully benefit-responsive, and the collective investment trust is included in the financial statements at contract value, as reported to the Plan by the plan custodian.

There are no reserves against the collective investment trust for credit risk of the contract issuer or otherwise. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Specific coverage provided by each contract may be different from each issuer and can be found in the contract of the collective investment trust. Examples of such events include the following: (1) amendments to plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 was 2.89% and for 2023 was 2.70%.

Note 9 Risks and Uncertainties

Persistent inflation, elevated interest rates, and ongoing geopolitical tensions and global trade disruptions have contributed to continued market volatility. These factors may materially impact the valuation of the Plan's investments and participants' account balances. The Plan Sponsor is taking the necessary steps to minimize any possible negative effect on profitability and remains committed to actively monitoring economic and political developments that could affect the Plan's performance.

Note 10 Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Reliance Trust Company, the Trustee for the Plan, and, therefore these transactions qualify as party-in-interest transactions.

Effective January 1, 2015, the Trustee provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and the Trustee. The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund service providers exceeds the amount owed under the MSA, the Trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay the Company expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or the Company may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

Note 11 Partial Plan Termination

During the plan year ended December 31, 2024, the Plan Sponsor closed 11 retail liquor store locations as part of a business restructuring initiative. As a result of these closures, a significant number of the Plan's participants experienced involuntary termination of employment and ceased participation in the Plan.

In accordance with Internal Revenue Code Section 411(d)(3), the Plan Sponsor evaluated the impact of these terminations and determined that a partial plan termination occurred. Consequently, all affected participants became 100% vested in their account balances attributable to employer contributions as of their termination date. The Plan Sponsor has taken appropriate steps to ensure compliance with applicable IRS regulations, and the financial statements reflect the impact of this event. No changes were made to the Plan's provisions or operations beyond those described above.

Note 12 Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued, and determined no items required disclosure.
