INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators and Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit



NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2023 AND 2022

NOTE A – DESCRIPTION OF PLAN

The following description of the 555 International, Inc. 401(K) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document and Summary Plan Description (the “SPD”) for further details of the Plan provisions. The Plan is subject to the provisions of the *Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”)*.

General

555 International, Inc., a corporation, formed the 555 International, Inc. 401(k) Profit Sharing Plan (the “Plan”) on January 1, 2001. In 2023, New Star Lighting, Inc., a corporation with common ownership and shared employees, was organized to expand production and sales between the two companies (the “Company”). The Plan has not been amended and restated since January 1, 2021.

Contributions

Except for those who are specifically ineligible to participate in the Plan, all employees who are at least 21 years of age and have three months of service with one hour worked each month are eligible to participate in the Plan.

The Company may contribute a discretionary profit-sharing amount for all eligible employees. Employees who are at least 21 years of age, have completed one year of service with the required hours, and are employed on the last day of the plan year, are eligible to receive profit sharing contribution. An employee’s share of the discretionary profit-sharing amount is determined by the number of allocation points earned which is a proportionate share of the employer contributions, based on the ratio of the employee’s points to all points awarded. An employee receives 75 points for each year of service. The Discretionary Profit-sharing contribution was \$300,000 for the years ended December 31, 2023 and 2022.

The Company may also contribute discretionary matching contributions for all employees who are making salary deferrals during the plan year, at least 21 years of age, have completed one year of service with the required hours, and are employed on the last day of the plan year. There were no matching contributions made for the years ended December 31, 2023 and 2022.

The Company makes a Qualified Non-Elective Contribution (QNEC) for all eligible employees for the plan year in order to pass certain nondiscrimination tests. When made, the amount is allocated in proportion to compensation to non-highly compensated participants who are eligible to receive an allocation of profit-sharing amounts. There was no QNEC made for the years ended December 31, 2023 and 2022.

Notes Receivable from Participants

A participant may request a loan for any purpose. Ascensus Trust Company, the custodian, determines the available amount at the time the loan request is approved. The maximum amount of any loan is the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan, reduced by the participant’s highest outstanding loan balance in the previous twelve months and the existing loan balance, even if all or a portion of this amount has been repaid. The minimum amount of any loan is \$1,000. Interest rate is based on the prime rate of interest published by the custodian as of the date of the loan, plus one percent. Participants are charged a processing fee and maintenance fee. Only one outstanding loan is allowed at any time, and a lifetime limit of seven.

Outstanding loans, which are secured by the participant's interest in the Plan, are repaid through payroll deductions, subject to rules permitting prepayment. Loans have a repayment term of up to five years. In the event of default, participants are considered to have received a distribution and are subject to income taxes on the distributed amount. Also, participants may be subject to an additional 10% penalty tax on the taxable distribution if it occurs prior to age 59 ½.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and earnings thereon, self-directed plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Account balances less than \$5,000 are subject to payment regardless of whether the employee consented to receive it upon termination.

Hardship Withdrawals

Hardship withdrawals may be made to satisfy certain immediate financial needs, according to specific types of costs and set conditions designated in the Plan. Hardship withdrawals can only be made from salary deferrals including earnings.

Forfeited Accounts

Employees who are terminated before being fully vested forfeit the non-vested portion of the account. Forfeitures are maintained in an unallocated account at the investment company. The forfeited amount is either used to reduce the Company's contribution or allocated to the remaining participants. As of December 31, 2023 and 2022, unallocated forfeitures amount was \$43 and \$3,423, respectively.

Administrative Expenses

Certain administrative operating expenses of the Plan are paid by the Company, as provided in the plan agreement.

Investment Options

Participants may direct the investment of their account balances and future contributions and Employer contributions into various investment options offered by the Plan. Participants are allowed to change their investment options daily.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, if applicable.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by its custodian, Ascensus Trust Company.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are stated at market value as of the last business day of the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are treated as distributions based on the terms of the Plan. Interest is calculated based on the prime rate of interest published as of the date of the loan, plus one percent. Interest from notes receivable from participants is recorded on the accrual basis. Participants are charged loan processing fees, and loan maintenance fees until the loan is paid in full. These fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Benefits Paid to Participants

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investments that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Administrative fees and expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Fees related to the administration of investments, notes receivable from participants and benefit payments are charged directly to the participant's account and are also recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

NOTE C – INFORMATION PREPARED AND CERTIFIED BY THE PLAN’S CUSTODIAN

The plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the *Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974* (ERISA). Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit.

The plan administrator has obtained a certification from Ascensus Trust Company, as custodian of the Plan, that the following information included in the Plan’s financial statements and supplemental schedule is complete and accurate:

- Investments as of December 31, 2023 and 2022;
- Notes Receivable from Participants as of December 31, 2023 and 2022;
- Plan transactions related to investment income and securities transactions for the years ended December 31, 2023 and 2022;
- Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023.

Accordingly, at the request of the plan administrator, the Plan’s independent certified public accountants performed no procedures on investment information and related activity, other than to agree the information to the trust statements certified by the Plan’s trustee and provided to them by the plan administrator.

NOTE D – FAIR VALUE OF MARKET INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market: Valued at cost plus interest earned, which approximates fair value.

NOTE E – PARTIES-IN-INTEREST TRANSACTIONS

Substantially all fees to administer the Plan are paid by the employer on behalf of the Plan. Certain employees of the employer provide administrative services to the Plan. These employees are compensated by the employer for such services.

Ascensus Trust Company, a subsidiary of Ascensus, LLC., is the custodian, therefore qualify as party-in-interest. Ascensus Trust Company manages Plan investments and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. Participants covered under the Plan are considered to be parties-in-interest. Notes receivables from participants are considered as parties-in-interest investments.

NOTE F – INCOME TAX STATUS

The Plan is a non-standardized pre-approved profit-sharing plan with CODA sponsored by CCH Incorporated, DBA ftwilliam.com, which the Internal Revenue Service (IRS) has determined in the letter dated June 30, 2020 and informed the same, that the form of the plan was acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States (GAAP) requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE G – DELINQUENT PARTICIPANT CONTRIBUTIONS

Salary deferrals in the amount of \$52,712 were not remitted, late or not remitted within the time required by the U.S. Department of Labor. Late transmissions of salary deferrals constitute a prohibited transaction under The ERISA section 406, regardless of materiality. The Company is in the process of reimbursing the Plan for lost earnings and paying the related excise taxes required by the Internal Revenue Service.
